NOTE 1 – DESCRIPTION OF PLAN

The Argus Media Inc. and Subsidiaries 401(k) Retirement Savings Plan (the Plan) is a defined contribution plan adopted by Argus Media Inc. and its wholly-owned subsidiaries (the Company) effective as of January 1, 1994 and was amended and restated effective January 1, 2022. The Plan is designed to encourage and assist eligible employees in adopting a regular savings program and provide additional tax-advantaged security for their retirement. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the terms of the plan document for a more complete description of the Plan's provisions.

Eligibility: Employees are eligible to participate in the Plan when they have attained age 21. Employees may enter the Plan on the first day they satisfy the eligibility requirements.

Contributions: A participant may elect to contribute, on a pre-tax or Roth 401(k) basis, up to 100% of the participant's compensation to the Plan, subject to the annual deferral and contribution limits under the Internal Revenue Code of 1986 (IRC), as amended. Participants who have attained or will attain age 50 by the end of the calendar year may make additional catch-up contributions, also subject to IRC limits.

The Plan includes an automatic enrollment provision whereby newly eligible employees are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation, unless the employee affirmatively elects a different deferral percentage or opts out of participation. These automatic contributions are invested according to the Plan's default investment alternative until the participant makes an affirmative investment election.

The Company contributes 100% of the first 6% of eligible compensation that a participant contributes to the Plan, which qualifies as a safe harbor matching contribution under IRS regulations.

In addition, the Company may elect to make discretionary matching contributions, equal to a percentage of the participant's elective deferrals, up to 4% of eligible compensation, subject to satisfaction of service and employment requirements.

Participants may also deposit into the Plan rollover contributions from eligible distributions received from other qualified retirement plans and conduit IRAs.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions (b) Plan earnings and losses, and (c) forfeitures of discretionary matching contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Each participant shall have a 100% vested, nonforfeitable right to their elective contributions, rollover contributions, and safe harbor matching contributions in the Plan. Participants will vest in the Company discretionary matching contributions as follows: 20% vested after one year of service, 50% vested after two years of service, 75% vested after three years of service, 85% vested after four years of service, and 100% vested after five years of service. Participants will also be 100% vested in nonelective contributions if they are employed on or after normal retirement age or if employment is terminated because of the participant's death or disability.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers mutual funds and a guaranteed investment contract as investment options for participants. Participants may change their investment choices at any time.

Notes Receivable From Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance in the available contribution sources or \$50,000 less the participant's highest outstanding loan balance immediately prior to the loan. Loan terms cannot exceed five years unless the loan is for the purchase of a primary residence, in which case the Plan may permit a longer repayment term. The loans are adequately secured by the vested balance in the participant's account and bear a reasonable rate of interest. Loan principal and interest repayments are made via payroll deductions, are credited directly to the participant's account, and are invested at the participant's direction in one or more of the investment options.

Payment of Benefits: Upon termination of service due to death, disability, or normal retirement, each participant will be entitled to the full value of their accounts. Upon termination of service, a participant shall be entitled to receive a single lump-sum payment in cash equal to the value of the participant's vested account balance, installment payments, ad-hoc payments, or a direct rollover to an IRA or another employer retirement plan.

If a participant's vested account balance is \$5,000 or less, the account will be distributed directly to the participant in a cash lump-sum. For vested account balances exceeding \$5,000, participants must consent to distribute their account.

Participants may receive an in-service withdrawal from certain other accounts prior to termination of employment with the Company if they have attained age 59 ½ or incurred a financial hardship.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant's accounts will become 100% vested.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Forfeited Accounts: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan as a forfeiture. Forfeitures may be used to pay Plan expenses or to reduce employer contributions. At December 31, 2024 and 2023, forfeited balances totaled \$140,230 and \$387,161, respectively. During 2024, \$300,000 of forfeitures were used to offset administrative expenses.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 11, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive contract are reported at fair value as further described in Notes 3 and 4. Fair value is the price that would be received to sell an asset or paid by the Plan to transfer a liability in an orderly transaction between market participants on the measurement date. The Company determined the Plan's valuation policies utilizing information provided by the trustee. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefit are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit risks and global event risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quotes prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

NOTE 5 – GROUP ANNUITY CONTRACT

The Plan has a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (Empower), which is called the Key Guaranteed Portfolio Fund (Fund). Empower maintains the contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract value of the group annuity contract at December 31, 2024 and 2023 was \$1,303,201 and \$1,566,742, respectively.

NOTE 5 – GROUP ANNUITY CONTRACT (Continued)

Since the Fund is fully benefit-responsive traditional investment contract, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fund. The Fund is presented on the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (1) premature termination of the contract by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, and (6) early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

Empower may not terminate the contract at any amount less than the contract value. Empower is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula agreed upon with Empower. Such interest rates are reviewed on a quarterly basis for resetting.

The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the Fund over the year. The average yield earned by the Plan for 2024 and 2023 was 1.41% and 1.23%, respectively.

NOTE 6 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds an unallocated investment contract with Empower. Empower is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to Empower qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan had been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan was operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.
