As disclosed in Note 1a to the financial statements, the Plan Sponsor approved a merger of the Conn-Selmer Union Employee's 401(k) Plan into the Conn-Selmer 401(k) & Profit Sharing Plan. The assets of the Conn-Selmer Union Employee's 401(k) Plan were transferred into the Conn-Selmer 401(k) & Profit Sharing Plan during January 2024. Our opinion on the 2024 Financial Statements is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Conn-Selmer 401(k) & Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental schedules, Form 5500, Schedule H, Part IV, Line 4a - Schedule of Delinquent Participant Contributions and Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of Conn-Selmer 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan was a defined contribution 401(k) plan sponsored by Conn-Selmer, Inc. (the Plan Sponsor) (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is charged with governance and oversight of the Plan, determining the appropriateness of investment offerings, and monitoring investment performance.

On January 2, 2024, the Conn-Selmer Union Employee's 401(k) Plan with assets of \$5,426,336 was merged into the Plan with all related participant account balances being credited accordingly.

b. Eligibility

All employees of the Company who have attained age 18 are eligible to participate in the Plan. The Plan excludes nonresident aliens and residents of Puerto Rico from participating in the Plan. Effective January 1, 2024, employees covered under a collective bargaining agreement are no longer excluded from participating in the Plan. Participants must have been employed on the last day of the plan year to receive the discretionary matching and non-elective contributions. Participants must also complete 1,000 hours of service during the plan year to receive the discretionary non-elective contributions.

c. Contributions

Eligible participants may contribute through salary reductions up to 70% of eligible pre-tax annual compensation, as defined, limited to the maximum amount allowable under the provisions of the Internal Revenue Code (IRC). The Plan allows for catch-up contributions for participants who have attained age fifty by the end of the plan year. The Plan allows for participants to make after-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions).

The Plan includes an automatic enrollment provision enabling eligible employees to be automatically enrolled into the Plan 35 days after the employee's date of hire, unless they elect to participate sooner. Newly eligible participants are automatically enrolled and defer 6% of their eligible compensation (as defined by the Plan). In accordance with the automatic enrollment provision, the deferral rate will increase by 1% annually, not to exceed 10%, for those participants who have been automatically enrolled. Deferrals will be allocated to a default fund as defined in the plan document. Participants may cancel, modify, or otherwise change any of the automatic elections.

The Company may make discretionary matching contributions. For the plan year ended December 31, 2024, the Company matched 50% of every dollar contributed, not to exceed 3% of the participant's eligible wages. The Plan Sponsor may also make discretionary non-elective contributions; however, the Plan Sponsor did not make any discretionary non-elective contributions for 2024.

d. Participant Accounts

Each participant's account balance is credited with the participant's contributions, allocation of the Company's contributions, plan earnings or losses, and is charged with an allocation of administrative fees paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

e. Vesting

Participants are immediately vested in their voluntary contributions and actual earnings thereon. Vesting in discretionary employer contributions and any earnings thereon is based on years of service. A participant will be 100% vested, based on a cliff vesting schedule, after two years of credited service, as defined in the plan document. In the event of death, disability, or attainment of the age 62, participants' accounts become fully vested.

f. Payment of Benefits

Upon attaining normal retirement age of 62 or termination of services, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested account balance or leave their balance in the Plan if the balance exceeded \$5,000. The Plan required balances of \$5,000 or less to be paid out to participants upon termination of employment. There were also retirement benefits available upon disability or death. Effective January 1, 2024, the involuntary distribution amount was increased to \$7,000 per the SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant could also request a withdrawal upon demonstration to the Plan Administrator that they were suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of Treasury or their delegate.

g. Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to five years, unless for the purchase of a primary residence, in which case the maturity is ten years. Loans are secured by the vested balance in the participant's account and bear interest at an amount determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Participants may only have one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions.

h. Forfeitures

Forfeitures represented non-vested Plan Sponsor discretionary matching and non-elective contributions of participants who terminated their employment or who withdrew from the Plan. Forfeitures were retained by the Plan and were used to reduce Company contributions or to pay plan expenses. During 2024, the Company used \$50,000 of forfeitures to reduce Company contributions. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$58,667 and \$41,331, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institution. See Note 4 for discussions of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, there were \$155,165 of defaulted loans that have been deemed distributed and included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

Contributions

Contributions from plan participants and discretionary matching contributions from the Company were recorded in the year in which the participant contributions are withheld from compensation. The discretionary non-elective contributions are recorded when such contributions are authorized by the Company.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions along with asset management, audit fees, and investment advisory fees are charged directly to participant accounts. Investment-related expenses are included in net appreciation of investments.

Subsequent Events

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition for disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. Fair Value Measurement establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain investment contracts, asset-backed securities, debt obligations, and other securities. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business matter.

Money market fund: Valued at the daily closing price reported by the fund from an actively traded exchange.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

5. COMMON COLLECTIVE TRUST

The Plan's investment in the Common Collective Trust (CCT) is represented by the CCT's underlying investment in the FA Stable Value I fund which invests in fully benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the CCT is not considered a fully benefit-responsive investment contract and is reported at fair value (see Note 4).

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Master Services Agreement (MSA). The Plan receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. The Plan or the Company may make a payment to Fidelity for administrative expenses not covered by revenue sharing. During 2024, the Plan paid the qualified institution administrative expenses totaling \$155,682, which is presented net of \$10,061 of the revenue share in the statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, there was a balance totaling \$26,799 and \$13,869 in the revenue sharing account, respectively.

7. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan was operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rates, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024 and 2023, the Company did not remit to the Plan's trustee certain participant contributions and loan repayments totaling \$433,374 and \$359,101, respectively, within the time period prescribed by the Department of Labor regulations. Delays in remitting the contributions to the trustee were due to administrative errors. The Company remitted lost earnings on the 2024 delinquent participant contributions during the 2025 plan year. The Company remitted the lost earnings of \$110 for the 2023 delinquent contributions in 2024. The \$359,101 of 2023 delinquent contributions includes \$297,267 delinquent participant contributions and loan repayments related to the Conn-Selmer 401(K) & Profit Sharing Plan and \$61,834 delinquent participant contributions and loan repayments related to the Conn-Selmer Union Employee's 401(k) Plan.
