INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of the
New South Construction Supply LLC Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the New South Construction Supply LLC Retirement Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of February 1, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to February 1, 2024, and the related notes to the financial statements.

Opinion

Notes to Financial Statements

February 1, 2024 and December 31, 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the New South Construction Supply LLC (the “Company” or “Employer”) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and related amendments for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees (as defined by the Plan) of the Company who are 21 years of age and have 3 months of service as defined by the Plan. Deferrals begin on the first day of the Plan year quarter subsequent to becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Participants may elect to make pretax and Roth contributions up to the limits prescribed by the Internal Revenue Service (“IRS”). Upon reaching eligibility, employees are automatically enrolled, unless they make an affirmative election not to contribute, at a deferral rate of 4 percent of eligible compensation. The Plan also allows for participants who are 50 years old or older to make catch-up contributions up to the limits prescribed by the IRS. Participants can change their contribution percentages at any time and those changes will be effective as soon as administratively feasible.

For each Plan year, the Company may contribute to the Plan, on behalf of each eligible participant, a discretionary matching contribution. For the period from January 1, 2024 to February 1, 2024, the Company did not make any Employer contributions other than the prior year corrective contributions of \$41,783. All Employer contributions are invested as the participant directs.

As discussed in Note 9 to the financial statements, a total of \$54,838 of delinquent participant contributions and \$18,953 of lost earnings on delinquent participant contributions are included in Employer contributions receivable on the statement of net assets available for benefits as of December 31, 2023. The lost earnings are included as Employer contributions on the statement of changes in net assets available for benefits for the year ended December 31, 2023. The contribution was made to the Colony Hardware Corp 401(k) Plan in December 2024 and therefore, was included in the transfer amount.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company’s contributions, an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately one hundred percent vested in their voluntary employee contributions. A vesting year means a plan year in which an individual has been credited with 1,000 hours for which an individual is compensated.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

A participant who incurs a severance from employment with the Company prior to normal retirement shall be vested in their Employer contribution account according to this schedule:

Notes Receivable from Participants

The Plan allows for notes receivable from participants, subject to the provisions as set forth in the Plan. The loan amount shall be greater than \$1,000 and not exceed the lesser of \$50,000 or 50% of the sum of the participant's total vested balance. Participants are limited to two outstanding loans at any given time. Loans bear a reasonable rate of interest comparable to the interest rate charged on similar commercial loans by persons in the business of lending money. Principal and interest are paid ratably through payroll deductions in each pay period.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump sum distribution, installment payments or partial payments. For vested account balances under \$5,000, lump sum distributions or direct rollovers will be made. Distributions or direct rollovers of vested account balances of more than \$1,000 cannot be made before the participant's normal retirement date without the participant's written consent. In addition, during employment, a participant may withdraw all or a portion of their vested account balance, to the extent necessary, to meet a qualifying hardship, or for childbirth and adoption expenses.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59 ½.

Investment Elections

Upon enrollment in the Plan, a participant may direct contributions among investment options in increments of one percent. Participants may change their investment choices at any time.

Forfeited Accounts

If a participant leaves the Company for any reason other than retirement, disability or death, they are entitled to all their contributions and related earnings, and the vested portion of Employer contributions and related earnings. The nonvested portion of Employer contributions and the related earnings will be forfeited.

Forfeitures may be used to pay certain Plan expenses or allocated to participants in accordance with Plan documents. There were no forfeitures used to pay expenses during the period from January 1, 2024 to February 1, 2024. At February 1, 2024 and December 31, 2023, unallocated nonvested accounts totaled \$0 and \$8,092, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared using the accrual method of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Company pays certain administrative expenses incurred in the administration of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Certain other expenses, including loan set-up fees and other transactional costs, are charged to the participant accounts, and included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has monitored and evaluated any subsequent events from February 1, 2024 through September 5, 2025, the date on which financial statements were available to be issued. There were no events required to be disclosed.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at February 1, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 to February 1, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (“John Hancock”), the custodian of the Plan.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan had a fully benefit-responsive investment contract with John Hancock totaling \$17,264 at December 31, 2023. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. Such interest rates were viewed on a periodic basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – TAX STATUS

The IRS has informed the volume submitter plan sponsor, by an opinion letter dated June 30, 2020, that the Plan is acceptable under the appropriate sections of the Internal Revenue Code. The Plan is designed to constitute a qualified tax-exempt plan under section 401(a) of the Internal Revenue Code. As such, the Plan is exempt from federal income tax, and amounts contributed by the Employer will not be taxed to the participant until the participant receives a qualifying distribution from the Plan. The Plan has been amended since the date of the opinion letter, however the Plan administrator believes that the Plan is operating in accordance with the applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United State of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes the Plan has merged in accordance with IRS regulations.

NOTE 7 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock, therefore these transactions qualify as party-in-interest. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. John Hancock performs certain administrative, advisory and recordkeeping services for the Plan. For the period from January 1, 2024 to February 1, 2024, John Hancock was paid \$2,449 for these services.

The Plan provides for loans to participants. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

NOTE 8 – DELINQUENT PARTICIPANT CONTRIBUTIONS

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances on the Schedule of Delinquent Participant Contributions, which totaled \$54,838 were remitted in 2024 into the Colony Hardware Corp 401(k) Plan. Lost earnings of \$18,953 were calculated and remitted to participant accounts in 2024 in the into the Colony Hardware Corp 401(k) Plan.

NOTE 9 – PLAN MERGER

Plan Merger

Effective February 1, 2024, the Plan was merged into the Colony Hardware Corp 401(K) Plan. Plan assets were transferred into the Colony Hardware Corp 401(K) Plan.
