TO THE PLAN ADMINISTRATOR

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Anchor Tool & Die Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of November 4, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to November 4, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Anchor Tool & Die Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of November 4, 2024 and December 31, 2023, and for the period from January 1, 2024 to November 4, 2024, stating that the certified investment information, as described in Notes 3 and 4, to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Anchor Tool & Die Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Anchor Tool & Die Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Anchor Tool & Die Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Anchor Tool & Die Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

### NOTES TO THE FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF PLAN

The following description of the Anchor Tool & Die Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution retirement plan covering all employees of Anchor Tool & Die Company (the Company) who have completed 720 hours of service within six-months' time period and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Administrator.

In recent years, the Plan has been amended to comply with the Heroes Earnings Assistance and Relief Tax (HEART) Act, the Worker, Retiree, and Employer Recovery Act (WRERA), and other Internal Revenue Service (IRS) and Department of Labor (DOL) guidance. The purpose of these changes was to comply with IRS and DOL regulations and maintain the Plan's tax-exempt status.

Effective November 4, 2024, the Plan was terminated, and its assets were transferred to a successor pooled employer plan administered by The Standard.

##### Contributions

Participants may elect to contribute their eligible compensation plus additional catch-up contributions on a pre-tax basis, subject to IRS limitations for the Plan year. The Plan also permits rollover contributions from other qualified retirement plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Prior to January 1, 2022, the automatic deferral rate was 1%. There is an automatic increase or escalation of the deferral percentage of 1% annually up to a maximum of 6%. Participants direct the investment of contributions into a variety of investment options offered by the Plan.

The Company may, at its discretion, make matching contributions. For the period ended November 4, 2024, matching contributions equal to 50% of the first 6% of the compensation that a participant contributed to the Plan were made by the Company. Matching contributions totaled \$174,137. The Company may also make a discretionary Qualified Nonelective Contribution (QNEC) to the Plan. No QNEC contributions were made for the period ended November 4, 2024. Total annual contributions made to the Plan on behalf of any participant are subject to limitations imposed under the Internal Revenue Code (IRC).

##### Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's discretionary matching and QNEC contributions, and Plan earnings (losses), and charged with an allocation of administrative expenses. The Company's matching contributions are allocated based on participants' compensation for the Plan year relating to the contribution. Discretionary QNEC contribution allocations are based on participant compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO THE FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN (continued)

Notes Receivable from Participants

Participants may borrow money from their individual accounts subject to certain minimum and maximum amounts as prescribed by the Plan and in the IRC. The notes are secured by the balance in the participant's account and bear interest at a market rate. The participant must have a minimum vested account balance of \$2,000 to be eligible for a loan. Principal and interest are paid ratably through payroll deductions over the term of the loan. Interest income of \$9,900 for the period ended November 4, 2024 was recorded as interest income on notes receivable from participants in the accompanying Statement of Changes in Net Assets Available for Benefits. All notes receivable from participants as of November 4, 2024 were transferred to the successor plan in connection with the Plan's termination.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service with a minimum of 1,000 hours per year according to the following schedule:

1 year	33%
2 years	66%
3 years	100%

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a future period. If the participant's account balance is between \$1,000 and \$5,000, the Plan Administrator makes an automatic rollover of the account balance to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the Plan Administrator directs the trustee to make a lump-sum distribution. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also be permitted to receive a distribution from their account prior to termination of employment if they reach age 59 ½ or experience financial hardship. Any hardship distribution would be limited to actual participant contributions and vested discretionary employer contributions not previously withdrawn and may be authorized at any time by the Plan Administrator.

Forfeitures

Forfeitures are created when participants terminate employment prior to becoming entitled to full benefits. At November 4, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$16,969, respectively. Forfeitures are used to reduce future Company discretionary matching or profit-sharing contributions. The remaining balance in the forfeiture account at November 4, 2024 was transferred to the successor plan as part of the plan termination.

Administrative Expenses

Administrative expenses are paid by the Company or the Plan. During the period ended November 4, 2024, administrative expenses paid by the Plan totaled \$68,235.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on the investments purchased and sold, as well as held, during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. As of November 4, 2024 and December 31, 2023, no allowance for credit losses was deemed necessary. Delinquent participant notes were reclassified as taxable deemed distributions in accordance with the terms of the Plan document.

##### Payment of Benefits

Benefits are recorded when paid. Benefit payments totaled \$1,678,409 for the period ended November 4, 2024.

##### Subsequent Events

Plan management has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

#### 3. CERTIFICATION

Investment information disclosed in the accompanying financial statements, including net appreciation (depreciation) in the fair value of investments, and interest and dividends for the period ended November 4, 2024 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Trust Company (Empower) and has not been audited by the independent auditors.

Investment information disclosed in the accompanying financial statements, including investments held at December 31, 2023 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower and has not been audited by the independent auditors.

#### 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 4, 2024 and December 31, 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Collective trust funds – Valued at the NAV, as provided by the custodian, of units of a bank collective trust and are not classified in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between levels of the fair value hierarchy as of the actual date of the event of change in circumstances that caused the transfer. There were no transfers between levels of the fair value hierarchy during the period ended November 4, 2024.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan transactions include units of investment accounts managed by Reliance and Empower for the year ended December 31, 2023. Reliance was the custodian of the Plan until March 31, 2023. Empower became the custodian effective April 1, 2023. Therefore, these transactions qualify as party-in-interest transactions.

6. PLAN TERMINATION

The Plan was terminated effective November 4, 2024. In connection with the termination, all remaining assets were transferred to a successor pooled employer plan administered by The Standard, in accordance with Plan provisions.

7. TAX STATUS

The trust established under the Plan, which holds the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan has adopted an IRS approved prototype plan. The prototype plan has received a favorable opinion letter from the IRS that it qualifies under IRS Code Section 401(a), provided all terms of the plan are followed. The Plan was amended since receiving the determination letter. However, the Plan Administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. The Plan held no investments as of November 4, 2024.

#### 9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Plan's financial statements have been prepared for the period from January 1, 2024 through November 4, 2024, the date of plan termination. The Plan's Form 5500 is prepared for the period from January 1, 2024 through November 30, 2024. Although the reporting periods differ, there are no differences in net assets or changes in net assets between the financial statements and the Form 5500.
