INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Midwest Hardwood Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Midwest Hardwood Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following is a brief description of the Midwest Hardwood Company 401(k) Plan (the “Plan”) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers substantially all employees of Midwest Hardwood Company, LLC, (the “Company” or “Plan Sponsor”). Employees are eligible to participate in the Plan as soon as administratively feasible following their employment commencement date. Effective January 1, 2024, the Plan was amended to add an automatic enrollment feature, in which employees are automatically enrolled in the Plan at 5% of eligible compensation, with an automatic increase of 1% annually, up to 10%, unless the participant elects to decline participation or elects a different percentage. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Each eligible employee may make pre-tax contributions to the Plan up to 100% of eligible compensation, as defined in the Plan, not to exceed statutory limits. Effective January 1, 2024, the Plan was amended to permit Roth contributions, in addition to pre-tax contributions, up to 100% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes matching contributions to the Plan equal to 40% of participant contributions up to a maximum of \$500 per participant. Participants are eligible for employer matching contributions upon completion of one year (1,000 hours) of service annually, and must be employed on the last day of the Plan year. The matching contribution is remitted to the Plan subsequent to the Plan year-end and is recorded as employer contributions receivable in the accompanying statements of net assets available for benefits. Employer contributions receivable were \$124,987 and \$65,993, as of December 31, 2024 and 2023, respectively.

Vesting – Participants are immediately vested in all contributions and related investment earnings thereon.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s matching contribution, Plan earnings, and charged with withdrawals and an allocation of administrative expenses. Allocations are based on the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, or up to ten years for the purchase of a primary residence. The notes receivable are secured by the balance in the participant’s account and bear interest at rates that are commensurate with local prevailing rates at the date of issuance, as determined quarterly by the plan administrator, which ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions and mature at various dates through October 2029. A participant may have no more than one outstanding note at any one time.

1. PLAN DESCRIPTION (continued)

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively. Excess contributions payable were \$15,269 and \$71,063, as of December 31, 2024 and 2023, respectively.

Payment of Benefits – On termination of service due to death, disability, retirement, or other termination of a participant's employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. Distributions will be made as soon as practical after a participant's request. The Plan also allows for in-service withdrawals for employees who attain age 59 ½. Distributions are also permitted in the event of financial hardship, as defined by the Plan.

Administrative Expenses – The costs of administering the Plan are borne by both the Plan and the Company.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants shall become fully vested in their accounts at the date of such termination.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan determines the fair value of assets and liabilities which are subject to reporting at fair value based on standards established within accounting principles generally accepted in the United States of America. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 are to be used only where neither Level 1 nor Level 2 inputs are available.

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Mutual funds: Valued based on the quoted market price available on an active market, which represents the net asset value ("NAV") of the shares held by the Plan at year end.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Common collective trust funds: Valued at the NAV of units held by the Plan at year-end. These common collective trust funds have been measured at fair value using the NAV practical expedient as of December 31, 2024 and 2023, and generally have no redemption restrictions or unfunded capital commitments.

Pooled separate account: This account is valued at the NAV of units held by the Plan at year-end. The pooled separate account has been measured at fair value using the NAV practical expedient as of December 31, 2024 and 2023, and generally has no redemption restrictions or unfunded capital commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Payment of Benefits – Benefit payments to participants are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events – Management has evaluated the effects of all subsequent events through August 20, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. TRANSACTIONS WITH PARTIES IN INTEREST

The Plan's pooled separate account and fully benefit-responsive investment contract are investments managed by Principal Life Insurance Company. Principal Life Insurance Company is an affiliate of Principal Trust Company, the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

4. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, 2024 and 2023, with the exception of common collective trust funds and the pooled separate account, which are measured at fair value using the NAV practical expedient. The fair values for the common collective trust funds and the pooled separate account are provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

5. GUARANTEED INVESTMENT ACCOUNT

The guaranteed investment account is a fixed interest account which guarantees a specified interest rate which is adjusted semi-annually. This investment is fully benefit-responsive and is valued based on contract value. Contract value represents contributions made under the contract plus credited interest less participant withdrawals and fees.

6. INCOME TAX STATUS

The Plan has adopted the Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan with CODA (the "Prototype Plan"). The Prototype Plan received an Opinion Letter from the Internal Revenue Service ("IRS") on June 30, 2020, stating that the form of the Prototype Plan is acceptable under Section 401(a) of the IRC for use by employers for the benefit of their employees. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax exempt.

7. CERTIFIED INVESTMENT INFORMATION

The information was prepared by Principal Trust Company, the trustee of the Plan, and furnished to the Plan Sponsor.
