### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Maletis Beverage 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Maletis Beverage 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Maletis Beverage 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 – Description of Plan

The following description of the Maletis Beverage 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

**General** – The Plan is a 401(k) salary deferral and profit-sharing plan covering substantially all nonunion employees of RM Distributors, LLC and affiliates, which consist of RM Beverage Washington, LLC; RM Beverage Oregon, LLC; RM Beverage Delaware, LLC; and RM Management Co. (dba Maletis Beverage). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). RM Distributors, LLC and affiliates (the Company) is the Plan's sponsor and serves as Plan administrator.

The Plan was amended effective May 7, 2023, allowing participation by employees previously covered by a collective bargaining agreement with Teamsters Local 162 in Oregon as of this date.

**Eligibility** – Employees of the Company are eligible to participate in the Plan and receive employer matching contributions upon reaching age 21 and after completing 90 days of service as a regular employee. After meeting eligibility requirements, participants may enter the Plan on the first day of each calendar month. To be eligible for employer-paid profit-sharing contributions, an eligible employee must be at least age 21 and be credited with at least 1,000 hours of service during the first Plan year (calendar year) of employment. If an eligible employee does not meet these eligibility requirements in the first Plan year of employment, service for eligibility purposes is measured on the employee's employment anniversary year instead of the Plan year. All participants must be employed on the last day of the Plan year to receive profit sharing contributions for that Plan year.

### Contributions

*Participant contributions* – Each year, participants may contribute between 2–25% of pretax annual compensation, as defined in the Plan. Participants may also make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

*Employer match and profit-sharing contributions* – The Company makes fixed matching and non-discretionary profit-sharing contributions to the Plan. Fixed matching contributions shall be equal to the lesser of 100% of the participant's compensation contributed as salary deferrals, not to exceed 15% or, an amount which does not result in an excess aggregate contribution, as defined by the Plan. Fixed matching contributions totaled \$224,596 for the year ended December 31, 2024. Non-discretionary employer profit sharing contributions will be equal to 5% of eligible compensation for the year, as defined, plus an additional 5% for all earnings in excess of the Social Security Taxable Wage Base, adjusted annually. Profit sharing contributions for the year ended December 31, 2024, were \$1,020,464.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant’s account is credited with the participant’s contributions and Company matching contributions as well as allocations of the Company’s profit-sharing contributions and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Vesting** – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service, with 20% vesting each year starting with two years of employment.

**Notes receivable from participants** – Participants may borrow from their accounts amounts equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time. Under the terms of the Plan Agreement, Plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest is paid ratably through biweekly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.00% to 9.50% with various maturities through April 2033.

**Payment of benefits** – On termination of service due to death, disability, reaching age 59 ½, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Unless a participant timely elects otherwise, for vested account balances of \$1,000 or less, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. For vested account balances between \$1,000 and \$5,000, the value of the vested interest will be rolled over to an individual retirement plan designated by the Plan administrator.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to reinstate previously forfeited accounts of rehired participants and then to reduce the funding of the profit sharing and matching contributions. If a participant terminates employment and has not incurred five consecutive one year breaks in service, the previously forfeited nonvested portion of that participant’s account shall be reinstated, provided the participant repays to the Plan any previously distributed vested balance. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$125,747 and \$59,349, respectively. For the year ended December 31, 2024, Company profit sharing contributions funded in 2025 were reduced by \$125,747 from forfeited nonvested accounts.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – Investments are reported at fair value. The Plan's custodian, Charles Schwab Trust Bank, certifies the fair value of the registered investment companies and collective trust. If available, quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants and corresponding matching contributions are recorded in the year in which the related participant compensation is earned.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan Document.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Administrative expenses of operating and maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available to be issued.

### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trust* – Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

*Life insurance policies* – Units held in life insurance policies are valued at current cash surrender value by including the value of any dividend additions or accumulations net of any outstanding policy indebtedness. The cash surrender value is provided by the life insurance company and is determined by inputs including the policy's face value, the premium payment term and the number of years it has been held. The Plan is the named beneficiary on the life insurance policies and each policy is allocated to the insured participant's account so that the proceeds will be payable by the Plan pursuant to the participant's designated beneficiary. There are no restrictions in place to redeem the units held in life insurance policies.

#### Note 4 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 8, 2023, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

#### **Note 6 – Certified Investment Information**

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution:

- Investments and cash reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, except for cash surrender value of life insurance policies and notes receivable from participants.
- Net appreciation in fair value of investments, dividends, and interest reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024, except for interest income on notes receivable from participants and increase in cash surrender value of life insurance policies of \$100,674 included in net appreciation in fair value of investments.
- Investments reflected on the schedule of assets (held at end of year), except for cash surrender value of life insurance policies and notes receivable from participants.

#### **Note 7 – Plan Termination**

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

#### **Note 8 – Party-in-Interest Transactions**

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by Charles Schwab Investment Management, Inc. Charles Schwab Trust Bank is the custodian of the Plan and an affiliate of Charles Schwab Investment Management, Inc. and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.
