***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Wolverine World Wide, Inc. 401(k) Retirement Savings Plan I, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Wolverine World Wide, Inc. 401(k) Retirement Savings Plan I's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. #### **Note A – Description of Plan**

The following description of Wolverine World Wide, Inc. 401(k) Retirement Savings Plan I (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution 401(k) plan covering substantially all eligible employees of participating entities within Wolverine World Wide, Inc. (Company), the Plan's sponsor. Employees generally become participants on the first day of the month following completion of 30 days of service. Upon participation in the Plan, employees become eligible to receive annual matching contributions from the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may elect to make contributions to the Plan through payroll deductions of 1%-100% from each participant's compensation, as defined, subject to statutory limitations. The Plan also allows participants to transfer funds from other qualified plans into the Plan. The Plan requires that certain employees are subject to automatic pay deferrals of 3% unless an affirmative alternate election is made.

The Company may make a discretionary matching contribution based on the participant's contribution. The matching contribution amount for the 2024 and 2023 plan years was 50% of the first 6% of the participant's deferral for participants hired before January 1, 2013. Participants hired after December 31, 2012 received a matching contribution of 100% of the first 5% deferred plus 50% of the next 1% deferred for the years ended December 31, 2024 and 2023.

#### **Plan Operations**

The Company has appointed Empower Trust Company, LLC (the Trustee) to serve as Trustee and the Company to act as plan administrator. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled and approves all distributions from the Plan to participants. The Plan's fiduciary committee is responsible for oversight, determines the appropriateness of the Plan's investment strategy, and monitors investment performance.

#### **Note A – Description of Plan (Continued)**

##### **Participant Accounts**

Individual accounts are maintained for each participant, with benefits limited to the amount contributed to the participant's account plus or minus any allocation of income, expenses, forfeitures, gains, or losses. Allocations to participant accounts are based on compensation or account balances, as specified by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose.

##### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer matching contribution accounts is based on years of continuous service, as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1 year	0%
1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 years or more	100%

A participant shall be credited a year of service for each period in which the participant completes 1,000 hours of service. A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

The accounts of a participant who was a participant in the Wolverine World Wide, Inc. 401(k) Retirement Savings Plan II (Plan II) on December 31, 2019, and who was actively employed as of that date are fully vested.

##### **Loans to Participants**

Under certain conditions, a participant may obtain a loan from the Plan. A participant may borrow a maximum of the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance during the prior 12-month period. Loan terms will generally not exceed five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator, ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### **Note A – Description of Plan (Continued)**

##### **Payment of Benefits**

Upon termination of employment a participant may elect to receive either a lump sum payment in cash or to have the lump sum payment transferred to an eligible retirement plan. Participants with a vested account balance of less than \$1,000 receive an immediate lump sum distribution if no election is made by the participant. Terminated participants who have an account balance that exceeds \$1,000, but is less than \$5,000, will have their balance automatically rolled over into an individual retirement account designated by the Company if no election is made by the participant. After-tax benefits may be withdrawn at any time.

In-service withdrawals are permitted upon attaining age 59½. A participant may also request a withdrawal upon demonstration by the participant to the plan administrator that the participant is suffering from a financial hardship.

##### **Costs and Expenses**

Certain transaction fees and other administrative expenses are paid by the Plan and are based on reasonable and customary rates. Certain other costs and expenses incurred in connection with the operation of the Plan are borne by the Company.

##### **Forfeited Accounts**

Forfeited balances of terminated participants' nonvested accounts are used to reduce the annual Company matching contribution or to pay plan expenses. The balance in the forfeiture account at December 31, 2024 and 2023 was \$490,197 and \$278,144, respectively. Forfeitures of \$265,409 and \$234,144, were used to reduce employer matching contributions during the years ended December 31, 2024 and 2023, respectively. No forfeitures were used to pay plan expenses during 2024 and 2023.

#### **Note B – Summary of Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### ***Note B – Summary of Accounting Policies (Continued)***

##### **Investment Valuation and Income Recognition**

Investments are reported in the Plan's financial statements at fair value (except the guaranteed investment contract, which reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Income from interest is recorded as it is earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document; therefore, an allowance for credit losses is not considered necessary at December 31, 2024 and 2023.

##### **Benefits**

Benefits are recorded when paid.

##### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 9, 2025, which is the date the financial statements were available to be issued.

#### ***Note C – Fair Value Measurements***

The Plan's investments, with exception of the guaranteed investment contract, are reported at fair value in the accompanying statements of assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note C – Fair Value Measurements (Continued)**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets,
- quoted prices for identical or similar assets and liabilities in markets that are not active,
- other inputs that are observable or can be corroborated by observable market data,
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies, and similar techniques that use significant unobservable inputs.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued based on quoted net asset value (NAV) of the shares held by the Plan on the last business day of the plan year.

#### ***Note D – Investment Contract with Insurance Company***

Plan assets include a synthetic guaranteed investment contract issued by Empower Insurance and Annuity Company of America (formerly Prudential Life Insurance Company). The methodology for calculating the interest rate credit is defined in the terms of the contract. Under the existing contract, the crediting rate is reset on a quarterly basis. The crediting interest rate was 0.82% and 1.20% for years ended December 31, 2024 and 2023, respectively. The crediting rate shall not be less than 0%.

The synthetic guaranteed investment contract is a fully benefit-responsive contract, and therefore contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the contract. Contract value, as reported to the Plan by Prudential Insurance Company of America, represents contributions made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals, and fees. There are generally no events that could limit the ability of the Plan to transact at contract value. There are also generally no events that allow the issuer to terminate the contract with less than 30 days' notice, or which require the plan sponsor to settle at an amount different than contract value. With consideration to these guidelines, participants may ordinarily direct permitted withdrawal or transfer all or a portion of their investment at contract value within reasonable timeframes.

#### ***Note E – Risks and Uncertainties***

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amount reported in the statements of assets available for benefits.

#### ***Note F – Information Certified by Certifying Entities***

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, revenue sharing income, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the certifying entities. Certifications were provided by Prudential Bank & Trust, FSB LLC for Plan activity occurring through March 31, 2023, and Empower Insurance and Annuity Company of America as of December 31, 2023 and from April 1, 2023 through December 31, 2023. Certifications were provided by Empower Insurance and Annuity Company of America and Empower Trust Company, LLC as of December 31, 2024.

#### ***Note G – Party-In-Interest Transactions***

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$612,787 and \$607,718 for the years ended December 31, 2024 and 2023, respectively. Such fees were based on reasonable and customary rates.

In addition, the Plan maintains notes receivable from participants. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

#### ***Note H – Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

#### ***Note I – Tax Status***

The Plan obtained its latest determination letter dated August 23, 2023, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### ***Note J – Transfers to and from Related Plans***

During the year ended December 31, 2023, \$11,095 was transferred to the Plan from the Wolverine World Wide, Inc. 401(k) Retirement Savings Plan II. There were no transfers for the year ended December 31, 2024.

Effective December 31, 2022, the Sweaty Betty USA Digital LLC 401(k) Plan merged with the Plan. During the year ended December 31, 2023, \$624,593 was transferred from the Sweaty Betty USA Digital LLC 401(k) Plan.
