Note A – Description of Plan

The following description of Wolverine World Wide, Inc. 401(k) Retirement Savings Plan II (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Wolverine World Wide, Inc. (the "Company"). The Plan covers substantially all United States hourly and retail employees who have completed one year of service (six months if hired before January 1, 2017), are at least twenty-one years of age, and meet the definition of eligibility as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make contributions to the Plan through payroll deductions of 1%-100% from each participant's compensation, as defined, subject to statutory limitations. The Plan also allows participants to transfer funds from other qualified plans into the Plan. The Plan requires that certain employees are subject to automatic pay deferrals of 3% unless an affirmative alternate election is made.

The Company may make a discretionary matching contribution based on the participant's contribution. The matching contribution amount for the 2024 and 2023 plan years was 50% of the first 6% of the participant's deferral for participants hired before January 1, 2013. Participants hired after December 31, 2012 received a matching contribution of 100% of the first 5% deferred plus 50% of the next 1% deferred for the years ended December 31, 2024 and 2023.

Plan Operations

The Company has appointed Empower Trust Company, LLC (the Trustee), to serve as Trustee and the Company to act as plan administrator. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan, ensures that all government and participant reporting requirements are fulfilled, and approves all distributions from the Plan to participants. The Plan's fiduciary committee is responsible for oversight, determines the appropriateness of the Plan's investment strategy, and monitors investment performance.

Participant Accounts

Individual accounts are maintained for each participant, with benefits limited to the amount contributed to the participant's account plus or minus any allocation of income, expenses, forfeitures, gains, or losses. Allocations to participant accounts are based on compensation or account balances, as specified by the plan document.

Participant Accounts (Continued)

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contribution accounts is based on years of continuous service, as follows:

1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 years or more	100%

A participant shall be credited a year of service for each period in which the participant completes 1,000 hours of service. A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

Participants in the Plan on December 31, 2016 are 100% vested in Company matching contributions made after January 1, 2007. Prior to January 1, 2007, a participant's interest in the Company's contributions and earnings thereon vested after three years of service with the Company. A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

Loans to Participants

Under certain conditions, a participant may obtain a loan from the Plan. A participant's loan cannot exceed the lesser of \$50,000 or one half of the participant's vested account balance reduced by the highest outstanding loan balance in the account during the prior 12-month period. Loan terms may not exceed five years except for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator, ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. A participant may have only one loan outstanding at any one time.

Payment of Benefits

Upon termination of employment a participant may elect to receive either a lump sum payment in cash or to have the lump sum payment transferred to an eligible retirement plan. Participants with a vested account balance of less than \$1,000 receive an immediate lump-sum distribution if no election is made by the participant. Terminated participants who have an account balance that exceeds \$1,000, but is less than \$5,000, will have their balance automatically rolled over into an individual retirement account designated by the Company if no election is made by the participant. After-tax contributions may be withdrawn at any time.

In-service withdrawals are permitted upon attaining age 59½. A participant may also request a withdrawal upon demonstration by the participant to the plan administrator that the participant is suffering from a financial hardship.

Costs and Expenses

Certain transaction fees and other administrative expenses are paid by the Plan and are based on reasonable and customary rates. Certain other costs and expenses incurred in connection with the operation of the Plan are borne by the Company.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce the annual Company matching contribution or to pay plan expenses. The balance in the forfeiture account at December 31, 2024 and 2023 was \$72,935 and \$51,484, respectively. Forfeitures of \$74,889 and \$27,951 were used to reduce employer matching contributions during the years ended December 31, 2024 and 2023, respectively. No forfeitures were used to pay plan expenses during 2024 or 2023.

Note B – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported in the Plan's financial statements at fair value (except the guaranteed investment contract, which is valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Income from interest is recorded as it is earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expense when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document; therefore, an allowance for credit losses is not considered necessary at December 31, 2024 and 2023.

Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 9, 2025, which is the date the financial statements were available to be issued.

Note C – Fair Value Measurements

The Plan's investments, with the exception of the guaranteed investment contract, are reported at fair value in the accompanying statements of assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Fair Value Measurements (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets,
- quoted prices for identical or similar assets and liabilities in markets that are not active,
- other inputs that are observable or can be corroborated by observable market data,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on quoted net asset value (NAV) of the shares held by the Plan on the last business day of the plan year.

Note D – Investment Contract with Insurance Company

Plan assets include a synthetic guaranteed investment contract issued by Empower Insurance and Annuity Company of America (formerly Prudential Life Insurance Company). The methodology for calculating the interest rate credit is defined in the terms of the contract. Under the existing contract, the crediting rate is reset on a quarterly basis. The crediting interest rate was 0.82% and 1.20% for years ended December 31, 2024 and 2023, respectively. The crediting rate shall not be less than 0%.

The synthetic guaranteed investment contract is a fully benefit-responsive contract, and therefore contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the contract. Contract value, as reported to the Plan by Prudential Insurance Company of America, represents contributions made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and fees. There are generally no events that could limit the ability of the Plan to transact at contract value. There are also generally no events that allow the issuer to terminate the contract with less than 30 days' notice or which require the plan sponsor to settle at an amount different than contract value. With consideration to these guidelines, participants may ordinarily direct permitted withdrawal or transfer all or a portion of their investment at contract value within reasonable timeframes.

Note E – Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of assets available for benefits.

Note F – Information Certified by Certified Entities

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, revenue sharing income, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the certifying entities. Certifications were provided by Prudential Bank & Trust, FSB LLC for Plan activity occurring through March 31, 2023, and Empower Insurance and Annuity Company of America as of December 31, 2023 and from April 1, 2023 through December 31, 2023. Certifications were provided by Empower Insurance and Annuity Company of America and Empower Trust Company, LLC as of December 31, 2024.

Note G – Party-In-Interest Transactions

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$140,044 and \$137,966 for the years ended December 31, 2024 and 2023, respectively. Such fees were based on reasonable and customary rates.

In addition, the Plan maintains notes receivable from participants. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

Note H – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

Note I – Tax Status

The Plan obtained its latest determination letter dated August 23, 2023, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note J – Transfers to and from Related Plans

During the year ended December 31, 2023, \$11,095 was transferred from the Plan to the Wolverine World Wide, Inc. 401(k) Retirement Savings Plan I. There were no transfers for the year ended December 31, 2024.
