Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of FMS 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of FMS 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the FMS 401(k) Profit Sharing Plan and Trust (the "Plan"), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Utilitra, LLC for the benefit of all eligible non-union employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Participation

The Plan covers substantially all employees of J.F. Electric, Incorporated and Utilitra, LLC (the "Companies" or "Employers"), with the exception of employees covered by a collective bargaining agreement, except for Local 2150 Electrical Designers, or employees considered to hold a position under the title "intern". Eligible employees may become participants in the Plan for purposes of making pre-tax or Roth contributions and receiving safe-harbor contributions on the first enrollment date, which is the first of the month after the employee starts employment, and after the employee has attained age 18. Participants become eligible to receive non-elective employer contributions on the first enrollment date that occurs after the employee has completed 1,000 hours of service during the previous 12 consecutive months and has attained age 18.

Contributions

Plan participants may contribute a percentage of pre-tax annual compensation, not to exceed the dollar limitation contained in Section 402(g) of the Internal Revenue Code (the "IRC"), through a salary reduction election. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. A participant is eligible to a safe-harbor match of 100% of the first 5% of the participant's covered compensation for the Plan year. The Companies may contribute additional profit-sharing amounts at the discretion of the Companies' Board of Directors. For the years ended December 31, 2024 and 2023, no discretionary contributions were made.

Participant accounts

Each participant's account is credited with the participant's deferral contributions, rollover contributions, and allocations of (a) the Companies matching contribution and, (b) Plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The participant's account is debited with any distributions or withdrawals made to the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their voluntary contributions and the Companies' safe-harbor contributions plus actual earnings thereon. Participants become vested in the Companies' profit sharing contributions ratably over six years, beginning in the second year of participation. A participant is 100% vested upon the completion of six years of service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest equal to the prime rate as published by the Wall Street Journal on the date of the loan plus two percent. Principal and interest are collected ratably through payroll deductions.

Payment of benefits

The Plan provides that a participant's vested interest in the Plan will be distributed to the participant upon retirement, total disability or death. Employees terminating employment with the Companies for other reasons are entitled to their vested interest in the Plan. Participants with vested account balances in excess of \$5,000 may elect to defer distribution to a future date as fully described in the Plan document. Distributions may be made in lump-sum amounts, in annual or more frequent periodic amounts as defined by the Plan, or by a combination of the two methods, as selected by the participant.

Participants may also withdraw certain basic contributions thereon in the event of a financial hardship as defined by the Plan and the IRC.

Forfeitures

The nonvested portion of a participant's distribution will be considered forfeited. Amounts forfeited from a participant's account may be used to reduce the Companies' contributions or to pay Plan expenses. Forfeitures utilized to reduce the Companies' contributions for the years ending December 31, 2024 and 2023 amounted to \$981 and \$0, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value except for the fully benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit payments

Benefit payments to participants are recorded when paid.

Excess contributions payable

Excess contributions payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from the Plan's financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

3. INVESTMENT INFORMATION CERTIFIED OR PROVIDED BY TRUSTEES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as of and for the years ending December 31, 2024 or 2023, Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively "Empower"), the trustees of the Plan, have certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits, the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year), and the information related to investment activity reflected in the statements of changes in net assets available for benefits.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan's Key Guaranteed Portfolio Fund investment option is a group annuity contract issued by Empower Annuity Insurance Company of America (the "issuer") for the years ending December 31, 2024 and 2023, respectively, and is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of the issuer and not on the value of the securities within the insurer's general account. The credit ratings of the issuer at December 31, 2024 and 2023 are considered investment grade and there were no reserves against contract value for credit risk of the contract issuer or otherwise. Only an event causing liquidity constraints at the issuer could limit the ability of the Plan to transact at the contract value to be paid within 90 days, or in rare circumstances, the contract value to be paid over time. There are not any events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value to be paid either within 90 days or over time. The Plan considers this contract to be fully benefit-responsive.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (continued)

The Key Guaranteed Portfolio Fund does not operate like a mutual fund, variable annuity product, or conventional fixed rate individual annuity product. Under the group annuity contract that supports this product, participants may ordinarily direct a permitted withdrawal or transfer of all or a portion of their account balance at contract value, within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. Interest is credited on contract balances using the "portfolio rate" approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of these contributions. Interest crediting rates are reviewed on a quarterly basis for resetting by the issuer.

When establishing interest crediting rates for this product, the issuer considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the general account. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than zero percent.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants shall immediately become 100% vested and, therefore, be entitled to receive a distribution of the value of all cash and investment units credited to his or her account as of that date.

7. INCOME TAX STATUS

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, stating that the Plan is qualified under IRC Section 401(a). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

U.S. GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. PARTY-IN-INTEREST TRANSACTIONS

ERISA defined party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

For the years ending December 31, 2024 and 2023, certain Plan investments were managed by Empower. Empower is the third-party administrator and trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services totaled \$116,473 and \$112,215 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the plan for investment fees are reflected in net appreciation in fair value of investments.

10. SUBSEQUENT EVENTS

The Plan is subject to an annual safe-harbor true-up matching contribution. Effective January 1, 2025, safe-harbor matching contributions in an amount equal to 100% of the matched employee contributions that are not in excess of 5% of plan compensation will be allocated to participant accounts as soon as administratively feasible after the end of each pay period.
