### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The San Diego Roofers Trust (the "Plan") was formed in 1963 under an agreement between the San Diego Roofers Union, Local 45 (the "Union") and the United Roofing Contractors Association. This agreement established a plan under which employers of Union members ("Employers") contribute amounts to the Plan on behalf of eligible employees.

The Declaration of Trust (the "Trust") and the Plan are subject to the provisions of the Labor-Management Relations Act of 1947 ("Taft-Hartley") and Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Under the provisions of the Declaration of Trust, three trustees are to be appointed by the Union and three trustees are to be appointed by the Employers' associations (collectively, the "Trustees" or "Board of Trustees").

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Employer Contributions**

Employer contributions as reported are contributions made by employers on behalf of employee hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

**D. Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employer's payroll records. The system of internal control provides for examination of employer's payroll records under a separate payroll compliance program.

**E. Benefits**

The Plan provides health benefits (hospital, surgical, major medical, dental, disability, and death benefits) through various insurance contracts covering active participants with 400 hours in four consecutive months becoming eligible in the 6th month. Hours worked in excess of the 400 hours ("bank hours") may be carried forward to a maximum of 400 hours and may be utilized in future months. The Plan requires participants to work 100 hours per month to maintain eligibility. Once a participant reaches 100 hours, any reported hours in excess of 100 go into the participant's bank hours.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**F. Tax-Exempt Status**

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501 (c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**G. Benefits and Benefits Obligations**

The Plan is required to provide benefits to certain active Plan participants if such participants have accumulated credit amounts (expressed as bank hours) in excess of the hours required for current coverage. The estimated liability is determined based on the Plan's estimate of the average cost of benefits provided, extended by bank hours accumulated. Premiums payable is calculated from the premiums paid subsequent to the end of year, on behalf of active participants for coverage during the year.

Under the Plan, eligible participants may receive disability benefits in accordance with the Plan description. The estimated liability represents premiums paid by the Plan into a self funded disability insurance program.

The Plan provides dental benefits to active members on a self-funded basis. The estimated liability represents the Plan's estimate for incurred but not reported dental claims. The estimate approximates three months of expenses.

**H. Investment Valuation and Income Recognition**

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Investment income includes interest income and unrealized gains and losses.

**NOTE 4 - CONCENTRATION OF CREDIT RISK**

At November 30, 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

**NOTE 5 - PLAN TERMINATION**

Although there has been no expressed intent to do so, the Plan may be terminated in accordance with the provisions of ERISA and related regulations. In the event of termination of the Plan, the assets then remaining, after providing for the expense of the Plan and for the payment of any distributions already approved, shall be distributed among the participants.

**NOTE 6 - RISKS AND UNCERTAINTIES**

Plan investments are exposed to various risks, such as interest rates, marketing fluctuations and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect the amounts reported in the financial statements.

**NOTE 7 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 15, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.


