## INDEPENDENT AUDITORS' REPORT

To the Retirement Plan Committee of

### **D.P. ELECTRIC, INC. 401(k) PLAN**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of *D.P. Electric, Inc. 401(k) Plan* (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules of delinquent participant contributions and of assets (held at year end) as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### (1) Description of the Plan

The following description of the *D.P. Electric, Inc. 401(k) Plan* (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General** - The Plan is a defined contribution retirement plan covering all employees of D.P. Electric, Inc. (the "Sponsor") who are not represented by a collective bargaining agreement or a non-resident alien. Eligibility requirements of the Plan are one year of service and attaining 18 years of age for all Plan contribution types. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA") and has been amended various times since inception.
- B. Participant contributions** - Participants may contribute up to 100% of their compensation on a pre-tax or after-tax (Roth) basis, as defined by the Plan, subject to certain limitations prescribed by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified pension plans. In addition, the Plan allows participants, attaining the age of 50 before the end of the Plan year, to make additional catch-up contributions to the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation on a pre-tax basis and their contributions invested in a designated balanced fund, unless an employee makes a different affirmative election or declines participation.

Plan entry is on a quarterly basis, on the first day of the month following the date an employee satisfies the eligibility requirements of the Plan. The permissible withdrawal provisions, as defined in the Plan document, provide participants with a 90 day period to revoke their automatic enrollment in the Plan.

- C. Employer contributions** - The Sponsor makes safe harbor contributions equal to 100% of each participant's deferrals up to 1% of the participant's compensation, plus 50% of the next 5% of the participant's deferrals. As a result, at no time can the Sponsor's safe harbor contribution exceed 3.5% of a participant's eligible compensation. Employer contributions are invested in the same funds and increments as directed by participants. Effective January 1, 2024, the Plan was amended to revise the safe harbor contribution formula to eligible Plan compensation earned during the Plan year by each participant versus on a per pay period basis.

The Plan also contains provisions for non-elective discretionary (profit-sharing) contributions. Profit-sharing contributions are at the discretion of the Sponsor and allocated to participant accounts based on allocation groups designated by the Sponsor. In order to receive an allocation of the Sponsor's non-elective discretionary contributions, employees must meet eligibility requirements of the Plan and be employed on the last day of the Plan year, unless such employee terminates employment during the Plan year due to death, disability, or reaching normal retirement age, as defined in the Plan document. The Sponsor did not authorize non-elective discretionary contributions for the year ended December 31, 2024.

- D. Participant accounts** - Each participant's account is credited with the participant's contributions, the Sponsor's safe-harbor and non-elective discretionary contributions, actual Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### (1) Description of the Plan (continued)

**E. Vesting** - Participants are immediately vested in their voluntary and rollover contributions, plus accrued earnings thereon. For the Sponsor's safe harbor contributions, plus actual earnings thereon, participants vest 50 percent beginning after one year of service and become fully vested after two years of service.

Effective January 1, 2018, participants vest in the Sponsor's non-elective discretionary contributions, plus actual earnings thereon, based on years of service as follows:

<u>Years of Service for Vesting</u>	<u>Percentage</u>
1	33%
2	67%
3	100%

The Sponsor's non-elective and discretionary matching contributions made to the Plan on or before December 31, 2017, plus actual earnings thereon, have a graded vesting schedule whereby participants vest 20% after the first year of service and are 100% vested after 5 years of service.

The Plan defines a year of credited service to be a Plan year with at least 1,000 hours of service. Upon death or total disability of a participant prior to retirement, the participant's account balance shall become fully vested.

**F. Payment of benefits** - If the value of a participant's vested benefit is more than \$7,000 on termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum payment amount equal to the value of his or her account, or annual installments over a certain period, and in no event exceeding the life expectancy of the participant as determined at the time of distribution. If the value of a participant's vested benefit is \$1,000 or less, a lump sum payment will be made to the participant. The Plan provides for the payment of benefits in amounts up to the entire vested balance in a participant's account upon one of the following:

- a. Termination of employment
- b. Death or disability of participant
- c. Attainment of age 59 ½
- d. Demonstrated hardship

The Plan also allows for in-service distributions for participants who have not separated from service based on the later of the date the participant attains normal retirement age (65) or 5 years of service.

**G. Notes receivable from participants** - Participants may borrow an amount not to exceed 50% of their vested account balance, up to a maximum of \$50,000 (but not less than \$1,000). All notes receivable must be repaid through an established repayment schedule, not to exceed five years from the date the proceeds are received, unless the entire proceeds are used to purchase the participant's primary residence, in which case the loan may be repaid over a longer term. The interest rate is based on the prime interest rate plus 1% at the time of the loan and is fixed over the life of the loan. Upon default, death, disability, or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable.

**H. Forfeitures** - Forfeitures of nonvested accounts are utilized to pay administrative expenses, reduce employer contributions, or may be reallocated to participant accounts as additional employer contributions, as required by the Plan document. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32,917 and \$21,411, respectively. During the year ended December 31, 2024, \$325 of forfeited nonvested accounts were used to pay administrative expenses.

### (1) Description of the Plan (continued)

- I. Termination of the Plan** - Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, participants become 100% vested in the Sponsor's contributions.
- J. Administrative expenses** - The Sponsor has elected to pay certain administrative expenses on behalf of the Plan during 2024. The Plan has no obligation to reimburse the Sponsor for such expenses. Participant loan origination fees are charged to the account of the participant requesting the loan.

### (2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** - The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

**Management's use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Plan to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results may differ from those estimates.

**Fair value measurement** - The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. If a Level 1 input is available, it must be used.
- Level 2: Inputs other than quoted prices that are observable for assets or liabilities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means.
- Level 3: Unobservable inputs, which contain assumptions by the party valuing those assets or liabilities. For Level 3 inputs, there is no market data or correlations with market assumptions. Examples would include limited partnership interests, closely held stock, etc.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Investment valuation and income recognition** - Mutual funds and the common collective trust are reported at fair value. The investment contract with insurance company is reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### (2) Significant accounting policies (continued)

The following is a description of the valuation methodologies used for the investments held by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds - Stated at net asset values, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.
- Common collective trust ("CCT") - Valued based upon the quoted redemption value of units, or the equivalent of net asset value, which is the practical expedient for estimating fair value. This investment had no unfunded commitments as of December 31, 2024 and can be redeemed daily with no redemption notice period or other redemption restrictions.
- Investment contract with insurance company - Investments in a fully benefit responsive fixed income guaranteed option are required to be reported at contract value rather than fair value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Risks and uncertainties** - The Plan provides for various investment fund options which, in turn, invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. The Plan's exposure to credit losses in the event of nonperformance of investments is limited to the carrying value of such investments. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Payment of benefits** - Benefits are recorded when paid.

**Subsequent events** - Plan management has evaluated subsequent events through September 9, 2025, which is the date the financial statements of the Plan were available to be issued.

### (3) Income tax status

The Plan has adopted a defined contribution Prototype Plan document, which obtained a favorable opinion dated November 14, 2022, stating that the Prototype Plan and related trust are designed in accordance with the applicable Internal Revenue Code ("IRC"). The Plan administrator and the Sponsor believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC, and that the Plan is qualified and the related trust is tax exempt as of and for the year ended December 31, 2024.

\*Certain investments that are measured using net asset value per share (or its equivalent) as a practical expedient for determining fair value are not required to be classified in the fair value hierarchy. ### (5) Investment contract with insurance company

The Plan participates in an investment contract with Empower Annuity Insurance Company of America ("Empower") via the Guaranteed Interest Fund ("GIF"). The GIF is collateralized by the general assets of Empower. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire portfolio compared to the minimum interest credit rate stated in the contract and prevailing market conditions. The interest crediting rate is reset quarterly. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

Certain events may limit the ability of the Plan to transact at contract value with the contract issuer. No events are considered probable of occurring, but examples of such events include the following:

- 1) The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
- 2) Premature termination of the contracts
- 3) Plan termination or merger
- 4) Changes to the Plan's prohibition on competing investment options
- 5) Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount other than contract value. Although no such events are considered probable of occurring, examples of such events include the following:

- 1) An uncured violation of the Plan's investment guidelines
- 2) A breach of material obligation under the contract
- 3) A material misrepresentation
- 4) A material amendment to the agreement without the consent of the issuer

### (6) Information certified by the Plan's custodians

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians, have certified that the following information included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments
- Notes receivable from participants
- Interest income on notes receivable from participants
- Interest and dividends
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### (7) Party-in-interest transactions

The Sponsor provides all employer contributions to the Plan; consequently, these transactions qualify as party-in-interest transactions.

Certain Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians, as defined by the Plan. The custodians provided the Plan with contract administration, investment management, and recordkeeping services, which qualify as party-in-interest transactions. Total administrative expenses paid by the Plan to the custodians for the year ended December 31, 2024 totaled \$56,305. There was also \$38,234 paid to another party during the year ended December 31, 2024 that consisted of investment management and Plan fiduciary advisory services.

Revenue sharing payments are made from administrative expenses paid by participants investing in the funds offered under the Plan. Amounts received from the investment fund managers qualify as party-in-interest transactions and are presented net of total administrative expenses in the statement of changes in net assets available for benefits. During the year ended December 31, 2024, \$38,234 of revenue sharing payments received offset custodian administrative expenses.

### (8) Delinquent participant contributions

Plan management determined that certain participant contributions withheld by the Plan Sponsor during the 2023 Plan year were remitted late based upon guidelines established by the DOL. These participant contributions totaled \$440 and were corrected by Plan management during the 2024 Plan year. Lost earnings associated with the corrections were not material for the Plan as a whole.

During 2024, Plan management determined that certain instances of participant contributions and loan repayments withheld by the Plan Sponsor were remitted late based upon guidelines established by the DOL. These participant contributions and loan repayments totaled \$7,523 and were corrected by Plan management during the 2025 Plan year. Lost earnings associated with the corrections were not material to the Plan as a whole.
