**NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF THE PLAN

The following description of the Unity House of Cayuga County, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

General

The Plan is a defined contribution plan which covers substantially all employees of Unity House of Cayuga County, Inc. (the Sponsor) who are 21 years of age and have completed 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make voluntary contributions up to the annual dollar limit set by law of pretax annual compensation, as defined by the Plan. Participants can also elect to voluntarily contribute after-tax Roth contributions to the Plan. Participants can also make deferral contributions on any employer paid bonus. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers investments in registered investment companies and a money market fund as investment options for participants.

The Plan includes an automatic enrollment provision. Newly eligible employees who have otherwise not affirmatively opted out of enrolling in the Plan are automatically enrolled. Participants enrolled as a result of this provision must defer 3% of their compensation to the Plan. The Plan also includes an auto-escalation provision whereby deferrals are increased by 1% each year, to a maximum of 6%, if the employee does not elect otherwise.

Participants are eligible for matching contributions only if they make deferral contribution to the Plan. The matching contributions include age 50 and over catch-up contributions. Employer matching contributions are allocated to participants accounts. The Sponsor makes employer matching contributions to the Plan equal to 100% of the first 1% of the participant's contribution and 50% of the next 5% of the participant's contribution, up to 3.5% of the participant's total compensation.

The Sponsor may make discretionary matching contributions to the Plan which are allocated to individual participant accounts. Within certain maximum limitations, the amounts of the Sponsor's annual contributions are determined by the Board of Directors. No discretionary matching contributions were made in 2024 or 2023.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution and (b) plan earnings/losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

1. DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are immediately vested in all salary reduction contributions, Roth contributions and rollover contributions plus actual earnings thereon.

As of January 1, 2018, employer matching contributions and employer nonelective contributions and any earnings thereon are vested in accordance with the following schedule:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are repayable over not more than two years, except in the case of a loan for the purchase of a primary residence. Participants must make loan payments through payroll deductions. The loans are secured by the balances in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator. Interest rates range from 4.25% to 9.50%.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or delay payment for a reasonable time for administrative convenience. However, unless the participant chooses to defer payment, the Plan must begin payments within 60 days after the close of the Plan year following the latest of: (a) the date on which the participant reached your Normal Retirement Age, or (b) the 10th anniversary of the year in which the participant became a participant in the Plan, or (c) the date the participant terminated employment with the employer. Also, withdrawals from participant accounts are not allowed before age 65 except in the event of death, disability or termination, without being subject to penalty. The Plan does not allow for hardship withdrawals.

1. DESCRIPTION OF THE PLAN (Continued)

Forfeited Accounts

In 2024 and 2023, forfeitures of \$12,308 and \$14,279, respectively, were used for expenses of the Plan. Unused forfeitures amounted to \$437 and \$432 at December 31, 2024 and 2023, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions in any of the investment options available. The Plan currently offers mutual funds and a money market fund as investment options. Participants may change their investment options at any time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant-directed.

Fair Value of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value of Financial Instruments (Continued)

The following is a description of the valuation methodology used for assets measured at fair value.

Money market fund and registered investment companies: Valued at the net asset value of shares held at year end based on quoted prices in active markets.

There have been no changes to the valuation techniques used during 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded based upon the terms of the Plan document.

Allowance for Credit Losses

The Plan records a receivable for the employer contribution that is remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant improvements or deteriorations are expected in the future economic conditions, therefore management has determined that no allowance for credit losses is necessary for the years ended December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Plan document states that at the discretion of the Sponsor, any administrative expenses can be paid by either the Plan or the Sponsor. For the years ended December 31, 2024 and 2023, administrative expenses of \$14,628 and \$13,971, respectively, were paid by the Plan Sponsor.

Investment Fees

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and are not separately identifiable as an expense.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates and such differences may be significant.

5. TAX STATUS

The Plan is operating under the Volume Submitter Profit Sharing Plan prepared by Fidelity Management Company. The Volume Submitter Profit Sharing Plan with CODA obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

6. PARTIES-IN-INTEREST TRANSACTIONS

Fidelity Management Trust Company is the trustee of the Plan's assets. Fidelity Investments is the recordkeeper of the Plan. Therefore, transactions between Fidelity Management Trust Company, Fidelity Investments, and the Plan qualify as party-in-interest transactions. Also, plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

8. PLAN TERMINATION

Although it has not expressed intent to do so, the Sponsor has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the terms of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.
