We have performed an audit of the accompanying financial statements of Bass Underwriters, Inc. 401(k) P.S. Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Bass Underwriters, Inc. 401(k) P.S. Plan (the "Plan"), effective January 1, 2002, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Bass Underwriters, Inc., Broward Insurance Consulting, LLC, Bass Underwriters of Florida, Bulldog Premium Finance, LLC, Insurance Technologies, Inc. and Gridiron Insurance Underwriters, Inc. (collectively the "Sponsor") who have three months of service except for collectively bargained employees, non-resident aliens and employees who became employees as the result of a merger or acquisition, as defined in the Plan documents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to the maximum percentage allowable, not to exceed the limits of code sections 401(k), 402(g), 404 and 415, as defined in the Plan document. Participants direct their account balance into various investments offered by the Plan and may also contribute amounts representing distributions from other qualified defined benefit or contribution plan rollovers. The Company matches 100% of the first 3% and 50% of the next 2% of eligible participant's contributions commencing after one year of eligible service and may also contribute additional discretionary profit sharing contributions. For the year ended December 31, 2024, employer contributions were \$1,504,459.

**Participant accounts and vesting**

The Plan is a safe harbor 401(k) plan, which among other things provides that certain committed contributions are fully vested when made. The sponsor may elect to make additional discretionary non elective and matching contributions each year which vest at a rate of 20% after two years of credited service and become 100% vested after six years of credited service.

In accordance with the Plan's auto enrollment provisions, 3% of new participant's salaries are automatically contributed to the Plan each pay period unless they choose otherwise. Each participant's account is credited with the participant's contribution, the sponsor's contribution, and plan earnings. Plan earnings are credited to the participants' accounts based on the performance of the investments selected by each participant. Participants are immediately vested in their voluntary and safe harbor sponsor contributions plus actual earnings thereon.

All non-vested benefits are forfeited by participants should they terminate employment prior to becoming vested. Such forfeitures are used by the Sponsor to offset administrative expenses or reduce future matching contributions to the Plan.

For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0.

**Cash in transit**

Cash in transit are amounts received by the custodian but not yet allocated to participant accounts and amounted to \$7,734 and \$166 at December 31, 2024 and 2023, respectively.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can only have one outstanding loan. The loans are secured by the balance in the participant's account and bear interest at the prevailing bank market interest rate at the time of the loan as determined by the plan administrator. Principal and interest is paid ratably through regular payroll deductions. At December 31, 2024 and 2023, loans collateralized by participant accounts amounted to \$447,529 and \$450,537, respectively, and bear interest at 4.25% to 9.50% annually. The interest rates charged are commensurate with local prevailing rates as determined periodically by the Plan administrator. Interest income of \$29,663 was recognized on these loans during 2024.

**NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)**

**Payment of benefits**

Participants' vested account balances are payable upon termination, retirement, disability, death, and approved hardship either (1) in a lump-sum amount equal to the value of the account balance, (2) in installment payments over a period of not more than the assumed life expectancy of the participant and beneficiary, if any, (3) by an account balance transfer to an individual retirement account or other qualified plan, or (4) any combination of the foregoing.

**Investment and administrative expenses**

Fees paid by the Plan during the year ended December 31, 2024 consisted of administration fees and third party administrator fees which amounted to \$168,347. All other expenses related to the Plan were paid by the Company.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

**Basis of accounting**

The Plan's financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition**

Investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Note 3 further details fair value measurements of the Plan. Assets of the Plan are reflected in the accompanying statements at fair value.

In accordance with the policy of stating investments at market value, the Plan presents in the statement of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of benefits**

Benefits are recorded when paid.

**Subsequent events**

The Plan has evaluated subsequent events through September 12, 2025, the date when the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of level 3 inputs for the periods presented.

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)**

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

**NOTE 4 – STABLE VALUE FUND**

The Morley Stable Value Fund Class 25 (the "Fund"), primarily consists of a diversified portfolio of Stable Value Investment Contracts (Investment Contracts) issued by life insurance companies, banks and other financial institutions, the performance of which may be predicated on underlying fixed income investments which consists primarily of U.S. government, credit, asset backed and mortgage backed securities. Funds with underlying securities of guaranteed investment contracts (GIC's) which have a guaranteed rate of return should be stated at contract value instead of fair value. Since only 1% of the Fund's underlying securities include GIC's, the Fund is stated at fair value. Participant initiated withdrawals are permitted from the Fund.

At December 31, 2024 and 2023, the fair value of the Fund was \$306,071 and \$61,056, respectively.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company can discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination, each participating employee shall become 100% vested in the Plan, and the assets shall be allocated among participating employees and beneficiaries in proportion to the employees' respective account balances.

**NOTE 6 – TAX STATUS**

The Company has established, and intends to maintain, the Plan as a qualified plan under IRC Section 401 which provides for exemptions from federal income taxation. The Plan obtained its latest determination letter on May 14, 2010, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter; however, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan's administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mid Atlantic Trust Company and AssetMark Trust Company (managed accounts), the trustees of the Plan, have certified the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the related investment activity reflected and interest income on notes receivable from participants in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the information reflected on the supplementary schedule of assets (held at end of year) as of December 31, 2024. This information has not been audited by the Plan's independent auditors.

**NOTE 8 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by AssetMark, the trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment advisory and investment management services totaled \$96,201 for the year ended December 31, 2024. All these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 – FIDELITY BONDING**

The Company maintains a fidelity bond of \$1,000,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.
