### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of HRP Associates, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of the Plan**

The following description of the HRP Associates, Inc. 401(k) Profit Sharing Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution plan covering substantially all employees of HRP Associates, Inc. (the Plan Sponsor and Employer) who are at least 19 years old and have completed six months of service. Entry dates into the Plan are the first day of the month following satisfaction of eligibility requirements. The Plan was established under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the administrator of the Plan (Plan Administrator). As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company (Fidelity) is the appointed trustee of the Plan, and acts at the direction of the Plan Administrator.

***Contributions***

Participants may contribute any percentage up to 60% of annual compensation, as defined in the Plan document, up to the annual limitation prescribed by the Internal Revenue Service (IRS), on a pre-tax or after-tax basis (Deferral). Participants who will be age 50 or older by the end of the calendar year and who are making Deferral contributions may also make a catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans if the contributions satisfy the tax law requirements for a qualified rollover (Rollover).

Effective February 14, 2024, the Plan was amended to include an automatic contribution provision under which eligible employees are automatically enrolled to contribute 3% of pre-tax compensation to the Plan unless they affirmatively elect otherwise. Each participant who is making automatic contributions shall have their participant contribution deferral increased annually by 1% of compensation until the default percentage of 10%. Eligible employees may elect not to contribute to the Plan, or elect to contribute a different percentage of compensation.

The Employer may make a discretionary non-elective contribution. Non-elective Employer contributions, if made, are allocated to participants in the ratio that their eligible compensation bears to the total eligible compensation paid to all eligible participants for the Plan year. Participants are eligible to receive non-elective Employer contributions after completing one year of service and upon completion of 1,000 hours of service within a Plan year. Participants' allocation of non-elective Employer contributions is calculated on January 1, April 1, July 1, or October 1, coinciding with the next entry date following the completion of eligibility requirements. A participant must be employed by the Employer on the last day of the Plan year in which it was made. The Employer elected to contribute \$255,136 in 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Employer non-elective contributions and Plan earnings/losses and any expenses incurred. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings on those contributions. Participants become vested in the non-elective Employer contributions and the allocated earnings on those contributions as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years and 100% after 6 years. Participants are immediately vested in all accounts upon death, disability, or attainment of retirement age as defined by the Plan. A year of vesting service is equal to the Plan year.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant can only have one loan outstanding at any time. Note terms range from one to five years, or up to 10 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest at a rate determined reasonable by the Plan Administrator as defined in the Plan document. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

On retirement, death, disability, or termination of service, a participant (or the participant's beneficiary in the event of death) will be entitled to 100% of their vested account balance, payable in a single lump-sum distribution. If a participant's vested balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance, and the non-vested portion shall be treated as a forfeiture. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$7,000 (increased from \$5,000 effective January 1, 2024), the amount will be rolled over to an individual retirement plan designated by the trustee, unless otherwise directed by the participant.

The Plan allows for in-service distributions of the participant's vested account balance upon reaching the age of 59½ or due to disability, as defined by the Plan. In-service withdrawals are also permitted for Rollover account balances at any time.

Participants may request a financial hardship withdrawal from their accounts, subject to the limitations imposed by the IRC. The minimum permitted hardship withdrawal is \$500.

***Forfeitures***

Participants in the Plan who leave the employment of the Employer before completing six years of service forfeit the non-vested portion of the non-elective Employer contributions to their accounts. Forfeitures may be used to reduce non-elective Employer contributions and Plan administrative expenses. At December 31, 2024 and 2023, forfeited non-vested balances were \$17,792 and \$26,345, respectively.

Subsequent to December 31, 2024, forfeitures in the amount of \$17,908 were used to reduce Employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within the stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

***Contributions***

Participant contributions are recorded bi-weekly when the Employer remits the contributions for investment into the Plan. Non-elective Employer contributions are funded on a discretionary basis.

***Excess Contributions Refundable***

Amounts refundable to participants for contributions in excess amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes the excess contributions to the applicable participants in the subsequent year.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Expenses incurred in the administration of the Plan are paid by the Plan Sponsor unless the Plan Sponsor directs that such expenses shall be paid by the Plan. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund. Participant notes receivable set-up and administration fees are charged directly against a participant's account on a pro-rata basis from all of the funds in which the respective participant is invested at the time the fees are taken and are included in administrative expenses.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in two mutual funds that accounted for approximately 22% of total Plan investments as of December 31, 2024. The Plan invested in one mutual fund that accounted for approximately 11% of total Plan investments as of December 31, 2023.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

*Money Market Fund:* The carrying amount of the money market fund is the deposit amount plus accrued interest, as determined according to stated terms.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed Brokerage Account:* Valued at the closing price reported on the active market on which the individual securities are traded. This account consists of common stock and cash.

*Common Collective Trust:* The Plan invests in the Fidelity Managed Income Portfolio (MIP) Fund, an investment vehicle that invests in benefit-responsive investment contracts, fixed income securities and money market funds. It is valued at NAV of units held by the Plan. The NAV, as provided by Fidelity, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan and no redemption notice period for this investment at the Plan level.

- (a) In accordance with Subtopic 820-10, the common collective trust fund is measured at fair value using the NAV per share (or its equivalent) practical expedient and has not been categorized in the fair value hierarchy. The fair value amount presented in the table is intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Plan Benefits.

**4. Plan Termination**

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**5. Income Tax Status**

The Plan was an adoption of a volume submitter defined contribution plan sponsored by Fidelity until October 31, 2021. As of November 1, 2021, the Plan adopted a new basic plan document changing the status of the Plan to a Fidelity Pre-Approved Plan. Fidelity has obtained an advisory letter dated October 6, 2020 stating that the form of the Plan is acceptable under Section 401 of the IRC. Generally, the Plan Administrator and the Plan may rely on the advisory letter received by Fidelity as to the form of the Plan qualifying under the IRC. The Plan has been amended since receiving the advisory letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

The Plan made direct payment to Fidelity for administrative services of \$2,764 for the year ended December 31, 2024. Participant notes receivable also qualify as party-in-interest transactions.

**8. Differences from Form 5500**

**9. Subsequent Events**

Effective January 1, 2025, the Plan adopted a provision of the SECURE Act 2.0 allowing certain eligible participants to make increased catch-up elective deferrals, referred to as “super catch-up” contributions. Under this provision, the maximum catch-up deferral amount for participants between the ages of 60 and 63 increased from \$7,500 to \$11,250.

Management has evaluated subsequent events through September 12, 2025, which is the date these financial statements were available to be issued.
