### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

---

#### (1) PLAN DESCRIPTION

The following description of the Finley & Cook 401(k) Savings Incentive Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### General

Finley & Cook, P.L.L.C. (the “Company”) is the Plan’s sponsor. The Plan is a non-standardized defined contribution pre-approved safe harbor 401(k) plan. The Plan is designed to comply with Section 401(a) and the regulations thereunder of the Internal Revenue Code of 1986, as amended, (the “Code”) and is subject to the applicable provisions of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers eligible employees of the Company, except collective bargaining employees and nonresident aliens.

The Plan is administered by the partners of the Company. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, “Empower”) processes and maintains the records of the participant data and is the custodian of the Plan’s assets.

##### Eligibility

Employees who are 21 years of age and have completed 500 hours of service in a consecutive 6-month period are eligible to participate in the Plan. Alternatively, if an employee does not complete 500 hours of service within a consecutive 6-month period, the employee may become eligible to participate in the Plan after 1 year of consecutive service. Employees who become eligible to participate in the Plan may enroll and begin participation on the next semiannual enrollment date of January 1 or July 1 after becoming eligible.

##### Contributions

Participants may contribute up to 100% of their eligible compensation, as defined in the plan document, as either pretax or Roth deferrals, up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the plan year are eligible for catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Contributions are subject to certain limitations of the Code.

(1) PLAN DESCRIPTION, CONTINUED

Contributions, Continued

Participants are automatically enrolled at 3% of their eligible compensation when eligibility is reached unless they elect to defer a different amount or opt out. Effective January 1, 2023, the Plan's automatic enrollment feature was amended to provide an annual escalation of 1% up to a maximum of 5% of eligible compensation for participants. The annual escalation will be applied as of the second period that begins after the period in which the initial deferral amount was withheld from the participant's eligible compensation and will occur as of July 1 of each plan year.

The Plan provides for safe harbor matching contributions by the Company. The Company contributes 100% of the first 3% and 50% of the next 2% (maximum 4%) of a participant's eligible compensation each payroll period. Catch-up contributions are eligible for safe harbor matching contributions by the Company.

Additional amounts may be contributed by the Company under the Plan's nonelective provisions at the discretion of the Company's partners. Allocations of the Company's nonelective contributions are based on the proportion of each participant's compensation to the total of all participants' eligible compensation in their respective classification, as defined in the plan document. Participants must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the year to be eligible to receive the Company's nonelective contributions. Participants, subject to death, total and permanent disability, or termination of employment on or after their normal retirement age of 65 during the plan year are eligible to share in the nonelective allocations regardless of the conditions discussed above. There were no nonelective contributions by the Company for the years ended December 31, 2024 or 2023.

Investment Options

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with participant contributions, the Company's safe harbor matching contributions, and allocations of the Company's nonelective contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant-directed transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) **PLAN DESCRIPTION, CONTINUED**

**Vesting**

Participants are immediately vested in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's nonelective contributions is based upon years of continuous service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Participants automatically become 100% vested upon death or total and permanent disability. Participants who terminate for any other reason are entitled to the vested amount of their accounts.

**Notes Receivable from Participants**

The Plan does not permit loans to participants.

**Payment of Benefits**

Upon retirement, termination, disability, or death, a participant (or their beneficiary, as applicable) may elect to receive a lump-sum or partial withdrawal equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59 1/2. Hardship distributions may be made to participants under certain conditions of the Code, account restrictions, and other provisions of the plan document.

Upon termination, involuntary distributions are allowed for participant account balances of less than \$5,000. Involuntary distributions of at least \$1,000 made without the participant's consent are rolled into an individual retirement account.

**Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Administration of Plan Assets**

Empower invests the contributions received, as well as interest and dividend income, and makes distributions to participants.

(1) **PLAN DESCRIPTION, CONTINUED**

**Administrative Costs**

The Company absorbs a portion of the Plan's administrative costs. The remaining plan costs, including investment-related expenses, are allocated to each participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States.

**Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investments**

Investments in registered investment companies are carried at fair value, determined using year-end quoted market prices in active markets. The guaranteed investment contract is recorded at contract value. See Note 3 for a discussion of fair value measurements.

**Income Recognition**

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Payment of Benefits**

Benefits are recorded when paid. There were no benefits requested before year-end that were not paid.

**Date of Management's Review of Subsequent Events**

Management has evaluated subsequent events through September 3, 2025, the date which the financial statements were available to be issued, and determined that no subsequent events have occurred that require adjustment to or disclosure in the financial statements.

(3) FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. In estimating fair value, the Plan utilizes valuation techniques that are consistent with the market approach, the income approach, and/or the cost approach, as applicable. Such valuation techniques are consistently applied. Inputs to valuation techniques include the assumptions that market participants would use in pricing an asset or liability. Fair values may not represent actual values of assets and liabilities that could have been realized on the measurement date or that will be realized in the future. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value amounts.

*Accounting Standards Codification* Topic 820, "Fair Value Measurement," establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1 inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset and liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

The Plan uses appropriate valuation methods based on the available inputs to measure the fair values of its assets and liabilities.

Registered Investment Companies

The fair values of registered investment companies are based on year-end quoted market prices in active markets.

**(4) GUARANTEED INVESTMENT CONTRACT**

At December 31, 2023, the Plan had a fully benefit-responsive guaranteed investment contract with Empower totaling \$413,703. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The guaranteed rate was reset quarterly. The investment contract had a minimum guaranteed rate of 1.23% as of December 31, 2023. Average yield on the contract was 1.23% in 2023. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represented contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**(4) GUARANTEED INVESTMENT CONTRACT, CONTINUED**

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may have been affected by future economic and regulatory developments.

Certain events might have limited the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, or (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan. As of December 31, 2023, no events were probable of occurring that might have limited the ability of the Plan to transact at contract value with the contract issuers and that also would have limited the ability of the Plan to transact at contract value with the participants.

**(5) TAX STATUS**

The Plan is a non-standardized pre-approved defined contribution plan offered through Employee Benefits Group, LLC, the third-party administrator of the Plan. The Internal Revenue Service has determined and informed Employee Benefits Group, LLC by a letter dated June 20, 2020, that the non-standardized plan is designed in accordance with applicable sections of the Code. Although the Plan has been amended from the original non-standardized plan, the plan administrator believes that the Plan and the related trust are currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**(6) INFORMATION CERTIFIED BY PLAN CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Investment activity (net appreciation in fair value of investments, interest, and dividends) as shown in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.
- Schedule H, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule.

**(7) TRANSACTIONS WITH PARTY-IN-INTEREST**

Certain administrative functions are performed by partners and employees of the Company. No partner or employee receives compensation from the Plan for these services. Certain administrative expenses were paid by the Company on behalf of the Plan. The Company does not expect to be reimbursed from the Plan for these expenses.

Certain of the Plan's investments are managed by Empower. Therefore, these transactions qualify as party-in-interest transactions under ERISA.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. The Plan also made direct payments to services providers, which were not covered by revenue sharing.

**(8) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for plan benefits.
