**NOTE 1 DESCRIPTION OF PLAN**

The Cineverse 401(k) Plan (the Plan) is administered by Cinedigm Corp. (the Company or Plan Sponsor). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan document, both of which are available from the Company. In May 2023, the Plan Sponsor filed to change the name of the organization to Cineverse Corp. and the Plan changed its name to Cineverse 401(k) Plan.

**General**

The Plan is a voluntary, participant-directed, defined-contribution savings plan, which became effective November 1, 2002. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

All employees of the Company, excluding members of a collective bargaining unit, leased employees and nonresident aliens, are eligible to participate in the Plan for pretax and safe harbor matching contributions after three months of service and the attainment of age 21. Employees who have completed one year of service and who are age 21 or older are eligible for discretionary nonelective contributions. Participants can enter the Plan on the first day of the month following the month eligibility requirements are met for pretax and safe harbor matching contributions; semiannually for discretionary nonelective contributions.

**Contributions**

Each Plan Year, participants may make voluntary pretax contributions and Roth 401(k) contributions to the Plan up to 100% of their eligible compensation, up to the annual Internal Revenue Service (IRS) dollar limit. The Plan accepts rollover contributions from qualified plans. Participants who have attained age 50 before the end of the Plan Year, are eligible to make catch-up contributions in accordance with, and subject to, IRS limitations. Employer safe harbor matching contributions are made equal to 100% of the first 3% of eligible compensation plus 50% of the next 2% of eligible compensation. The Company made safe harbor matching contributions of \$357,676 and \$379,308, respectively, for the years ended December 31, 2024 and 2023. Each year, the Company may make a discretionary, nonelective contribution to the Plan to all eligible participants who are enrolled in the Plan on the last day of the Plan Year, which is December 31, and have 1,000 hours of service. There were no discretionary nonelective contributions related to 2024 or 2023.

**Investment Options**

Upon enrollment in the Plan, participants may direct their employee and Company contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocation of: (a) the Company's safe harbor matching and discretionary nonelective contributions; and (b) Plan earnings, gains or losses; and (c) charged with an allocation of administrative expenses. Allocations are based on a participant's compensation or account balance, as defined in the Plan document.

The Plan permits participants to self-direct the investments of their accounts in a variety of investment options. All participants have elected to self-direct their accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their voluntary employee contributions, rollover contributions, employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary nonelective contributions is based on years of continuous service. A participant is 100% vested after three years of credited service, earning 33% per year after the completion of the first year of service. Participants become fully vested upon attainment of age 65, or upon death or disability of the participant.

**Notes Receivable from Participants**

Participants may borrow up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest loan balance in the participant's account during the prior 12-month period. The minimum loan amount allowed is \$1,000. Each loan is secured by the vested balance in the participant's account. Loans bear a reasonable rate of interest as determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for notes that would be made under similar circumstances. Participants may only have one loan outstanding at any given time. Loans must be repaid in level payments on at least a quarterly basis over a five-year period unless the loan is for the purchase of a participant's principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. If the participant terminates employment, the principal and interest shall be due immediately.

**Payment of Benefits**

After retirement, death, and disability, participants are entitled to receive a lump-sum distribution, monthly installments or partial withdrawals. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as April 1 following the calendar year of attaining the age of 72 or age at retirement. If the participants are still employed by the age of 72, the mandatory distribution date generally is April 1 following the termination date of employment. Unless otherwise designated, if the participant is married, their spouse is the beneficiary or, if single, the participant's estate is the beneficiary.

**Payment of Benefits (Continued)**

Upon termination, vested benefits can be rolled over to another qualified plan or an individual retirement account (IRA) or distributed in a lump-sum payment or partial withdrawals. If the vested balance is \$5,000 or less, any amount exceeding \$1,000 will be distributed to an IRA or annuity for the participant's benefit. If the participant's vested balance is \$1,000 or less, the participant will receive a lump-sum distribution without consent.

Hardship withdrawals are subject to approval by the Plan administrator and are also subject to income tax withholding and penalties.

**In-Service Withdrawals**

Participants attaining the age of 59½ may request a withdrawal of all or part of their vested account balances.

**Retirement**

The Plan's normal retirement age is 65. There is no early retirement provision under the Plan.

**Forfeitures**

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These amounts are allocated to the Plan's forfeiture accounts. Forfeitures are allocated to offset Plan expenses, excluding participant transaction fees, employer safe harbor matching or discretionary nonelective contributions. During the years ended December 31, 2024 and 2023, \$497 and \$25, respectively, were used to offset Plan expenses. During the years ended December 31, 2024 and 2023, \$2,534 and \$14,868, respectively, were used to offset employer contributions. At December 31, 2024 and 2023, \$1,195 and \$494, respectively, was available in the forfeiture account.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation of investments is reported on the statements of changes in net assets available for benefits and consists of the realized gains (losses) and the unrealized appreciation of those investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses and Participant Transaction Fees**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, investment fees, and certain Plan administration fees not covered by the Company, are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Mutual Fund Fees**

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

**Subsequent Events**

The Company has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE PLAN TRUSTEE (UNAUDITED)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 inputs)

*Common/Collective Trust* – Valued at the net asset value (NAV) of units of a bank collective trust or a pooled separate account. NAV is a readily determinable fair value and is the basis for current transactions. (Level 2 inputs)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 PLAN TERMINATION**

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions, as of the termination date.

**NOTE 7 INCOME TAX STATUS**

The prototype Plan Sponsor has obtained an opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the prototype Plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded, as of December 31, 2024 and 2023, that there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
