Note 1 - Description of the Plan

The following description of the Kitsap Bank 401(k) Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the plan agreement for complete information regarding the Plan's provisions.

General - The Plan was formed January 1, 1985, for the benefit of the employees of Kitsap Bank (the Company). All employees, other than nonresident aliens and employees covered by a collective bargaining agreement, are eligible to participate in the Plan upon reaching 21 years of age and completing three months of service. Eligible employees may begin participating in the Plan on the first of the month following satisfaction of such eligibility requirements. To become eligible for discretionary profit-sharing contributions, participants must complete one year of service with 1,000 hours of service. Additionally, in order to receive any discretionary profit-sharing contributions, employees must complete 1,000 hours of service during the year and be employed on the last day of the year, unless terminated due to death, disability, or attainment of normal retirement age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration - Empower and its affiliated companies, Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC (Empower Trust), provide recordkeeping and certain administrative services and serve as the Plan's trustee.

Contributions - Participants may elect to defer up to 50% of their compensation as pre-tax or Roth contributions. The Plan has adopted an automatic enrollment feature under which eligible employees are enrolled with a 4% pre-tax deferral rate unless they formally waive participation or elect a different participation level. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible defined benefit or defined contribution plans (rollover).

The Company makes safe harbor matching contributions equal to 100% of each participant's contribution, up to a maximum of 4% of compensation, calculated on an annual basis.

The Company may also elect to make a discretionary profit-sharing contribution. This contribution is allocated to the participant accounts based on the ratio of the individual participant's compensation to total compensation of all participants with a tiered disparity for earnings in excess of the social security wage base. No discretionary profit-sharing contributions were made for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Vesting - Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Participants vest in their discretionary profit-sharing contributions based on years of service, with 100% vesting after three years of service.

Participant Accounts - Each participant's account is credited with (a) the participant's contributions, safe harbor matching contributions, and discretionary profit-sharing contributions allocated on their behalf, if any, and (b) Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. Participants are allowed to direct the investment of all contributions into various investment options that offer a diversity of investment risk and return. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Continued

Payment of Benefits - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive an annuity or lump-sum distribution equal to the value of the participant's vested account balance. Prior to termination of service, participants may elect to receive a distribution of the portion of their account attributable to elective deferrals and safe harbor matching contributions provided certain age and service requirements have been met, as defined within the plan agreement (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan agreement. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Forfeitures - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$8,000 and \$3,000, respectively. No forfeited amounts were used during the year ended December 31, 2024.

Notes Receivable From Participants - A participant may borrow the lesser of \$50,000 or 50% of their vested balance, with a minimum loan of \$1,000. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. The interest rate is set at 1.0% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities with disclosure on contingent assets and liabilities at the date of financial statements and reported amounts of additions to or deductions from plan assets during the reporting period. Actual results could differ from those estimates.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and realized gains and losses on investments.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments, and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Benefits Paid to Participants - Benefits paid to participants are recognized when they are paid.

Subsequent Events - The Plan's management has evaluated subsequent events through August 20, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides a framework for determining fair value measures for financial assets and liabilities. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant transactions (purchases and sales) may occur daily.

Note 4 - Fully Benefit-Responsive Investment Contract

Participants may invest in the Empower Investments Fixed Account (EIFA, or the Fund), a fixed annuity product offered through a EAICA group annuity contract. Contributions to the Fund are maintained in the EAICA general account. The Fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. The account is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The rate of credited interest for any period of time will be determined by EAICA and is guaranteed for three-month periods. The Fund has a minimum crediting interest rate of 0%. Certain events might limit the ability of the Plan to transact at contract value including early termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with EAICA and that would limit the ability of the Plan to transact at contract value with the participants.

During 2024, the Plan approved a plan to replace the Fund with another similar investment. The Fund was liquidated in 2025 at contract value with the balance transferred to the elected replacement fund.

Note 5 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by EAICA and Empower Trust, qualified institutions. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by EAICA and Empower Trust, the Plan's trustee. Transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants would become 100% vested in their employer contributions.

Note 8 - Income Tax Status

The Company adopted an Empower Retirement LLC (Empower) pre-approved plan document. Empower received an approval letter from the IRS dated November 14, 2022, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, however, the Plan’s management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
