Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 - ORGANIZATION AND DESCRIPTION OF THE PLAN

The provisions of the Parking & Transportation Management Services, Inc. (the Company) 401(k) Plan (the Plan) were effective June 1, 2018. The Plan has been amended and restated to comply with current legislation. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company and its participating affiliates, excluding union, leased, non-resident alien employees, and residents of Puerto Rico. Employees become eligible for participation after thirty days of service and the attainment of age 21. Employees are eligible to receive discretionary profit sharing contributions if they have also completed 1,000 hours of service during the Plan year and are employed on the last day of the year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Participants may elect to contribute up to 100% of their pre-tax eligible compensation or Roth after-tax eligible compensation to the Plan as defined in the Plan document, within statutory limits. These contributions are paid to the Plan after each pay period. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company provides for safe harbor matching contributions of 100% of the first 3% of compensation that a participant defers to the Plan, plus 50% of the amount the participant defers between 3% and 5% of compensation. Matching contributions are paid to the Plan after each pay period.

The Company may also make discretionary profit sharing contributions. No profit sharing contribution was made in 2024.

Participant Accounts

Individual participant accounts are maintained by the Plan's third party administrator. Each participant's account is credited or charged with the participant's contribution, the Company's contributions, allocations of investment income and losses on the individual account balances, and administrative expenses, if any. Distribution and loan transaction fees are deducted from the respective participant's account. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

NOTE 1 - ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)

Investment Options

Participants may direct employee and employer contributions among various mutual funds and a guaranteed investment contract. The guaranteed interest accounts are maintained in the issuer's general account and are included in the Plan's financial statements at contract value, which approximated fair value, and represents contributions made under the contracts, plus earnings, less Plan withdrawals, and administrative fees. The guaranteed crediting interest rates are determined when each deposit is directed to the account and all rates credited during the deposit year are averaged into a single composite rate. These investments are not fully benefit-responsive.

Vesting

Participants are immediately vested in their own contributions and Company contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. Terms of the notes receivable may not exceed five years, except for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate on the date of the note receivable issuance plus 1.5%. Interest rates range from 6.75% to 10.25% on the outstanding notes receivable from participants at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefits may be distributed upon retirement, death, disability, or other termination of employment. Benefits equal to the participant's vested account balance are paid in a lump sum, installments, and annuity options depending on certain factors as described in the Plan document and at the participant's election. Under certain hardship circumstances, participants may request a distribution of certain vested account balances prior to retirement.

Subsequent Events

The Plan has evaluated subsequent events through August 27, 2025, the date the financial statements were available to be issued.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are significant accounting policies used by the Plan:

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus accrued, but unpaid interest, if any. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for individual transactions such as distributions and loans are deducted from the respective participant's account. Investment related expenses, and revenue sharing fees or credits, are included in net appreciation or depreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

NOTE 3 - FAIR VALUE MEASUREMENTS (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed interest account – Traditional guaranteed contract valued at contract value (see Note 1), which approximates fair value. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only based on unobservable inputs including comparable interest rates for similar investments.

NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments that is disclosed in the accompanying financial statements and ERISA-required supplemental schedule on page 13, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance) for the period January 1, 2023 through June 28, 2024, and Transamerica Trust Company (Transamerica) for the period June 29, 2024 through December 31, 2024, the custodians of the Plan.

NOTE 5 - CHANGE IN SERVICE PROVIDERS

Effective June 29, 2024, the Plan Administrator elected to change the Plan's custodian from Reliance Trust Company (Reliance) to Transamerica Trust Company (Transamerica). There were no changes to the Plan's assets as a result of the change in custodian.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan investments are units of participation in guaranteed interest accounts managed by Transamerica and its affiliates. Fees are paid by the Plan to these parties for administrative services. Additionally, these parties collect revenue sharing from the Plan's investments to pay for administrative services.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 8 - TAX STATUS

The Plan operates under provisions of a Pre-Approved Plan, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the Pre-Approved Plan, as then designed, was acceptable under the applicable sections of the Internal Revenue Code (IRC) for use by the employers for the benefit of their employees. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

GAAP requires the Plan Administrator to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan allows participants to invest in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
