Opinion

Note 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Significant accounting policies followed by Association Health & Welfare VEBA Master Trust d/b/a Indiana Employers Trust (the Plan) are listed below:

Basis of Accounting:

Assets and liabilities and income and expense are recognized on the accrual basis of accounting.

Basis of Presentation

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Premium Receivables and Allowance for Doubtful Accounts

The Plan follows Financial Accounting Standards Board's (FASB) Accounting Standards Update (ASU) 2016-13, *Measurement of Credit Losses on Financial Instruments*. The standard requires recognition of an allowance that reflects a current estimate of credit losses expected to be incurred over the life of the asset. Collections and payments from the contributing employers are continuously monitored and credit losses are estimated relating to the Plan's receivables based on a number of factors, including the age of receivable balances, history of losses, expectations of future credit losses, and the contributing employers' ability to pay their obligations.

Premiums receivable consist of amounts billed to participating employers and are carried at original invoice amount less an estimate made for doubtful receivables based on a review of all outstanding amounts on a regular basis. Premium receivables were \$49,352 and \$8,104 for the years ended November 30, 2024 and November 30, 2023, respectively.

Cash and Cash Equivalents

The Plan maintains cash balances with financial institutions which may exceed the Federal Deposit Insurance Corporation limit of \$250,000.

Subsequent Events

Management has evaluated subsequent events through September 5, 2025, the date that the financial statements were available to be issued.

Note 2: DESCRIPTION OF PLAN

The Plan began operating January 1, 2014 and is a group insurance arrangement whereby multiple associations participate in the Plan that provides fully insured health, dental, vision, and prescription drug benefits, as well as life and AD&D insurance benefits through insurance companies to employees and their dependents of employers who participate. Coverage is also available to certain employees who have separated from service under the COBRA provisions of federal law. Complete descriptions are set forth in the Summary of Benefits that can be obtained from the Plan administrator. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Note 3: CONTRIBUTIONS AND PREMIUM PAYMENT

Contributions from employers and employees are recognized as revenue when insurance premiums become due. Total premiums of \$9,998,956 and \$9,958,458 were recognized during the years ended November 30, 2024 and November 30, 2023, respectively, which also include contributions for accidental death and dismemberment, life, vision, medical, dental, and COBRA insurance premiums.

Note 4: TAX STATUS

The Plan obtained its latest determination letter on November 6, 2014, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code pursuant to Section 501(c)(9). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

In accordance with Section 419A of the Internal Revenue Code, the Plan is subject to Plan tax rates on net income earned from unrelated business activities. As the Plan is a fully insured Voluntary Employee Beneficiary Association, investment income less related investment fees are subject to tax, excluding investment income (if any exists) from tax exempt sources. For the years ended November 30, 2024 and November 30, 2023, the Plan did not incur any Federal or State income tax expense.

Management evaluates all significant income tax positions that it takes. For the years ended November 30, 2024 and November 30, 2023, management does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits in interest expense. No interest or penalties have been accrued or charged to expense for uncertain tax positions for the years ended November 30, 2024 and November 30, 2023.

The tax returns of the Plan are subject to examination by the taxing authority, generally for a period of three years from the date the tax returns were filed.

Note 5: PLAN TERMINATION

The Plan's Trustees intend to operate the Plan as designed indefinitely and have not expressed any intent to terminate the Plan. But they have the right to do so at any time. In the event of termination, the Trustees of the Plan will use the assets to pay any and all expenses properly chargeable against the Plan. Any assets remaining shall be applied to provide, through the purchase of insurance, life, medical, accident or other benefits within the meaning of, and in accordance with Sections 501(c)(9), of the Internal Revenue Code.

Note 6: PLAN FUNDING POLICY

The Plan’s funding policy is to select contribution rates which will allow for the timely payment of benefits and provide the reserves necessary to meet extraordinary expenditures.

Note 7: PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the Plan during the years ended November 30, 2024 and November 30, 2023, for services rendered by parties-in-interest, were based on contractual rates for their services.

Note 8: CONCENTRATION OF CREDIT RISK AND ECONOMIC DEPENDENCY

In accordance with the Financial Accounting Standards Board’s Accounting Standards Codification (ASC) 825-10-50-20, credit risk is the possibility that a loss may occur from the failure of another party to perform according to the terms of a contract. Bank deposits are federally insured up to \$250,000 for each account owned at a federally insured bank.
