Opinion

We have audited the accompanying financial statements of Cement Masons – Employers Health, Welfare and Vacation Trust (the Plan and Trust), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024, and 2023, the related statements of changes in net assets available for benefits for the years then ended, the related statement of changes in the benefit obligations for the year ended December 31, 2024 and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, information regarding the Cement Masons – Employers Health, Welfare and Vacation Trust's net assets available for benefits as of December 31, 2024, and 2023, and the changes therein for the years then ended, and changes in the plan benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America, as established by the AICPA's Auditing Standards Board. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Cement Masons–Employers Health, Welfare and Vacation Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America, as established by AICPA's Auditing Standards Board.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Cement Masons – Employers Health, Welfare and Vacation Trust (the Plan) provides only general information and further reference should be made to the Plan agreement for more complete information regarding the provisions of this Plan. A copy of that document can be obtained from the Plan Administrator through Masonry Industry Trust Administration, 9848 E. Burnside Street, Portland, Oregon 97216.

General: The Plan is a multi-employer plan that is collectively bargained which provides health, drug, dental, vision, life, disability, and vacation benefits covering substantially all active and retired eligible participants. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan provides benefits to eligible covered employees of participating employers under collective bargaining agreements with various local unions of Oregon and Washington, as well as retirees that make required payments under the terms of the Plan. Idaho and Montana participate in the vacation plan only. Specific information regarding effective rates can be obtained from the Plan Administrator by referring to the applicable bargaining agreement.

Administration of Plan: The administration of the Trust is the responsibility of the Plan's Board of Trustees comprised of Union Trustees and Employer Trustees. The Plan's investments are managed by Quest Investment Management. US Bank serves as custodian of the Plan's investments.

Benefits: The Plan provides medical, dental, vision, chiropractic, life, accidental death and dismemberment, and disability benefits for eligible participants and to their beneficiaries and covered dependents. Retired members can participate provided they make the appropriate monthly payments within the Plan's guidelines. The Trust also administers the vacation plan.

Eligibility: Participants are eligible for coverage if they are working under a collective bargaining agreement within the jurisdictions of the OPCMIA Local 555 or Local 82 or any other Local Union approved by the board of trustees and if sufficient contributions have been made on their behalf by a participating employer or employees for as long as they and/or their dependents are enrolled for coverage. Participants are also eligible for coverage if they are retired and drawing pension from either the Cement Masons-Employers Pension Trust or the Plasterers Local No. 82 Pension Plan.

Participants are eligible for coverage for at least 10 years (120 months) in the Cement Masons-Employers Active Health and Welfare Trust and at least 36 months of coverage in the 60 months immediately preceding retirement from the pension plan. Retired participants must remain a continuous member of Operative Plasterers and Cement Masons International Union Locals No. 555 or 82 as long as they and/or dependents are enrolled for coverage and enroll in Medicare parts A and B when eligible, at which time coverage under this plan terminates.

Plan Funding: The Plan is funded primarily through contributions from participating employers based on covered hours worked by their employees in accordance with the applicable bargaining agreements.

Plan Termination: If not precluded by the terms of a collective bargaining agreement, the Trust Fund may be discontinued or terminated in whole or in part by the mutual consent of the trustors.

In the event of termination, the Trustees shall:

- (1) Make provision out of the Trust Fund for the payment of expenses incurred up to the date of termination of the Trust Fund and expenses incidental to such termination,
- (2) Arrange for final audit and report their transactions and accounts, for the purposes of termination of their trusteeship,
- (3) Apply the Trust Fund to pay any and all obligations of the Trust and distribute and apply any remaining surplus in such manner as will, in their opinion, best effectuate the purpose of the Trust and the requirements of law; and
- (4) Give any notice and prepare and file any reports, which may be required by law.

Employer Contributions: Employer contributions reported in the financial statements include amounts relating to hours worked by the participants from November 2023, through October 2024, and November 2022, through October 2023, respectively. These amounts are recognized in the periods to which the participant eligibility expenses, and vacation amounts relate. According to the actuary, the estimated costs of providing postretirement benefits that are expected to be funded by retiree contributions are as follows:

Plan Amendments: The Plan became a self-funded Plan effective January 1, 2018, in accord with action taken by the Trustees during 2017, which is expected to result in significant savings to the Plan. Details regarding this change and the benefit structure are available from the Plan Administrator. As of January 1, 2019, maximum out-of-pocket medical expenses for the Trust Plan (in-network) will increase from 2018 Plan year and specific rules regarding opt-out/opt-back will be changed.

Effective starting January 1, 2020, the Trust Self-Insured Plan is offering a Telemedicine Benefit with WellVia, which has a national network of board certified, state licensed doctors offering medical and mental health consultations by computer or mobile device. Doctors can diagnose acute non-emergency medical conditions and prescribe medications when appropriate. Access to therapy is also available. The benefit is being offered with no cost for accessing providers through this benefit and \$0 copay. Kaiser members are supposed to contact Kaiser to see if telemedicine benefits are available with Kaiser. The Board has elected to offer telemedicine benefits as a permanent benefit to members, with phone/virtual visits being offered the same as in-person regular or urgent care visits, subject to the Plan's eligibility rules and in-network or out-of-network deductibles and cost sharing.

Effective starting June 1, 2021, the Trust Self-Insured Plan is offering the following amended benefits:

- Removal of requirement of prior authorization for chiropractic and acupuncture services.
- Requirement of prior authorization for many outpatient or ambulatory services, including rehabilitation and imaging services. Any covered benefit will be based on the cost of most appropriate setting for the provider.
- Alternative care must be within the scope of professional provider's license for it to be covered. There is an aggregate annual maximum for alternative care services. When there are different copayment levels for alternative care and associated services, only the copayment with the highest cost sharing will apply per visit by the same provider in addition to any applicable coinsurance.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are stated at fair value based on quoted market prices, when available. The amounts shown in Note 7 for securities that have no quoted market price represent estimated fair value. Many factors are considered in arriving at that fair market value. See Note 6 for further information regarding fair value. In general, however, common stocks, corporate bonds, US Government agency securities and mutual funds are valued based on the information provided by US Bank, the custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on ex-dividend date. Realized gains and losses on the sales of investment securities are recorded as the difference between proceeds received and cost. Cost is determined on the historical cost basis.

Postretirement Benefit Obligation: Actuarial computations under Accounting Standards Codification, ASC Topic 965 are for purposes of fulfilling trust financial accounting requirements with regard to postretirement benefit obligations. The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to participant service rendered through December 31, 2024, and 2023, respectively. Postretirement benefits include future benefits to be paid to or for (1) currently retired or disabled participants and their beneficiaries and dependents and (2) active participants and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims – cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for deaths, disability, withdrawal or retirement) between the valuation date and the expected date of payment. Further details regarding the postretirement benefit obligation may be found in the actuary’s reports for the years ended December 31, 2024, and 2023. Please note that the results contained in this report do not reflect the potential changes in future health care costs of recent health care legislation, as the effects of such legislation will depend on a number of factors, such as future regulations, which are not yet known.

The postretirement benefit obligations as of December 31, 2024, and 2023, was based on the census data, plan provisions, actuarial assumptions and methods as specified in the December 31, 2024, full valuation.

For the years ended December 31, 2024, and 2023, the actuary applied the aggregated trend of 4% per year to the expected dental and vision costs. No trend was applied to the life benefit or to the stipend for Medicare eligible retirees.

The following were other significant assumptions used in the valuations as of December 31, 2024, and 2023.

Weighted-average discount rate 5.50% (4.80% as of December 31, 2023)

Average retirement age:

For participants who meet the 30-year service requirement or 45,000 hours and age 55 requirement, the rate of retirement is 50% each year until age 62. Otherwise, according to the following table:

Mortality rate Non-Disabled Mortality: The RP-2014 Mortality Tables with Blue Collar adjustment, set forward two years, with generational projection at 50% of the ultimate rates specified in the M-2014 projection scale.

Disabled Mortality: The RP-2014 Disabled Mortality Tables, without projection.

The actuary did not reflect any potential impact of the Medicare Retiree Drug Subsidies under the Medicare Prescription Drug, Improvement and Modernization Act of 2003.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Accumulated Eligibility: It is not uncommon for participants to periodically be without work. Therefore, the Plan has a provision whereby participants can earn coverage for periods of unemployment based on eligibility earned in excess of the amount needed to provide coverage, limited to five months of eligibility. Accumulated eligibility as of December 31, 2024, and 2023 was based on the amount of future coverage accumulation for participants. Each active participant's reserve is increased by the amount of the monthly contributions received for that active participant by the Trust and can be decreased monthly by an amount, based on the type of coverage and insurer, to provide coverage. For active participants, a month of eligibility was estimated to be valued at \$1,390 and \$1,609 as of December 31, 2024, and 2023. The maximum accumulated eligibility is five months. As of December 31, 2024, and 2023, the accumulated eligibility was calculated by valuing each month of accumulated eligibility at an estimated average cost for each month. If a participating employee terminates, the Trust generally provides the participant with health coverage for such a period as the participant has accumulated coverage.

Benefits Currently Payable: Benefit obligations currently payable include the Plan's liability for vacation funds receivable as of December 31, 2024, and 2023 that are expected to be transferred to participant's accounts subsequent to their receipt and premiums payable.

Other Benefit Obligations: Benefit obligations currently payable include the Plan's liability for claims incurred as of December 31, 2024, but not reported, and the Plan's liability for premiums payable and estimated claims reported but not yet paid as of December 31, 2024. The Plan's liability for claims incurred but not reported is estimated by a consultant.

Contributions Receivable: Contributions receivable from employers is stated at the amounts the Trust expects to collect from hours worked during the last month of the calendar year. These monies are earmarked for participant eligibility expenses for February 2025 and 2024 as of December 31, 2024, and 2023, respectively. In accordance with guidelines of the American Institute of Certified Public Accountants, the financial statements set forth the employer contributions due that are estimated be collectible. The methodology used by and policy under which the Plan determines whether a contribution receivable is considered collectible is based on review of contributions receivable by the trustees and its legal counsel. The estimated employer contributions receivable presented in these financial statements as of December 31, 2024, and 2023 are net of estimated uncollectible contributions of \$59,011 and \$58,678, respectively, which is estimated based on information provided by the administration office. Contributions are considered delinquent on the 20th of the month following the month in which covered hours are worked. The Plan's policy for charging off uncollectible receivables is based on action by the Board of Trustees.

Concentration of Source of Contributions and Labor: The Trust receives approximately 86% of its additions to net assets from employer contributions. These contributions are based on hours worked by participants who are generally union cement finishers. The contributions paid on hours worked by these participants and, therefore, the relative financial stability of the Trust is directly affected by the quantity of work resulting from construction contracts and signatory employers that have work associated with covered employment.

Deferred Revenue: Income from employer contributions that are derived from participant hours worked and self-payments received are recognized as revenue in the periods to which the participant eligibility expenses and vacation amounts relate.

Subsequent Events: The Trust has evaluated subsequent events through September 11, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – BENEFIT OBLIGATIONS

The Trust's deficiency of net assets over benefit obligations at December 31, 2024, and 2023, relates primarily to the postretirement benefit obligation for which there is no provision for funding by the current bargaining agreement. The calculation of the obligation does not imply that there is any legal liability to provide the benefits valued nor do the participants have any vested rights in the postretirement benefit obligations. The board of trustees has the right to amend or terminate postretirement benefits. In addition, the postretirement benefits have not been funded by the Trust.

The health care cost trend rate assumptions (Note 2) have a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point each year, it would increase/ (decrease) the obligation as of December 31, 2024, and 2023, by \$666,909 and \$659,752, respectively.

NOTE 5 – TAX STATUS

The Plan obtained its latest determination letter from Internal Revenue Service dated January 6, 1960, stating that the Plan, as then designed, was in compliance with the applicable requirements under Section 501(c)(9) of the Internal Revenue Code (IRC) and was therefore, exempt from federal income taxes. Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Plan administrator and the Plan's legal counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and, therefore, they believe that the Plan and the Trust is qualified and is tax exempt.

NOTE 5 – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that are more likely than not would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan is subject to routine audits by taxing agencies; however, there are currently no audits for any tax periods in progress. Typically plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan. The Plan's activities do not generate any unrelated business income (UBI) or any associated taxes (UBIT).

NOTE 6 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs would be used only when Level 1 or Level 2 inputs were not available. Following ASU 2015-12, investments are measured at fair value by general type and do not need to be disaggregated by investment nature, characteristics and risks. The various levels of input used to value the investments presented in these financial statements are as follows:

Level 1 – The fair values of U.S. Treasury issues, common stocks and mutual funds are based on quoted market prices.

Level 2 – The fair values of corporate and international bonds are based on information provided by US Bank as of December 31, 2024, and 2023.

Level 3 – In some cases, the estimated values of certain assets or liabilities may be based on the best information available that may include significant unobservable inputs. This is the case when there is little to no market activity or other observable inputs for the asset or liability at the measurement date. In these circumstances the reporting entity's own assumptions and data are often used to develop an estimate of fair value.

As of December 31, 2024, and 2023, the Plan held no investments where the estimated fair value was based on Level 3 inputs.

These financial statements do not reflect these amounts, as there is no practical way of reasonably estimating the amounts that will be collected.

NOTE 10 – CONCENTRATIONS OF CREDIT RISK ARISING FROM CASH DEPOSITS IN
EXCESS OF INSURED LIMITS

The Trust maintained cash balances at KeyBank in Portland, Oregon. At December 31, 2024, and 2023, cash balances in excess of insurance limits total \$308,627 and \$160,480, respectively. The insurance for these types of accounts will be up to \$250,000 per depositor per institution.

As of December 31, 2024, and 2023, cash in the amount of \$204,228 and \$303,538, respectively were held in a money market fund at US Bank, which were not covered by FDIC insurance. In the event that the financial institutions were to fail, the Trust could incur a loss to the extent deposits exceed available coverage.

NOTE 11 – STOP-LOSS INSURANCE

Subsequent to January 1, 2018, Trust benefits were funded with a self-insurance program with a form of stop-loss insurance coverage to cover potential catastrophic claims. For medical benefits, claims paid in excess per person per contract year are covered by the stop-loss policy in the amounts of \$150,000 for the years ended December 31, 2024, and 2023. Effective January 1, 2025, this threshold increased to \$160,000.

NOTE 12 – RELATED PARTY TRANSACTION

Employer contributions which are collected by Masonry Industry Trust Administration, are being deposited in the Cement Masons – Employers Health, Welfare and Vacation Trust administrative account using KeyCapture. These Funds are then immediately electronically transferred to various industry benefit plans and ancillary funds. As of December 31, 2024, Cement Masons – Employers Health, Welfare and Vacation Trust does not hold any funds that belong to any other benefit plan trust or ancillary funds.

As of December 31, 2024, funds in the amount \$7,642,700 were transferred from Cement Masons – Employers Health, Welfare and Vacation Trust to the Cement Masons – Employers Pension Trust.

As of December 31, 2024, funds in the amount \$579,256 were transferred from Cement Masons – Employers Health, Welfare and Vacation Trust to the Oregon-Washington Cement Masons-Employers Apprenticeship and Training Trust.

As of December 31, 2024, funds in the amount \$1,135,052 were transferred from Cement Masons – Employers Health, Welfare and Vacation Trust to the Operative Plasterers Local No. 82 Pension Fund.

NOTE 13 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities (Note 6 and 7). Investment securities are exposed to various economic risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Specifically, the Plan holds investments in fixed income securities (including, but not limited to, US Treasury and corporate issues) which are subject to market value changes resulting from fluctuations in market interest rates. Generally, as market interest rates increase, the market value of a specific security decreases and vice versa. Therefore, investments in fixed income securities held within such investments vehicles as mutual funds and other investment holdings may be exposed to risks associated with interest rate fluctuations depending on the extent and character of their fixed income holdings.

The actuarial present value of postretirement benefit obligations are reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial status of the Plan.


