INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Behavior Interventions, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

1. Description of plan

The following description of the Behavior Interventions, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Behavior Interventions, Inc. (Sponsor), who are age 21 or older. Employees are required to complete one period of service (completion of twelve consecutive months from their date of hire) before entering the Plan and the plan entry date is the first day of the month coinciding with or next following the date the eligibility requirements are met.

Employees meeting the Plan's eligibility requirements are permitted to make deferrals into the Plan. The Sponsor may provide a safe harbor matching contribution for eligible participants. In addition, the Sponsor may make discretionary matching contributions as well as discretionary profit sharing contributions. A participant is eligible to share in discretionary profit sharing contributions if employed on the last day of the plan year, unless separated by death, disability or retirement during the plan year.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trustees are responsible for oversight of the Plan. The Plan Administrator is the Sponsor and is responsible for the day-to-day operations of the Plan. The Plan's trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

The Plan is in operational compliance with the requirements of current laws and regulations. Formal amendments will be adopted by the prescribed deadlines.

Contributions

Each year, participants may contribute up to the maximum limit established under the Internal Revenue Code (IRC). Participants may choose between two types of deferral options: pre-tax deferrals and Roth deferrals. Participants that are fifty years of age or older may make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans and individual retirement accounts as rollover contributions.

For the year ended December 31, 2024, the Sponsor elected to make a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation, which totaled \$533,131. The Sponsor may make discretionary matching contributions and profit sharing contributions; however, no discretionary matching or profit sharing contributions were made or declared for the year ended December 31, 2024.

The Sponsor remits employee deferral contributions, discretionary employer matching contributions and employer safe harbor matching contributions to the Plan on a payroll by payroll basis. The Sponsor remits discretionary profit sharing contributions after the close of the plan year.

Participants direct the investment of contributions into various investment options offered by the Plan and may change their investment options at any time.

Each participant's account is credited with the participant's elective and rollover contributions, as well as allocations of the Sponsor's safe harbor matching contributions, discretionary matching and profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary and rollover contributions, as well as in safe harbor contributions made by the employer. Participants become fully vested in other employer contributions, and earnings thereon, using a graded vesting schedule, after completing six periods of service. Additionally, participants become 100% vested if separated from service due to death or disability prior to termination of employment or if employed on or after attaining normal retirement age.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of the participant's vested account balance or \$50,000. Loans are repayable through payroll deductions over a period decided by the participant, generally not to exceed sixty months. Loans are collateralized by the balance in the participant's account. Interest is charged at the prime rate plus 1.5%. A participant may have no more than one loan outstanding at a given time and refinancing of outstanding loans is not permitted.

Payment of benefits

Benefits are generally paid in the form of a lump sum.

Participants may withdraw all or a portion of the vested portion of their accounts if they:

- terminate employment before attaining normal retirement age
- become disabled
- retire
- die
- attain normal retirement age but continue to work, or
- qualify for in-service distributions upon attaining age 59 ½

Payment of benefits (Continued)

In addition, participants may withdraw from all of their fully-vested accounts, and earnings thereon, if they incur a financial hardship. Participants may receive a distribution from their rollover account at any time.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,747 and \$-0-, respectively. Forfeitures may be used to reduce any employer contribution.

2. Summary of significant accounting policies

Basis of accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Contributions

Contributions from Plan participants and the matching contributions from the Sponsor are recorded in the year in which the employee contributions are withheld from compensation. The Sponsor discretionary profit sharing contribution is recorded when the related participant compensation is paid.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies using information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses, which represent the internal expenses of each respective fund.

Notes receivable from participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the loan to be a distribution, the participant loan is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Income Taxes

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 740, *Income Taxes*, requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if they have taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's policy is to recognize interest and penalties related to unrecognized tax benefits in income tax expense.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from the financial statements. Administrative expenses include investment advisory fees, participant maintenance fees, and fees related to the administration of participant notes receivable and benefit payments charged directly to the affected participant's account. Investment related expenses are included in net appreciation in fair value of investments.

3. Investments and fair value of financial instruments

FASB ASC Topic 820, *Fair Value Measurement*, provides a framework for measuring, reporting and disclosing fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Stable value guaranteed income fund – The stable value guaranteed income fund is valued at cost which approximates fair value and is based on the beginning balance, plus any deposits and credited interest, less any withdrawals, charges or expenses.

Pooled separate accounts – Valued based on the NAV of units in each account held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The underlying investments of the pooled separate accounts, which generally consist of mutual funds, each follow a separate investment strategy as described below:

Target retirement funds – The funds within this class are designed to simplify the asset allocation process for participants. As a fund's target retirement year approaches, the allocation of underlying assets shifts to a more conservative mix of asset classes.

Income Funds - The funds within this class seek to generate current income while maintaining limited price volatility by investing in inflation protected securities and investment grade bonds.

Growth and income funds - The funds within this class seek to generate current income and future capital growth primarily through investments in stocks and bonds with the objective of providing current income while maintaining limited price volatility.

Growth funds - The funds within this class seek growth of capital by targeting U.S companies that are projected to grow faster than other similarly capitalized companies, thereby commanding higher prices.

Index funds - The funds in this class seek to achieve the return of selected benchmark indexes by investing all, or substantially all, of their assets in the stocks that make up that index.

International value funds - The funds within this class seek long-term capital appreciation by generally investing at least 80% of net assets in a portfolio of equity and equity-related securities issued by non-U.S. companies of any capitalization size.

International growth funds - The funds within this class seek capital appreciation by investing primarily in stocks with above average growth potential for companies of any capitalization size located outside the U.S. and are expected to diversify their assets in countries across developed and emerging markets.

Specialty funds - These funds seek capital appreciation by investing in stocks in certain specialized industries.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investment information certified by a qualified institution

The Plan administrator, having determined that it is permissible in the circumstances, elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, certain information summarized below related to the accompanying financial statements and ERISA-required supplemental information was obtained by plan management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A) (John Hancock), a qualified institution and custodian of the Plan, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- a. The investments, at fair value, at December 31, 2024 and 2023.
- b. Net appreciation in fair value of investments for the year ended December 31, 2024.
- c. Schedule H, Line 4i-Schedule of Assets (Held at End of Year), except for participant loans.

5. Related party and party-in-interest transactions

Certain plan investments are units of pooled separate accounts and a stable value guaranteed income fund managed by John Hancock. John Hancock is the custodian as defined by the Plan.

The Plan also issues loans to its participants which are secured by the participants' account balances.

These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules under ERISA.

Certain administrative functions of the Plan are performed by employees of the Sponsor. No such employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be entitled to the full amount in their accounts.

7. Tax Status

The Plan adopted a Non-Standardized Defined Contribution Pre-Approved Plan developed by Delaware Valley Retirement, Inc (DVR). The IRS has determined and informed DVR by its IRS Opinion Letter dated June 30, 2020 that the preapproved defined contribution plan document was designed in accordance with the applicable IRC provisions as of that date. The Plan has been amended since receiving the opinion letter. However, management of the Plan believes that the Plan is currently designed and being operated in accordance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for the benefits.

9. Subsequent events

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022 and includes mandatory and optional provisions with varying effective dates in 2025 and later. Plan management is evaluating these provisions and will update the Plan's governance and operations accordingly.

Effective February 1, 2025, the Plan adopted a Non-Standardized Defined Contribution Pre-Approved Plan developed by CCH Incorporated, DBA fwilliam.com (CCH). The IRS has determined and informed CCH by its IRS Opinion Letter dated June 30, 2020 that the preapproved defined contribution plan document was designed in accordance with the applicable IRC provisions as of that date. The most significant change to the Plan resulting from this adoption and restatement was the modification of the Plan's eligibility requirements to cover substantially all employees of the Sponsor who are age 20 or older.

In connection with the preparation of the financial statements, the Plan has evaluated subsequent events from December 31, 2024 through September 5, 2025, which is the date the financial statements were available for issuance and concluded that no additional disclosures are required.
