#### NOTE A - PLAN DESCRIPTION

Nassco, Inc. Profit Sharing and 401(k) Plan (the Plan) is a defined contribution plan sponsored by Nassco, Inc. (the Company). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan that covers substantially all employees of the Company who have reached 21 years of age and have completed three months of consecutive employment in which a minimum of one hour of service is performed. If an employee does not complete the minimum one hour of service during the specified period, the employee is subject to a one year of service requirement. The plan also includes an initial automatic deferral for any eligible employee who has not opted out of auto-enrollment. Additionally, the Plan adopted a provision to automatically increase automatic deferrals 1%, up to a maximum of 10%, each May 1, unless the participant opts-out of the auto-escalation feature. This provision applies to all eligible participants deferring less than 10%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

OneAmerica Retirement Services (OneAmerica) serves as the record keeper to the plan. Matrix Trust Company serves as the trustee and custodian.

##### **Contributions**

The Plan provides for voluntary pre-tax employee contributions of 1% to 50% of compensation, up to the maximum amount allowed by law, or for voluntary after-tax employee contributions of 1% to 50% of compensation, up to the maximum amount allowed by law. The Company may, but is not required to, make discretionary matching contributions to the Plan. Discretionary matching contributions are determined as a percentage of salary deferrals made during each payroll period or as a uniform dollar amount rather than on a Plan year basis. In 2024 and 2023, the Company matched 50% of the participant's contribution up to 4% of eligible compensation. Participants may also contribute amounts representing distributions from another qualified plan (rollovers).

In addition, the Company's Board of Directors may authorize discretionary profit-sharing contributions to employees who have completed a minimum of 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. Employees are eligible to share in the allocation of profit-sharing contributions even if they do not satisfy the last day and annual service allocation requirement if they died or became disabled during the Plan year. Discretionary profit-sharing contributions, net of forfeitures used, authorized for 2024 and 2023 were \$377,420 and \$376,183, respectively.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings and charged with withdrawals and an allocation of plan losses and expenses. Allocations are based on plan earnings and participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant directed.

##### **Investment Options**

Participants may direct employee and employer contributions in any of the several investment options offered by the Plan. By designating these investment alternatives for participants, allowing frequent fund transfers, and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant Directed Account Arrangement.

***Plan Expenses***

The Plan pays certain Plan administrative costs which are expensed when incurred. Other expenses are paid by the Company.

***Vesting***

Participants are immediately fully vested in their contributions plus actual earnings thereon. Participants become fully vested in their account balances upon retirement, death, or disability, as defined by the Plan.

Company contributions are vested on a six-year schedule as follows:

***Payment of Benefits***

Upon termination of service, employer contributions will be available for distribution if the total vested participant account balance is less than \$5,000. If the total vested employer contribution account balance is \$5,000 or more, it will not be available for distribution until the later of (1) termination of employment, or (2) the earliest of death, disability or attainment of Normal Retirement Age (59). Salary deferrals are available for distribution upon termination of service regardless of the participant account balance.

The Plan offers several methods of distribution for account balances available for distribution depending on the account balance. For account balances \$5,000 or less, participant consent is not required, and the entire vested benefit is distributed in a lump sum as soon as administratively feasible following their termination of service. Participants with vested account balances available for distribution exceeding \$5,000 can choose to receive their distribution as a lump-sum distribution, installment distribution, or as partial withdrawals. In service distributions are allowed under certain circumstances as described in the Plan agreement. Required minimum distributions begin upon the attainment of age 72. The SECURE 2.0 Act of 2022 increased the required minimum distribution age to 73 starting on January 1, 2023.

***Forfeitures***

Forfeitures are used to reduce employer discretionary profit sharing and matching contributions. Forfeitures used in 2024 and 2023 were \$22,146 and \$74,491, respectively. There were outstanding forfeitures as of December 31, 2024 and 2023 of \$45,690 and \$22,135, respectively.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at their fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Realized gains and unrealized appreciation are recorded in the accompanying financial statements as net appreciation in fair value of investments. Realized gains on investment transactions are recorded as the difference between proceeds received and the carrying value of the investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Payment of Benefits***

Benefits paid to participants are recorded when paid.

**NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance allowed by

29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustee, Matrix Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- (a) Investments as disclosed in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- (b) Total investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- (c) Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE D - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

There is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value and their classification in the valuation hierarchy as of December 31, 2024 and 2023:

*Mutual funds* - Valued at the net asset value (NAV) of shares held by the Plan at year-end, which is obtained on an active market.

*Collective trust funds* - At December 31, 2024 and 2023, the Plan's investment in common collective trust funds was comprised of an investment in the MetLife Stable Value Fund - Series 25053. The objective of this fund is to provide safety and preservation of principal and accumulated interest for participant-initiated transactions. The interest credited to balances in this fund will reflect both current market conditions and performance of the underlying investments in this fund. This fund invests entirely in the MetLife Group Annuity Contract 25053, which consists of separately managed investment portfolios directed by Reliance Trust Company. This fund is a bank collective trust fund for which Reliance Trust Company serves as the trustee and investment manager. This fund is not FDIC-insured or registered with the Securities and Exchange Commission. There are no unfunded commitments and no withdrawal restrictions.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. **NOTE E - TAX STATUS**

On September 24, 2015, the Internal Revenue Service stated that the volume submitter profit-sharing plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the termination of the Plan, all amounts credited to participant accounts shall become fully vested, regardless of the Plan's current vesting schedule.

**NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

While serving as trustee as defined by the Plan, certain transactions with Matrix qualify as party-in-interest transactions; however, they are not considered to be prohibited transactions.

**NOTE H - SUBSEQUENT EVENTS**

The Plan evaluated its December 31, 2024 financial statements for subsequent events through September 12, 2025, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events, which would require recognition or disclosure in the financial statements.
