Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

1. Description of the Plan

The following description of the RK Properties 401(k) P/S Plan (the “Plan”) provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on December 1, 1999, as a defined contribution plan. The Plan covers all employees of Rance King Properties, Inc. (the “Company”) and subsidiaries who have completed at least six months of service and are twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 1, 2022, the Plan was amended to apply automatic enrollment to employees who become eligible on/after May 1, 2023 at a default pre-tax elective deferral rate of 5%.

Participant Contributions

Participants may contribute up to ninety percent of their pre-tax annual compensation and may elect to designate all or any portion of their elective deferral contributions as Roth elective deferral contributions, subject to the annual federal tax limitation established by the Internal Revenue Service (IRS), as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Plan allows participants to make rollover contributions from a qualified plan. Such contributions are 100% and non-forfeitable.

Forfeitures

Forfeitures are the non-vested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to pay Plan administrative expenses, with any remaining amount used to reduce future Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$43,741 and \$207,091, respectively. During the year ended December 31, 2024, \$201,142 of the forfeiture balance was applied to the participant accounts as employer contributions.

Participant Accounts

All investments are directed by plan participants. Upon enrollment in the Plan, a participant directs contributions in any of the available investment options. If a participant has not elected investment options, contributions will be directed to the default investments as determined by the plan administrator. Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's salary reduction and rollover contributions, employer discretionary matching contributions and an allocation of the employer's discretionary profit-sharing contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant's compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account plus actual earnings thereon is based on years of continuous service as follows: 0% vested for the first two years of service, then 20% vesting per year until the participant is 100% vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of the lower of 50% of their vested account balance or \$50,000. Note transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participant's fund. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates ranged from 4.75% to 10.5% at December 31, 2024. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Participants are eligible to receive the vested portion of benefits upon termination of employment, death, disability, retirement or Plan termination. If a participant's balance does not exceed \$5,000, the vested benefit will be distributed as a single lump-sum payment. If a participant's balance exceeds \$5,000, the vested benefit can be distributed as a single lump-sum payment or as partial withdrawals of at least \$1,000. The distribution(s) shall be made to the participant or beneficiary in accordance with the election of the participant. Distributions may also be made for hardship withdrawals, which are authorized by the Plan Administrator and conform to the "deemed hardship" standards set forth in Treasury Regulation Section 1.401(k)(d)(2). Such hardship distributions are subject to certain limitations.

Investment Options

Reliance Trust Company as Trustee under a trust agreement held the assets of the Plan during the year, including all contributions and earnings thereon. Upon enrollment in the Plan, participants may direct contributions in any of the investment options made available by the Trustee.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting and have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The Plan administrator uses estimates and assumptions in preparing the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported changes in net assets. Actual results could vary from the estimates that were used.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. Interest income on notes receivable is recorded on the accrual basis.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits if a defined-contribution plan attributable to fully benefit-responsible investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan currently does not hold any fully benefit responsive funds (see Note 6).

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market fluctuation and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participant account balances, the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Plan Expenses

The Company sponsors the Plan. Personnel within the Company perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as Plan expenses. All other Plan expenses are paid by the Company and excluded from these financial statements. Other recordkeeping services are paid by the Plan and totaled \$32,321 for the year ended December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

3. Income Tax Status

The IRS has determined and informed the Plan by letter dated March 31, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was amended on May 1, 2022, to incorporate required modifications to the plan. An updated determination letter has not been received however, management and the Trustee believe the modifications are in compliance with IRS specifications.

Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its exempt status and had not taken uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Information Certified by the Trustee

The Plan Sponsor elected the method of compliance presented by 29 CFR 2520.103(A)(3)(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, certain information certified need not be subject to independent audit.

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023, as well as in the supplemental schedule as of December 31, 2024, and the net realized and unrealized appreciation/(depreciation) in fair value of mutual funds and common/collective trust, and dividend income for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Plan's trustee, Reliance Trust.

5. Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balance.

6. Fair Value Measurement

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: quoted prices in active markets for identical assets or liabilities
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: observable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (Mutual funds): Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

The following is a description of the valuation methodologies used in 2024 and 2023 for assets measured at Net Asset Value as the practical expedient to estimate fair value:

Common/collective trusts: Common/collective trusts ("CCT") are valued at NAV which is based on the fair value of the underlying investments of the CCT, less any liabilities. The CCT invests in guaranteed investment contracts and similar contracts issued by insurance companies, banks, and other financial institutions. Also, the CCT invests in security-backed investment contracts and short-term investments. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) and redemption notices may occur daily. The CCT has no unfunded commitments. Investments measured at fair value based on the NAV per share as a practical expedient were \$314,992 and \$813,682 as of December 31, 2024 and 2023, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used as of December 31, 2024 and 2023. There were no transfers between Levels 1, 2 and 3 for the year ended December 31, 2024.

Any transactions involving these investments are on the open market at fair value or contract value, as outlined in Note 2. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in interest transactions under ERISA.

8. Subsequent Events

The Plan has evaluated subsequent events from the date of the Statements of Net Assets Available for Benefits through September 11, 2024, the date the financial statements were available to be issued. During this period, no material recognizable subsequent events were identified, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.
