## INDEPENDENT AUDITOR'S REPORT

To the Trustee and Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cascade Management, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## 1. Plan Description

The following description of Cascade Management, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective March 7, 2022.

### General

The Plan is a defined contribution plan for substantially all employees of Cascade Management, Inc. (the Employer); the Plan was established June 1, 1992 under the provisions of the Internal Revenue Code (IRC) Section 401(k). The Plan covers all employees who are at least 18 years old and have completed one year and 1,000 hours of service, and enter the first day of the month following the date they become eligible. The Plan provides employees who are eligible to participate with an opportunity to accumulate funds for retirement benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Contributions

Each year, participants may contribute up to 90 percent of their compensation. Participants may elect their deferrals to be treated as pre-tax or after-tax (Roth). Individuals who attain age 50 by the end of the Plan year are eligible to make additional "catch-up" contributions. All participants who are eligible to participate but not deferring will be automatically enrolled into the plan with 1 percent of base compensation as pre-tax deferrals, unless they opt out. This automatic enrollment will also apply to new employees who become eligible to participate in the plan. There is no auto-escalation provision related to the automatic enrolment provision. Participants may also contribute amounts representing rollover distributions from other qualified plans. All participant contributions shall be fully vested at all times.

The Employer may make a matching contribution. During 2024 and 2023, the Employer's matching contributions were 50 percent of up to the first 4 percent of base compensation, with a maximum of 2 percent that the Company will contribute to the Plan. The Employer may also make a discretionary non-elective contribution in addition to the Employer match each year. There was no Employer discretionary non-elective contribution for the years ended December 31, 2024 and 2023.

Participants direct the investment of their contributions into various investment options offered by the Plan.

### Participant Accounts

The account of each participant is credited with the participant's contribution and allocation of (a) the Employer's matching and discretionary non-elective contributions and (b) Plan earnings. Each participant's account is charged with any fees or expenses related to individual investment options and fees associated with loan processing. Allocations of Plan earnings (losses) and advisory fees are based on individual participant earnings or account balances, as defined in the Plan. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**1. Plan Description, continued**

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in any Employer contribution is based on years of continuous service. A participant becomes 20 percent vested after completing two years of service and 100 percent vested after six years of service. A year of service for vesting purposes is a Plan year in which the participant has 1,000 hours of service.

**Payments of Benefits**

Upon retirement, disability, death, or termination of employment, a participant (or their designated beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annual installments. A participant who reaches normal retirement age, as defined in the Plan document, may take in-service distributions of all or part of their account balance at any time. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum payment.

**Hardships**

If a participant has an immediate and heavy financial need, hardship withdrawals are allowed under the Plan in an amount not to exceed the lesser of the participant's vested balance or the participant's immediate and severe financial need. In the event of a hardship withdrawal, the participant's elective deferral contributions, if any, will be automatically suspended. The participant will be ineligible to resume making such contributions for six months.

**Forfeited Nonvested Accounts**

Forfeited nonvested accounts may be used to reduce future Employer contributions and/or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22 and \$13, respectively. For the year ended December 31, 2024, \$26,985 was forfeited by participants and \$28,003 of forfeited nonvested accounts were applied to Employer contributions into the Plan. For the year ended December 31, 2023, \$5,164 was forfeited by participants and \$5,165 of forfeited nonvested accounts were applied to Employer contributions into the Plan.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The Plan allows only one outstanding loan for each participant at any one time. The loans are secured by the balance in the participant's account and bear interest at a rate of 2 percentage points over the prime interest rate, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Loan terms range up to five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time determined by the Plan Administrator with a maximum term of 30 years. Principal and interest on participant loans is paid ratably through bi-weekly payroll deductions.

**Administration of the Plan**

The Employer is the Plan Administrator and Plan Sponsor. Reliance Trust Company served as the Plan's trustee as of and for the years ended December 31, 2024 and 2023. ADP served as a third-party administrator and recordkeeper to the Plan as of and for the years ended December 31, 2024 and 2023.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses and Fees**

Certain administrative expenses of the Plan are paid from Plan assets or from the balance of available forfeitures. Certain other administrative expenses may also be paid by the Employer; such expenses are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Contributions**

Participant contributions are recorded in the year in which they are withheld from compensation.

**Payment of Benefits**

Benefits are recorded in the financial statements when paid.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable. There was no impact to the financial statements as a result of adopting this standard.

**3. Tax Status**

As of March 7, 2022, the Plan was restated under a prototype plan through execution of an adoption agreement. The prototype plan adopted is the Automatic Data Processing Defined Contribution Plan. ADP, LLC, the sponsor of the prototype plan, has received an opinion letter dated October 6, 2020, stating that the Plan was designed in accordance with applicable requirements of the Internal Revenue Code (IRC).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**4. Related Party Transactions**

The Plan could have investments which are shares of registered investment companies managed by Reliance Trust Company, the trustee of the Plan for the years ended December 31, 2024 and 2023, and therefore, these transactions would qualify as party in interest transactions. These party in interest transactions are exempt from the prohibited transaction rules of ERISA. Fees paid to ADP, LLC, an affiliate of the trustee, were \$33,024 and \$29,863 for the years ended December 31, 2024 and 2023, respectively. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

**5. Plan Termination**

Although the Employer has not expressed any intent to discontinue its contributions and terminate the Plan Agreement, it may do so at any time subject to the provisions set forth in ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their accounts.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**8. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Units held in the common/collective trusts are valued using the net asset value (NAV) of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the common/collective trust measured at NAV have not been classified in the fair value hierarchy. All common/collective trust investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.
