We have performed audits of the accompanying financial statements of NinjaTrader Group, LLC 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### Note 1 – Description of Plan

The following description of the NinjaTrader Group, LLC 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General and eligibility

The Plan is a defined contribution plan, established on May 1, 2013, for the benefit of the eligible employees of NinjaTrader Group, LLC and its affiliates (collectively, the Employers, Company, or Plan Sponsor). The Plan was amended and restated on July 1, 2022 to comply with certain tax legislation, include an additional adopting employer, and appoint a new recordkeeper and trustee. Eligible employees are full-time employees who have reached the age of twenty-one (21) and completed three (3) months of credited service. An employee may participate in the Plan beginning on the first day of each month following the date the employee completes the age and service requirements. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Company is the Plan Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

ADP Retirement Services (ADP) provides recordkeeping and third party administrative services to the Plan. Reliance Trust Company (RTC or the Trustee) serves as the Trustee of the Plan, holds the Plan's investment assets, and executes investment transactions.

#### Contributions

Each year, participants in the Plan may voluntarily contribute up to 90% of their annual compensation, as defined, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment, up to 6%. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has a qualified automatic contribution arrangement (QACA) whereby the Company makes a safe harbor matching contribution equal to 100% of the first 1% and 50% of the next 5% of a participant's eligible compensation, as defined, that a participants contributions to the Plan. For the year ended December 31, 2024, the Company's QACA safe harbor matching contribution totaled \$708,639. The Company may also make additional discretionary and profit-sharing contributions to the Plan. No such discretionary or profit-sharing contributions were made during the year ended December 31, 2024. Participants are eligible for the Company's safe harbor, discretionary or profit-sharing contributions after meeting the eligibility requirements to participate in the Plan. All Employer contributions are invested in funds in accordance with the participant's discretion and the Plan's provisions.

Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant account is credited with the participant's contribution and an allocation of: (a) the Employers' contributions, if any, and (b) Plan earnings or losses. Participant accounts are charged with his or her withdrawals and an allocation of administrative expenses that are provided by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested portion of their account.

**Note 1 – Description of Plan, Continued**

Vesting

Participants are immediately vested in their individual contributions. Participants are fully vested in their Employers' QACA safe harbor matching contributions, plus actual earnings and losses, thereon, after two (2) years of credited service based on a vesting schedule. Vesting in the Employers' other contributions, if any, plus earnings or losses thereon, is based upon years of credited service. A participant is 100% vested in the Employers' other contributions after five years of credited service based on a graded vesting schedule. Regardless of years of service, participants are 100% vested upon reaching normal retirement age (65), becoming disabled, or upon death or termination of the Plan.

Forfeitures

Forfeited nonvested accounts may be used to reduce future employer contributions or to pay Plan administration expenses. As of December 31, 2024 and 2023, unallocated nonvested forfeitures totaled \$759 and \$1,543, respectively. For the year ended December 31, 2024, forfeitures used to reduce the Employers' contributions totaled \$22,075.

Notes receivable from participants

The Plan does not permit participant loans. However, participant loans that transferred into the Plan from the Transact Futures 401(K) Plan (Transact 401(K)), as part of the Company's acquisition of Transact 401(K)'s sponsor, remain in force until all principal payments are complete, as defined in the Plan document.

Payment of benefits

On termination of service due to death, disability, or normal retirement age (65), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, or in monthly installments or a rollover into another qualified plan. For termination of service due to other reasons, a participant may choose to leave the vested interest in the Plan if such amounts exceed \$1,000 or elect a lump-sum distribution. Participants with vested amounts less than \$1,000 must elect a lump-sum distribution. Participants may elect to receive an in-service distribution of vested funds if they meet certain defined requirements, including becoming disabled, reaching age 59½ or for a qualifying financial hardship, as defined.

Plan administration

The Company is the Plan Administrator and, as such, controls and manages the operations of the Plan. Plan management has contracted with ADP provides recordkeeping and third party administrative services. RTC serves as the Trustee, maintains the records of the participants' data and invests cash received, interest and dividend income and makes distributions to participants (subject to the direction of participants). Fees from covered service providers of the Plan are in compliance with the Department of Labor's (DOL) regulations regarding ERISA Section 408(b)(2).

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investments valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences may be material.

Risks and uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, liquidity risk and credit risk. Due to the high level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Payment of benefits

The Plan records benefits when paid.

Contributions

Contributions from Plan participants and the contributions from the Employers are recorded in the year in which the participants' contributions are withheld from compensation.

Plan expenses

Investment related expenses are included in net appreciation in fair value of investments. Certain administrative expenses, such as recordkeeping, trustee, and third-party administrator fees, are paid from Plan assets and classified as an expense rather than as a reduction of investment income. Certain other administrative expenses are paid by the Plan Sponsor and are not reflected in these financial statements. Participant directed transactions such as loan processing fees are charged directly to participants' accounts.

Uncertain tax positions

U.S. GAAP requires Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at December 31, 2024 that it would be unable to substantiate.

**Note 3 – Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan’s independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental information, including assessing whether the supplemental information, is in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 4 – Fair Value Measurements**

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

**Note 4 – Fair Value Measurements, Continued**

The following is a description of the valuation methodologies used for assets measured at fair value:

*Collective investment trust fund (CIT)* – valued daily at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CIT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. This practical expedient would not be used when it is determined to be probable that the CIT will sell for an amount different from the reported NAV. The CIT provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to this investment. This is direct filing entities. Participant transactions (purchases and sales) may occur daily at NAV.

*Mutual funds* – valued at quoted market prices, which represent their daily net asset value (NAV) and, therefore, are classified as Level 1. Mutual funds held by the Plan are open-end mutual funds that are traded on national exchanges (active markets).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Related Party Transactions and Party-In-Interest Transactions**

Parties-in-interest are defined under the DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employers and certain others.

The Plan's investments are maintained and managed by Reliance Trust Company, the Plan's Trustee, and therefore, these transactions qualify as party-in-interest transactions. ADP is the Plan's recordkeeper and third-party administrator, fees charged by ADP and transactions with ADP qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Plan Sponsor. No officer or employee receives compensation from the Plan for these services.

**Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employers' contribution portion of their accounts.

**Note 7 – Tax Status**

On October 6, 2020, the IRS stated that the Non-Standardized Pre-Approved profit sharing plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC) and therefore, the Plan and its related trust are tax-exempt. The Plan has not received a determination letter specific to the Plan itself. The Plan Administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
