## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
MB Medical Operations, LLC 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of MB Medical Operations, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of MB Medical Operations, LLC 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of MB Medical Operations, LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting**

As discussed in Note 1A to the financial statements, the governing body of MB Medical Operations, LLC 401(k) Plan approved a plan of liquidation on November 4, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

NOTE 1 - DESCRIPTION OF PLAN

The following description of the MB Medical Operations, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A) GENERAL

Effective January 1, 2022, MB Medical Operations, LLC (the "Company") established a Safe Harbor 401(k) plan covering eligible employees who are at least 21 years of age and who have completed three months of service, as defined. Effective January 1, 2024, eligible employees of MD Medical Transport, LLC, Miami Beach Medical Consultants, and Rodolfo Dumenigo MD, PA are also eligible to join the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("Code").

The Company serves as the plan administrator. Transamerica Life Insurance Company Inc., a qualified institution, served as the Plan's record keeper and custodian ("Transamerica") for the period from January 1, 2023 to February 28, 2023. Effective March 1, 2023, the Company changed service providers to ADP Retirement Services ("ADP") and Reliance Trust Company ("Reliance"), a qualified institution, became the appointed trustee.

On November 4, 2024, the plan sponsor approved the termination of the Plan effective March 31, 2025. As of the date of these financial statements, the plan sponsor has initiated the process of termination in accordance with applicable provisions of the Code and Department of Labor Regulations. Final distributions will be determined based on all participants being 100% vested and will be made as soon as possible after the termination date. As a result, the Plan has adopted the liquidation basis of accounting in accordance with Accounting Standards Codification ("ASC") 205-30, *Presentation of Financial Statements — Liquidation Basis of Accounting*, effective November 4, 2024.

B) CONTRIBUTIONS

Participants may elect to contribute to the Plan a portion of their compensation, as defined by the Plan, on both pre-tax and Roth (after-tax) basis, subject to Internal Revenue Service ("IRS") limitations. Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contribution). Catch-up contributions are permitted for participants who are 50 or older during the Plan year. The total maximum allowable contribution per participant to the Plan directly from the participant was \$23,000 for the fiscal Plan year, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

B) CONTRIBUTIONS (CONTINUED)

The Company can elect to make safe harbor matching contributions, qualified non-elective contributions as well as discretionary matching contributions to the Plan. During 2024, the Company elected to make safe harbor matching contributions equal to 100% of the amount contributed by participants to the Plan up to the first 3% of participant compensation plus 50% of elected deferrals that exceed 3% of participant compensation up to 5%. The Company’s safe-harbor matching contribution was approximately \$1,005,000 for the year ended December 31, 2024. This amount is net of approximately \$4,500 in forfeitures used to offset matching contributions.

C) PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s compensation deferral contributions, the Company’s discretionary contributions, if any, and an allocation of the investment earnings, based upon each participant’s election. The benefit to which a participant is entitled upon withdrawal from the Plan, as defined above, is the vested benefit in the participant’s account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

D) INVESTMENT OPTIONS

Participants may direct their elective 401(k) contributions, rollovers, if any, as well as Company discretionary matching and non-elective contributions to the Plan in a variety of investment options as more fully described in the Plan document. Participants may change their investment options and deferral percentages at their discretion.

E) VESTING

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in discretionary employer contributions plus actual earnings thereon is based on years of continuous service. Vesting in the Company’s discretionary and non-elective contributions is as follows:

Participants are 100% vested, regardless of years of service, when they reach normal retirement age, are totally and permanently disabled, or death occurs.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

F) PAYMENT OF BENEFITS

Benefits are payable on termination of service due to retirement, termination, disability or death. Participants or their beneficiaries may elect to receive a lump-sum distribution or annual installments, and partial withdrawals as defined in the Plan document. Eligible participants may also make hardship withdrawals, as defined.

G) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of (a) 50 percent of their vested account balance, or (b) \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve month period. Participants are permitted to have one loan outstanding at any given time. The notes are secured by the vested balance in the participant's account. Notes bear interest at a fixed rate equal to 1% above the prime rate at origination.

Principal and interest is repaid through payroll deductions over a period of no more than five years, unless the loan is used for the purchase of a primary residence.

H) FORFEITED ACCOUNTS

Pursuant to the Plan, forfeited non-vested accounts may be used to pay Plan expenses or reduce employer contributions. Approximately \$4,500 in forfeitures were used to offset matching contributions during the year ended December 31, 2024. The Plan had approximately \$20 and \$11 in non-vested forfeiture balances at December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

A) BASIS OF ACCOUNTING

The Plan's financial statements are prepared under the liquidation basis of accounting in accordance with ASC 205-30, *Presentation of Financial Statements— Liquidation Basis of Accounting*. Under the liquidation basis of accounting, assets are measured at their estimated net realizable values, and liabilities are measured at estimated settlement amounts, including costs expected to be incurred during liquidation. The financial statements include management's estimates of the amounts expected to be collected and paid during the liquidation process. Actual amounts may differ from these estimates.

B) USE OF ESTIMATES

The preparation of financial statements in conformity with the liquidation basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (COTNINUED)

C) INVESTMENT VALUATION AND INCOME RECOGNITION

Investments of the Plan are reported at their estimated net realizable value as of the liquidation date, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in pooled separate accounts are valued based the net asset value ("NAV") of the underlying mutual funds. The Plan utilizes the NAV practical expedient for its pooled separate account investments. The Plan's stable value fund is reported contract value, which approximates fair value.

Purchases and sales of securities are recorded on a trade date basis. Dividend and interest income are recorded by the custodian in the period earned. Net realized and unrealized appreciation or depreciation in fair value of investments consists of the change in unrealized appreciation or depreciation and the realized gain or loss on the sales of investments during the year. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses. Investments are self-directed by the individual Plan participants.

D) NOTES RECEIVABLE FROM PARTICIPANTS

Under accounting principles generally accepted in the United States of America, notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. In accordance with the liquidation basis of accounting, the Plan has evaluated the collectability of these receivables as of December 31, 2024. Outstanding loan balances, including accrued interest, are generally not expected to be repaid and are therefore treated as deemed distributions to participants. The deemed distributions are reclassified from Plan assets and are included in accrued liquidation costs in the accompanying statement of changes in net assets in liquidation available for benefits. During the year ended December 31, 2024, approximately \$116,000 in notes receivable from participants were treated as deemed distributions (Note 5).

E) PAYMENT OF BENEFITS

Benefits are recorded when paid.

F) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (COTNINUED)

G) ADMINISTRATIVE EXPENSES

The Plan agreement allows the Company to absorb the majority of the Plan's administrative and investment-related expenses. Investment-related expenses are included in net depreciation of fair value of investments through revenue sharing arrangements. During the fiscal year ended December 31, 2024, approximately \$43,000 in administrative expenses were incurred by the Plan.

H) RECENT ACCOUNTING PRONOUNCEMENTS

The Company evaluates new accounting pronouncements for relevance and impact on the Plan's financial statements. Management does not expect that timely adoption of new pronouncements will have a material impact on the Plan's net assets available for benefits.

I) MANAGEMENT REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 3, 2025, the date when the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, Level 1 and Level 2 inputs were available and therefore used. No level 3 inputs were used by the Plan.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

TRP Stable value fund – The T. Rowe Price Stable Value Common Trust Fund invests primarily in a portfolio of contract issued by U.S. insurance companies, U.S. banks, U.S. branches of foreign insurance companies, foreign banks, and other financial institutions that meet the quality standards established by T. Rowe Price Trust Company. The investment objectives of the trust are to maximize current income consistent with the maintenance of principal and to provide for benefit-responsive participant withdrawals at contract value for certain events without penalty or adjustment. The trustee calculates the NAV of the units daily. To calculate the NAV of units, the trust’s assets are valued and totaled, and then any expenses, costs, charges, or other liabilities incurred or accrued by the trust (and each class thereof) are subtracted. Each class’s pro-rata share of the net value of the trust’s assets is divided by the total number of units outstanding of such class.

NOTE 4 - PLAN TERMINATION AND LIQUIDATION

On November 4, 2024, the plan sponsor approved the termination of the Plan effective March 31, 2025. As a result, the Plan adopted the liquidation basis of accounting and all participants became 100% vested in their employer contributions.

NOTE 5 - ACCRUED LIQUIDATION COSTS

The financial statements include accrued liquidation costs of \$139,011 as of December 31, 2024, representing management’s estimate of expenses to be incurred through completion of the Plan’s termination. Actual costs of liquidation may differ from these estimates.

NOTE 6 - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing plan, which has obtained a favorable IRS opinion letter on October 6, 2020, in which the IRS stated that the form of the Plan was acceptable under Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified and the related trust is tax-exempt. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee and qualified institution, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fees paid to Reliance and ADP qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 9 - FIDELITY BONDING

The Company maintains a fidelity bond of \$280,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA. The policy has a provision whereby loss coverage is increased to the minimum required by ERISA up to the \$500,000 limit.
