Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Logic Information Systems 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (Liquidation) and 2023 (Going Concern) and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 (Liquidation) and 2023 (Going Concern), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Logic Information Systems 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Logic Information Systems 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Logic Information Systems 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter

As described in Note 1 to the financial statements, the Trustees of the Plan approved to terminate the Plan as of August 12, 2024, and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from going concern basis used in presenting the 2023 financial statements, to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Logic Information Systems 401(k) Plan (the Plan) is intended to provide general information only. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan's provisions.

Sale of Plan Sponsor and Plan Termination

On June 2, 2024, Logic Information Systems, Inc. (the Company and plan sponsor), completed a transaction whereby it sold all of its outstanding stock to Accenture, Inc. (the "Acquirer"). The Trustees of the Plan approved to terminate the Plan as of April 30, 2025 at which time the accounts of all participants became 100 percent vested. Participants were able to continue to make contributions to the Plan through the August 9, 2024 payroll date and then the Participants were migrated over to the Acquirer's sponsored defined contribution plan. Participants could either roll over their investment into the Acquirer's plan or have their investments automatically rolled over to an Individual Retirement Account (IRA). All participant accounts were distributed by May 20, 2025.

As a result of the approved termination of the Plan, management determined that liquidation was imminent and the Plan has utilized the liquidation basis of accounting in presenting the 2024 financial statements. The liquidation basis of accounting generally requires accruing income and expenses expected to be incurred until the completion of the liquidation of the Plan, however, as the Company intended on paying all material liquidation expenses, no adjustments were recorded in respect to this matter during the years under audit.

General

The Plan was a single employer 401(k) defined contribution plan covering all employees of the Company. The Plan was established on October 1, 2017 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all requirements of Sections 401(a) and 401(k) of the Internal Revenue Code (IRC).

Plan Administration

The Company was the plan sponsor and plan administrator. The Plan contracted ADP Inc. to assist and advise about plan administrative matters and to provide recordkeeping services. ADP Inc. also assisted with plan administration and was responsible for: executing investment transactions; processing and collecting participant loans; receiving and disbursing rollovers to and from the Plan; maintaining plan records, including participant account information; making disbursements to former participants and for monitoring compliance of the Plan with regulatory requirements. Reliance Trust Company (the Trustee) held the assets of the Plan and provided the Plan with a certified list of the Plan's assets, as well as a detailed transaction register at the end of each Plan year.

Eligibility

Eligible employees were required to complete three months of service and reach the age of 21 to participate in the Plan. Employees could become participants in the Plan at the start of each month after satisfying the eligibility requirements.

Participant Wage Deferrals

Participants could elect to contribute up to 90% of their compensation to the Plan via wage deferrals subject to a calendar year dollar limit determined annually by the Internal Revenue Service (IRS). Participants could make two types of contributions to the Plan – a pre-tax 401(k) deferral or a Roth 401(k) deferral. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

Contributions in excess of IRS limitations were returned to participants when determined. There were no contributions and earnings thereon returned to participants that related to the Plan years ended December 31, 2024 and 2023.

Employer Contributions

The Plan provided for a discretionary matching employer contribution which was determined annually. To be eligible for the employer contributions, a participant must have completed at least 1,000 hours of service and have been employed on the last day of the Plan year unless termination was due to death, disability, or retirement. The employer match contribution was \$195,799 and \$417,560 for the Plan years ended December 31, 2024 and 2023, respectively.

Rollover Contributions

The Plan provided for participants to rollover contributions from other qualified retirement or profit sharing plans.

Participant Accounts

Each participant's account was credited with the participant's wage deferral contributions, rollover deposits, employer contributions, if any, and an allocation of plan earnings (losses). Participant accounts were charged with withdrawals and an allocation of administrative expenses. Allocations were based on the participant's account balances, or participant transactions, as defined.

The allocation of the employer's matching contribution, if any, was based upon a uniform percentage or dollar amount of individual participant wage deferrals each plan year.

Participants directed the investment of their wage deferrals and all employer contributions into various investment options offered by the Plan.

Vesting

Participants were immediately 100% vested in their wage deferral and employer match contributions and any earnings on those amounts.

Notes Receivable from Participants

Participant loans were permitted in accordance with the Plan's written loan policy. Loans could not exceed the lesser of 50% of the participant's vested account balance or \$50,000. Participants were limited to having two outstanding loans at any given time. Loans bear interest at a fixed rate of 1% above the prime interest rate on the first day of the month in which the loan was requested by the participant. Payments were made through payroll deductions over the loan term, not to exceed five years. Primary residence loans were an exception where terms were not to exceed 15 years.

Payment of Benefits

Upon termination of employment, participants were entitled to receive an amount equal to their vested account balance, determined as of the valuation date. A participant with an account balance that exceeded \$5,000 could elect to keep the remaining funds in the Plan, directly rollover the account balance into an IRA or savings account, or receive the balance in cash. Participants with an account balance under \$5,000 could either directly rollover the account balance into an IRA or savings account.

If no direction from the participant was received, the Plan would continue to hold the funds if over \$5,000, or would make a distribution to the participant if the account balance was under \$5,000. The Plan allowed for in-service distributions upon attainment of age 59½ and hardship distributions subject to Plan provisions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the liquidation basis of accounting as of and for the year ended December 31, 2024. The Plan's financial statements as of and for the year ended December 31, 2023 were prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

The financial statements and related notes are intended to conform with The Department of Labor's rules of Section 2520.103-8 and regulations for reporting and disclosures under The Employee Retirement Income Security Act of 1974. All information required to comply with these laws has been included herein and is in conformity with those laws.

Investment Valuation and Income (Loss) Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. The realized gain or loss on sales of investments is determined based upon the average cost of investments sold. Net appreciation (depreciation) in fair value of investments on the Statements of Changes in Net Assets Available for Benefits includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Dividend income is recorded on the ex-dividend date. Interest is recorded as earned.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost which includes their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. The Plan estimates expected credit losses on Notes Receivable from Participants based on historical experience, current conditions, and reasonable and supportable forecasts. The Plan utilizes an aging analysis to determine the allowance for credit losses, considering the length of time the receivables have been outstanding and the likelihood of collection. The Plan's credit quality indicators included the participant's employment status and repayment history. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

The estimate of expected credit losses reflects the Plan's assessment of future economic conditions and their potential impact on participants' ability to repay their loans. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Employee Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess employee contributions as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan was sponsored by the Company. Personnel within the Company's organization performed various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as Plan expenses. Administrative expenses are absorbed through the Plan. The Plan paid ADP Inc. \$35,830 and \$17,958 for recordkeeping and other administrative expenses during the Plan years ended December 31, 2024 and 2023, respectively. The Plan paid CK Financial \$12,746 and \$9,600 for investment advisory fees during the Plan years ended December 31, 2024 and 2023, respectively.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3 INFORMATION CERTIFIED BY THE PLAN TRUSTEE (UNAUDITED)

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan has received certifications from the Trustee that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investment balances
- Net appreciation in fair value of investments
- Dividend and interest income
- Notes receivable from participants and interest income
- Supplemental Schedule of Assets (Held at End of Year) – December 31, 2024

The Plan's Independent Auditors have not audited this information contained in the financial statements and supplemental schedule as it has been certified by the Trustee for the applicable periods.

NOTE 4 FAIR VALUE MEASUREMENTS

The Fair Value Measurements topic of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"> ◆ Quoted prices for similar assets or liabilities in active markets; ◆ Quoted prices for identical or similar assets or liabilities in inactive markets; ◆ Inputs other than quoted prices that are observable for the asset or liability; ◆ Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The plan administrator determines the fair value measurement policies and procedures subject to oversight by the Plan's investment committee. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted as necessary, based on current market conditions and other third-party information.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

NOTE 6 FEDERAL INCOME TAX STATUS

ADP Inc., the provider of the prototype plan document adopted by the Plan received an opinion letter in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan was relying on the opinion letter the prototype plan received from the Internal Revenue Service, that the Plan is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The plan administrator believes the Plan met the requirements of Section 401(a) of the IRC and was exempt from federal income tax under Section 401(a) of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan provided for investment in a variety of investment funds. These funds held various securities including U.S. Government securities, corporate debt securities, and equities. Investments in general are exposed to various risk factors, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it was reasonably possible that changes in the values of the investments would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 8 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Plan prepares its Form 5500 (Annual Return/Report of Employee Benefit Plan) using the modified accrual basis of accounting whereby it does not record employee or employer payables or receivables.
