INDEPENDENT AUDITOR'S REPORT

To the Investment Committee and participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Primrose Holdings LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

1. Description of Plan

The following description of the Primrose Holdings LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Primrose Holdings LLC and its subsidiary Primrose School Franchising Company LLC (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to participate in the Plan on the first day of the month after the completion of 2 months of service and the attainment of age 21. Part-time, temporary, or seasonal employees who have less than 1,000 hours of service during the Plan year are excluded from being eligible to participate in the Plan.

Contributions

Employees are automatically enrolled in the Plan upon meeting the eligibility requirements at a rate of 6% of eligible compensation, unless they elect otherwise. Participants may elect to make pre-tax and/or Roth contributions up to 90% of eligible compensation as defined in the Plan document, generally not to exceed a maximum of \$23,000 in 2024, plus an additional \$7,500 catch-up deferral for eligible employees age 50 or older at the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company makes a safe harbor matching contribution that is equal to 100% of a participant's contribution that does not exceed 1% of compensation plus 50% of a participant's contribution between 1% and 6% of compensation, as defined in the Plan document. The Company may also elect to make discretionary profit-sharing contributions and discretionary matching contributions. During 2024, the Company made no discretionary matching or profit-sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions and net change in fair value of investments in their account and is charged with certain administrative expenses and transaction charges for services received by individual participants. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in all contributions plus actual earnings thereon.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,849 and \$2,743, respectively. Forfeitures may be used first to pay for Plan administrative expenses and then to reduce Company contributions. In 2024, no forfeitures were used to offset Company contributions or administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at any time. Only active employees who participate in the Plan may request a note. The notes are secured by the balance in the participant's account and bear interest at 1% over the prime interest rate. During 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the note, not to exceed 5 years unless used for the purchase of the participant's primary residence. Principal and interest are paid through payroll deductions. All notes must be repaid immediately after termination of employment or death.

Payment of Benefits

At the time of death, disability, attainment of age 59½, termination of service, or retirement, the participant or their beneficiary may elect to receive their benefits as a lump-sum amount equal to the value of the participant's vested interest in their account. The participant's contributions may also be withdrawn in certain hardship situations. Participants that terminate employment and have an account balance less than \$5,000 will automatically receive a lump sum payment equal to the vested interest of their account.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan in accordance with the Plan's provisions. These expenses are paid to service providers of the Plan and therefore qualify for party-in-interest transactions. Certain other administrative expenses of the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for these expenses. Participant transaction fees paid by participants include distribution fees and other transaction fees.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Discretionary profit-sharing and matching contributions are recognized upon authorization by the Company. Any unfunded participant or Company contributions are included as a participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments, and fees charged for investment management and administrative services on those investments.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default the participant note balance is reduced, and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 29, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Plan's qualified institution.

4. Investments

Fees incurred by the Plan for investment management services are included in net change in fair value of investments as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to several risks, such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect participants' account balances.

The FASB established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable inputs, including quoted market prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The common/collective trust trades at net asset value (NAV) per share. The Plan has elected to use a practical expedient to measure the fair value of the investment in the common/collective trust. The NAV, including units of ownership to which a proportionate share of net assets is attributed, is used as of the reporting date. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The Putnam Stable Value Fund (the Fund) is a collective trust stable value fund with an intended purpose of providing stable principal and high current income. The Fund invests directly or indirectly in fully benefit-responsive investment contracts, and similar contracts issued by insurance companies, banks, and other financial institutions. The Fund's units are issued and redeemed daily at the constant NAV of \$1 per unit. The common/collective trust is not categorized within the fair value hierarchy. The common/collective trust includes certain redemption restrictions that are specific to each investment. The Fund has no unfunded commitments.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Income Tax Status

The Plan uses a non-standardized prototype plan document sponsored by Automatic Data Processing, LLC (ADP). ADP received an opinion letter from the IRS, dated October 6, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan has not received an individual determination letter and has been amended since ADP received the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
