INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Strohwig Industries, Inc. 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Strohwig Industries, Inc. 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Reliance Trust Company, LLC as of and for the year ended December 31, 2024 and for the period from July 1, 2023 through December 31, 2023 and Bank of America, N.A. for the period from January 1, 2023 through June 30, 2023 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

December 31, 2024 and 2023

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Strohwig Industries, Inc. 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through August 28, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Strohwig Industries, Inc. is the plan sponsor, employer and plan administrator. Reliance Trust Company is the plan trustee that holds custody of the plan's assets and maintains investment records. ADP, LLC (ADP) is the third party administrator, recordkeeper and tax counsel that performs various compliance tests. Prior to July 1, 2023, Bank of America, N.A. was the plan trustee that held custody of plan assets, third party administrator that maintained participant records and tax counsel that performed various compliance tests. Merrill Lynch is the plan's investment advisor.

Investments - The 401(k) committee (which is comprised of employees of the plan sponsor) determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the prospectuses and annual reports of the investments for more information. Earnings on investments bought, sold and held during the years are reflected in the accompanying statements of changes in net assets available for benefits.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

The following is a description of the valuation methodologies used for investments measured at fair value.

Common/collective trust - Valued at the NAV based on the units of the common/collective trust. The common/collective trust investment is a direct filing entity. The NAV, as certified by Reliance Trust, is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by the common/collective trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the common/collective trust will sell the investment for an amount different from the reported NAV.

Mutual funds - Valued at the daily published market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily NAV and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following description of the plan is provided for general information purposes only. Participants should refer to the plan document for more a complete description of the plan's provisions.

General - The plan was established on January 1, 1987 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to participate in the plan once they have reached the age of twenty-one and completed six months of service. An employee can enter the plan on the first payroll of the month immediately following the completion of the eligibility requirements.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may elect to contribute a percentage of their compensation subject to certain Internal Revenue Service limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Newly eligible employees are automatically enrolled in the plan and have 3% of their compensation withheld as elective deferral contributions. Such participants have the option to increase, decrease or stop the deferral at any time by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. Employer matching contributions equal to 50% of the first 6% of employee compensation contributed to the plan as elective deferral contributions were made in 2024 and 2023. These contributions were funded coinciding with the employer's payroll with an annual true-up contribution.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, rollover contributions and an allocation of employer contributions. Participants are allowed to change their investment options daily and change their deferral percentage each pay period.

Vesting - Participants are 100% vested in their account balance.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon death, disability, attainment of normal retirement age or termination of employment. Participants may receive their distribution in the form of a single lump sum, installments or partial withdrawals. In addition, hardship withdrawals are permitted under certain circumstances and in-service withdrawals can commence upon attaining the age of 59½.

Notes receivable from participants - With the approval of the plan administrator, participants may obtain a loan from their account. Loans must generally be paid back over a period not to exceed five years unless the loan is taken for the purchase of a primary residence. The minimum loan amount is \$1,000 and the maximum amount is limited to the lesser of \$50,000 or one-half of the participant's balance. Participants may have up to two loans outstanding at any given time. As of December 31, 2024 the loans have various repayment schedules through December 2030 with interest rates ranging from 5.25% to 10.00%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

Administrative fees - Certain administrative fees of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed fees for distribution and loan processing services and nonparticipant directed fees for administrative and advisory services. The nonparticipant directed fees are allocated to participants on an account value basis.

3. PARTY-IN-INTEREST TRANSACTIONS

Transactions between the plan, the recordkeepers and the custodians (as defined in Note 1), qualify as party-in-interest transactions. Direct fees paid by the plan are recorded as a component of administrative expenses in the accompanying financial statements. Direct fees paid to ADP were \$14,000 in 2024 and \$4,000 in 2023, and direct fees paid to Bank of America, N.A. were \$11,000 in 2023.

ADP also receives indirect compensation from mutual fund companies for services provided to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed by the plan to ADP for administrative services to the plan.

Prior to July 1, 2023, Bank of America, N.A. received indirect compensation from mutual fund companies for services Bank of America, N.A. provided to the funds. The compensation received by Bank of America, N.A. was used to offset certain amounts that would otherwise have been owed by the plan to Bank of America, N.A. for administrative services provided. If the revenue exceeded the cost of administrative services, the excess was credited to the plan. The revenue sharing amount credited to the plan was \$28,000 in 2023 and is reported as other income in the accompanying 2023 statement of changes in net assets available for benefits. At the employer's discretion, these rebates can be allocated to the accounts of participants or used to offset the plan's administrative expenses. There were no accumulated unapplied rebates allocated to participants in 2024. During 2023, \$53,000 of accumulated unapplied rebates were allocated to participants on an account value basis. Unapplied rebates were \$19,000 as of December 31, 2024 and 2023.

Notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan at any time subject to the provisions of ERISA.

5. INCOME TAX STATUS

Effective July 1, 2023, the plan adopted an ADP, LLC non-standardized pre-approved profit sharing plan. The pre-approved profit sharing plan received a favorable opinion on October 6, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Prior to July 1, 2023, the plan was operating under a Merrill Lynch, Pierce Fenner & Smith Inc. non-standardized pre-approved profit sharing plan. The pre-approved profit plan obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) if the plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY PLAN TRUSTEES

Management has obtained certifications from the plan trustees, as defined in Note 1, qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such and the notes receivable from participants as of December 31, 2024 and 2023;
- b. Dividends from investments, net appreciation (depreciation) in fair values of investments and interest income on notes receivable from participants during 2024 and 2023; and
- c. Contributions to and withdrawals from accounts, and purchases, sales and interfund transfers of investments during 2024 and 2023.
