Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Phoenix International Holdings, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Phoenix International Holdings, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section.

Basis for Opinion

Note 1. Description of Plan

The following description of the Phoenix International Holdings, Inc. Retirement Plan (the "Plan") provides only general information. A complete description of the Plan is contained in the Plan Document which governs the operation of the Plan.

General

The Plan is a defined contribution profit sharing 401(k) plan, covering all eligible employees of Phoenix International Holdings, Inc. (the "Company") who are age 21 or older. Employees are eligible to participate in elective deferrals and matching contributions on the first day of the month following their hire date. Participants are eligible to participate in the Company's profit sharing contributions on the first day of the month following one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was amended effective January 1, 2021 with regard to employer matching contributions. If the matching contributions made for all determination periods in a Plan year is less than what would have resulted had the Plan computed the matching contributions on a participant's compensations, salary deferrals, and other relevant facts for the whole Plan year, matching contributions are recomputed on the ratio of salary deferrals to compensation for the whole Plan year, and "true-up" adjustments are made for a participant who is eligible to receive employer matching contributions for the Plan year. The Plan was subsequently amended again effective January 1, 2023 to remove this "true-up" provision.

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans in 2023 and beyond.

Contributions

The maximum allowable employee contributions to the Plan were \$23,000 for 2024 and \$22,500 for 2023. For employees 50 years of age or older, additional catch-up contributions of \$7,500 could be made to the Plan in both 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make matching contributions, equal to a uniform percentage of employee contributions, or discretionary profit sharing contributions, which are allocated to each employee's account based on compensation.

The Company made matching contributions in 2024 and 2023 at a rate of \$.50 for each \$1.00 deferred up to a 6% maximum deferral. The Company did not make any nonelective contributions for 2024 or 2023.

Participant Accounts

Each participant's account is credited with participant contributions and allocations of (a) the Company's matching and profit sharing contributions and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan or directly related to participant accounts, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their 401(k) elective deferral and rollover contributions to the Plan plus actual earnings thereon. Vesting in employer matching and discretionary profit sharing contributions is based on years of service. At December 31, 2024 and 2023, the vesting schedule for employer matching and discretionary profit sharing contributions is as follows:

Benefit Payments

The Plan provides for benefit payments upon termination, death, disability, age 59 1/2 in-service distributions or normal retirement at the age of 65, based on the vested balance in the participant's account. Hardship withdrawals and participant loans are also permitted if certain conditions are met as outlined in the Plan Document. Benefit payments are recorded when paid. There were no significant benefits payable to terminated participants who have withdrawn from the Plan as of December 31, 2024 or 2023.

Notes Receivable – Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through semi-monthly payroll deductions for a period not to exceed five years, unless for the purchase of a primary residence. Participants may have only one outstanding loan at any given time.

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Administrative Expenses

All expenses related to the administration of the Plan, except for those directly related to participant accounts, are paid by the Company.

Forfeitures

A participant who terminates and has vested in the employer matching or discretionary profit sharing contributions retains the vested portion and the nonvested portion is forfeited when vested amounts are distributed. Any forfeitures may be used to offset employer contributions or to pay plan expenses. Forfeitures available to offset administrative expenses and employer contributions were \$3,595 and \$2,957 at December 31, 2024 and 2023, respectively.

Investment Options

Participants may direct the investment of their account balance into various investment options offered by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Note 3. Income Tax Status

The Plan has adopted a prototype plan designed by Automatic Data Processing, LLP (ADP). The prototype plan obtained its latest determination letter on October 6, 2020 in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (Code). The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there is no audit in progress for any open tax period.

The Plan administrator evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification Topic 820, Fair Value Measurement (ASC 820), establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of inputs other than quoted prices in an active market that are observable; and Level 3 inputs are unobservable and significant to the fair value measurement, and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
