## Independent Auditors' Report

To the Trustees

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

**Note 1 - Description of Plan**

The following description of KaTom Restaurant Supply, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. Copies of this booklet are available from the Company.

General – The Plan is a defined contribution plan sponsored by the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees, other than certain excluded employees (union employees, nonresident aliens, and leased employees), are eligible to become participants in the Plan on the first day of the month concurrent with or following three months of employment.

Investments – The investments of the Plan are held by The Trust Company of Tennessee, Inc. (the Custodian), who maintains the investments in various mutual funds, the Invesco Stable Value fund, and the Federated Hermes Capital Preservation collective investment fund. Participants direct the investments in their accounts into the various investment options offered by the Plan. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan’s investments failed to perform is the recorded amount of such investments.

Plan Contributions - Participants may elect to contribute a percentage of their annual compensation or a fixed amount per pay period, on a pre-tax or after-tax basis, as a salary deferral. These deferrals are subject to the annual limitations defined in the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation, and their contributions invested in a designated fund selected by the plan administrator until changed by the participant.

The Company will make a safe harbor matching contribution to all participants based on the following tiers of salary deferrals: 100% of salary deferrals up to the first 3% of Plan compensation, as defined; and 50% of salary deferrals up to the next 2% of Plan compensation. Participant catch-up contributions are eligible for matching contributions. Each year, the Plan Sponsor may make nonelective profit sharing contributions to the Plan. No such contributions were made during 2024.

Cash contributions receivable, if any, are unsecured.

Participant Accounts – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Vesting is the portion of the participant’s account that cannot be forfeited. Participants are immediately vested in employer safe-harbor matching and participant contributions, including earnings thereon. Vesting in the Plan Sponsor’s discretionary profit sharing contribution portion of each participant’s account is based on years of continuous service, and participants become fully vested in the Plan Sponsor’s contributions after six years of service as follows:

Years of Vesting Service	Less than 2	2	3	4	5	6 or more
Vesting %	0%	20%	40%	60%	80%	100%

Participants may also become 100% vested as a result of death, total and permanent disability, or reaching normal retirement age at 65.

Participant Loans – Participant loans are not permitted under the terms of the plan document.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant (or a participant’s beneficiary in the event of the death of a participant) may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account, or installment payments. For termination of service due to other reasons, a participant may receive the value of vested interest in his or her account as a lump sum distribution, or installment payments. In-service distributions from a participant’s vested account balance may be made provided the participant has reached the age of 59½, has incurred a plan-defined hardship, or has become disabled.

Forfeited Accounts - Forfeitures of terminated participants’ non-vested accounts can be used to reduce future Plan Sponsor contributions or pay certain Plan administrative expenses. If a terminated employee is rehired by the Plan Sponsor, then the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan document. There were no forfeitures available as of December 31, 2024.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America (U.S. GAAP). Annual returns filed under applicable provisions of ERISA and the IRC are filed on the modified cash basis of accounting.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Benefit Payments – Participant contributions are recorded in the period the Company makes payroll deductions from the Plan participants’ earnings. Receivables for these contributions are unsecured. Benefit payments are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Note 3 – Investments**

The plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by The Trust Company of Tennessee, Inc. and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$4,708,855 as of December 31, 2024, and \$3,223,306 as of December 31, 2023
- b. Net investment earnings as shown in the accompanying statement of changes in net assets available for benefits of \$528,974 for the year ended December 31, 2024
- c. All investment-related information in the accompanying supplemental Schedule H, Line 4i — Schedule of Assets (Held at End of Year) as of December 31, 2024

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* All common/collective trusts, including the Invesco Stable Value Fund and Federated Hermes Capital Preservation Fund, which primarily hold investments in fully benefit-responsive contracts, are valued at the net asset value of units of the common/collective trusts as determined by the issuer of the trust based on the fair values of the underlying net assets divided by the number of units outstanding. The net asset value per unit is a quoted price in a market that is not active; therefore, these investments are classified within Level 2 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023:

**Note 5 – Income Tax Status**

The Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with its investment, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
