Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of CW Resources, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan and Trust were established January 1, 2010 to provide health and other benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Company makes monthly contributions for participating employees covered under the Plan. For employees covered under contracts issued by federal, state, municipal or other contracting authorities which require the payment of specified fringe dollar amounts, the Company contributes to the Plan based upon an hourly funding formula. Employer contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents. The provision of benefits that are funded from contributions by the employee, other than for separated participants, is not readily available information supplied to the third-party administrator and therefore, such employee contributions are included in Employer Contributions in the statement of changes in net assets available for benefits.

Benefits

The Plan provides major medical, prescription drug coverage, dental, vision, and short-term disability for eligible participants and their beneficiaries on a self-funded basis. The Plan carries a stop-loss insurance policy which covers aggregate claims in excess of the deductibles as specified in the contract. Other benefits such as limited medical, life, accident, employee assistance program, limited prescription drug coverage as provided by a pharmacy benefit manager, and health advocacy are provided for through various contracts with insurance companies. The Plan purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid to the insurance company directly from the assets of the Plan. Additionally, the Plan also provides eligible participants certain ancillary benefits such as health reimbursement arrangement (HRA) and dismissal wage/unemployment benefits limited by the participants' balance as determined by the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Plan maintains its demand deposits in commercial bank accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. There was no allowance for uncollectible accounts as of December 31, 2024 and 2023.

Payment of Benefits

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Benefits are recorded when paid.

Insurance Premiums Payable

Insurance premiums payable are based upon the actual premiums due for December 31, 2024 and 2023, but paid by the Plan after year-end.

Dismissal Wage/Unemployment Benefits

The Plan provides dismissal wage/unemployment benefits to eligible participants upon termination of employment. A participant's account balance is determined by employer contributions (based on the employee's class), interest income, an allocation of forfeitures and an administrative expense charge. Included in the accompanying statements of net assets available for benefits are amounts available to provide dismissal wages/unemployment benefits as of December 31, 2024 and 2023, totaling \$1,584,317 and \$1,455,122, respectively.

Health Reimbursement Arrangement

The Plan has a HRA that is funded solely through Company contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the employer. Included in the accompanying Statements of Net Assets Available for Benefits are amounts available to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023, totaling approximately \$226,000 and \$191,000, respectively.

Benefit Claims Incurred But Not Reported

The obligation for benefit claims incurred, but not reported is an estimate for self-funded benefits incurred on or prior to December 31, 2024 and 2023, but reported and paid by the Plan after year-end. The estimate was calculated using available claims experience data and projected future claims.

Administrative Expenses

All administrative expenses may be paid out of the Plan unless paid by the Company. During the year ended December 31, 2024, the Plan paid for substantially all administrative expenses, which consisted of administration fees, accounting fees, and other miscellaneous expenses.

Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code Section 512(e)(3)(E). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the Internal Revenue Code. The Plan administrator believes the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023, therefore, no tax liability is reflected in these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through August 20, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENT OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Money Market Funds and Certificates of Deposit: Valued at cost, which approximates fair value.

NOTE 4 TAX STATUS

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 PLAN TERMINATION

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan management or Plan administrator to the other at least 60 days prior to the anniversary date of effective coverage under the Plan.

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimate for claims incurred but not reported is based on certain assumptions pertaining to available claims experience data and projected future claims. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 7 STOP LOSS COVERAGE

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The Plan maintained an insurance policy with the Fidelity Security Life Insurance Company and United States Fire Insurance Company during the years ended December 31, 2024 and 2023, respectively. The policies provides reimbursement to the Plan for claim amounts paid in excess of \$125,000 for the years ended December 31, 2024 and 2023, per year for each participant.

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

During the year ended December 31, 2024, the Plan submitted evidence for stop loss recoveries of \$117,723, which are netted against medical and other benefit claims paid in the accompanying statement of changes in net assets available for benefits. The stop loss receivable totals \$229,128 and \$111,404 as of December 31, 2024 and 2023, respectively.
