NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Medpace Inc. 401(k) Profit Sharing Plan & Trust (the "Plan") are prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than generally accepted accounting principles. Under this method, employee deferrals and employer contributions are recorded when actually received by the Plan instead of when they are deducted or accrued by the employer.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. The cost of investments sold is computed on an average cost basis for all realized gains and losses. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans may be reclassified as distributions based upon the terms of the Plan document.

Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain Plan expenses are paid by Medpace Inc. (the "Company"), and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

Related-Party Transactions

T. Rowe Price Trust Company is the trustee and custodian, as defined by the Plan and, therefore, some transactions qualify as party-in-interest.

Certain administrative functions are performed by the officers or employees of the Company. The Plan is not charged by the Company for these services.

Subsequent Event Evaluation

In preparing its financial statements, the Plan has evaluated events subsequent to the balance sheet date through August 19, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering all employees who are regularly scheduled to work at least 1,000 hours per year, excluding leased employees, self-employed individuals, collectively bargained employees, and non-resident aliens, who have completed thirty (30) days of service and are 21 years of age. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended. Enrollment in the Plan is allowed on the first day of the month following the date the employee becomes eligible to participate.

Contributions

Participants may elect to contribute a specific percentage or dollar amount of compensation, as defined in the Plan document, on a pre-tax or after-tax Roth basis. However, contributions may not exceed limits established under Section 402(g) of the Internal Revenue Code ("IRC") of 1986, as amended (\$23,000 in 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to IRC limitations (\$7,500 in 2024).

The Company may make a discretionary matching contribution equal to a percentage of each participant's elective contributions. The discretionary matching percentage will be announced each Plan Year by the employer. For purposes of employer contributions, employees are eligible after reaching 21 years of age and after one (1) year of service and must be employed on the last day of the Plan year. The matching percentage for December 31, 2024 was 50% of the first 8% of compensation deferred. Additional contributions to the Plan are based solely on the discretion of the employer.

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Rollover Contributions

Participants may roll over amounts previously held for his or her account in another employee benefit plan to the Plan on a tax-free basis, and such amounts will be fully vested at all times. Rollover and transfer contributions share in Plan earnings based on the terms of the Plan; however, no Company contributions are made with respect to any rollover contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions, including rollovers, plus actual earnings thereon. Vesting in the Company's contribution, plus actual earnings thereon, is not graduated and occurs at 100% after three years of credited service, as defined by the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$129,301 and \$38,404 respectively. These accounts will be used to reduce future employer contributions or pay certain Plan expenses. During 2024, \$39,455 of forfeitures were used to offset the employer matching contribution made for the 2023 plan year.

Participant Loans

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Terms for loan repayment are within five years or less, although longer terms are allowable for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are repaid ratably through monthly payroll deductions.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed as a single lump-sum payment.

In-service distributions are permissible from all sources for participants that have attained the age of 59 1/2.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of their elective deferrals or rollover account necessary to meet the financial hardship, subject to the limitations of the Plan and the IRC.

NOTE 3 FAIR VALUE MEASUREMENTS

The financial statements have been prepared in accordance with the modified cash basis of accounting. Because there is no authoritative guidance for fair value measurements under the modified cash basis of accounting, these financial statements have been prepared using provisions of accounting for fair value measurements in accordance with accounting principles generally accepted in the United States (GAAP) by analogy. GAAP provisions for accounting for Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

Money market fund: Valued at the net asset value ("NAV") of shares held by the Plan at year end.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
