## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Hanover College 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. DESCRIPTION OF THE PLAN:

The following brief description of the Hanover College 403(b) Retirement Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution retirement plan pursuant to Internal Revenue Code (IRC) Section 403(b), covering all employees, except student employees, of Hanover College (College). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The College's retirement committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the College's Board of Trustees.

The Plan covers substantially all non-student employees of the College. An employee is eligible to contribute employee elective deferrals to the Plan on the first day of the month following their date of hire. Salaried employees become eligible to receive employer contributions the first day of the month following the date they attain age 21, while hourly employees become eligible to receive employer contributions the first day of the month following 90 days of employment and attainment of age 21. Employees are automatically enrolled into the Plan at 3% of compensation after 90 days of employment.

#### CONTRIBUTIONS

Each year, participants may contribute up to the maximum allowable contribution, as defined by the IRC. The College may, at its discretion, make a discretionary contribution on behalf of eligible participants equal to a specified percentage of the employee's compensation for the period. The total contribution to a participant's account for the Plan year cannot exceed the maximum limit determined by the IRC. The College made discretionary contributions equal to 4% of participants' compensation for eligible participants with five years or less of service, and 8% of participants' compensation for participants with more than five years of service.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, the College's discretionary contribution, allocations of Plan earnings or losses, and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed.

#### VESTING

Participants are vested immediately in all contributions plus actual earnings thereon.

1. DESCRIPTION OF THE PLAN, continued:

### INVESTMENT OPTIONS

Participants can direct their allocable balances into variable annuity contracts, fixed annuity contracts, pooled separate accounts and target-date mutual funds managed by Teacher's Insurance and Annuity Association - College Retirement Equities Fund (TIAA and CREF). Participants that do not make investment elections are automatically invested in the appropriate target-date mutual fund based on the individual's age.

### PLAN LOANS

Participants may apply for a Plan loan directly from TIAA. Plan loans from TIAA of \$0 and \$2,195 as of December 31, 2024 and 2023, respectively, are secured by the balance in the participant's account. The loans are not considered assets of the Plan and therefore are not included in notes receivable from participants on the statements of net assets available for benefits.

### NOTES RECEIVABLE FROM PARTICIPANTS

Participants may apply for a loan from their participant account. The total of the loans that a participant has outstanding is limited to the lesser of \$50,000 or 50 percent of the participant's account balance. Participant loans bear interest at a rate determined by the Plan administrator at the time of the loan. Each loan shall be amortized in level payments, not less frequently than quarterly, over a maximum of 5 years (with certain exceptions for loans used to acquire a principal residence). These participant loans are reported as notes receivable from participants on the statements of net assets available for benefits.

### PAYMENT OF BENEFITS

Upon termination of service due to severance, retirement, or death, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a single life annuity, joint and fifty percent survivor annuity, joint and seventy-five percent survivor annuity, fixed period annuity, installment payments, or single lump sum. If the vested account balance is less than \$1,000, the participant will receive a lump-sum distribution. In-service withdrawals from employee deferrals only are permitted for employees over age 59 1/2 or disabled employees.

2. SIGNIFICANT ACCOUNTING POLICIES:

### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

### USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SIGNIFICANT ACCOUNTING POLICIES, continued:

### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### PAYMENT OF BENEFITS

Benefits are recorded when paid.

### ADMINISTRATIVE EXPENSES

Administrative expenses in the statement of changes in net assets available for benefits include recordkeeping fees paid to third-party administrators, audit fees, and transactional fees. Plan servicing fees paid to TIAA and other parties during the year ended December 31, 2024, totaled \$34,244.

3. INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equity Fund (CREF) has certified the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule H, Line 4i-Schedule of Assets (Held at End of Year), as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024. TIAA, Trust N.A. is the custodian of the portion of Plan assets invested in mutual fund shares and has authorized TIAA to certify investments held by TIAA, Trust, N.A. TIAA and CREF are the issuers of the remaining assets in the Plan.

### 4. FAIR VALUE MEASUREMENTS:

The Plan uses appropriate valuation techniques to determine fair value based on inputs available. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs consist of unadjusted quoted market prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

4. FAIR VALUE MEASUREMENTS, continued:

The fair value of mutual funds is based on quoted prices in active markets for identical assets. Variable annuity contracts are valued at the net asset value (NAV) of units held by the Plan at year end based on the fair value of the underlying investments. NAV is a readily determinable fair value which is published daily and is the basis for current transactions. Non benefit-responsive fixed annuity contracts are not actively traded, and significant other observable inputs are not available. Therefore, the fair value of the fixed annuity contracts is determined using an income approach by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. These contracts have liquidity restrictions and are non-benefit responsive. The fair value of the pooled separate account units is principally derived from the market value of the underlying real estate holdings or other real estate-related investments.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY:

The Plan has fully benefit-responsive guaranteed investment contracts with TIAA. TIAA maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by TIAA represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of benefit-responsive guaranteed investment contracts at December 31, 2024 and 2023, was \$6,202,303 and \$6,772,876, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3%, except for the TIAA Stable Value contract, which has no minimum crediting interest rate. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity date. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations

6. PARTIES-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed by TIAA. TIAA is the issuer of some contracts and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. TIAA receives revenue from mutual fund service providers for services TIAA provides to the funds. This revenue is used to offset certain amounts owed to TIAA for its administrative services to the Plan and is reflected as other income of \$33,161 in the statement of changes in net assets available for benefits.

For the year ended December 31, 2024, direct fees of \$6,744 and indirect fees of \$298,115 were paid to TIAA for recordkeeping and investment management services. In addition, \$27,500 of direct fees were paid to other parties-in-interest for advisor services, professional services, and plan servicing. Direct fees are reflected as administrative fees in the statement of changes in net assets available for benefits. Indirect fees are recorded as a reduction of investment income in the statement of changes in net assets available for benefits.

7. PLAN TERMINATION:

Although it has not expressed any intent to do so, the College has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by TIAA. The prototype plan document has obtained an opinion letter from the Internal Revenue Service dated August 8, 2017, in which it states that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through September 11, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
