Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Oceana, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Oceana, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of Oceana, Inc. Retirement Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Oceana, Inc. Retirement Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2008. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Independent Auditors' Report (continued)

Further, as described in Note 2 to the financial statements, the Oceana, Inc. Retirement Plan has excluded from investments in the accompanying Statements of Net Assets Available for Benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying Statement of Changes in Net Assets Available for Benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Oceana, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements



Notes to Financial Statements

-
1. **Description of the Plan** The following description of the Oceana, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Oceana, Inc. (the "Organization"), except for nonresident aliens, students performing certain services, and an employee who is eligible to participate in another 401(k) or 403(b) plan maintained by the plan sponsor. Collective bargaining unit employees are allowed to participate in the Plan but are not eligible for employer contributions. Employees who normally work less than 20 hours per week are excluded for purposes of employee contributions. Effective January 1, 2024, the Plan was amended to permit part-time, temporary, or seasonal employees who work 1,000 hours or less to participate in the Plan, however these employees are not eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Organization contributes to the Plan 100% of each eligible participant's contributions that are not over 5% of compensation. Prior to January 1, 2024, participants must have reached age 18 and attained six months of service to be eligible to receive the employer matching contribution. Effective January 1, 2024, the Plan was amended to remove these age and service requirements. The Plan provides for an additional discretionary contribution that is determined by the Organization. The discretionary contribution was 7% of compensation during 2024. Participants who were at least 18 years of age and had attained six months of service were eligible to receive the additional discretionary employer contributions. Participants direct the investment of their contributions and Organization contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Notes to Financial Statements

Participant accounts: Each participant's account is credited with the participant's contributions, the Organization's matching contributions, the Organization's discretionary contributions, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits: Benefits are payable upon retirement at age 59 1/2, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum and installment payments.

Vesting: Participants are vested immediately in all contributions plus actual earnings thereon.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at a rate comparable to lending institutions. Principal and interest are paid through payroll deductions.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Organization. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Participants are also charged an asset based fee for recordkeeping. These fees are included in administrative expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

The Plan was established in 2001, with contracts at TIAA. Contributions are no longer permissible under those contracts. The Department of Labor (DOL) released Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* (FAB 2009-02) in 2009. If FAB 2009-02 is implemented, the DOL has indicated that they will not reject Form 5500s from which contracts are excluded as long as certain conditions are met. The Plan administrator has determined that certain of their known contracts meet the criteria of FAB 2009-02, and thus has excluded these TIAA contracts from the financial statements and Form 5500. If the identified known contracts, as reported by TIAA, were included, Net Assets Available for Benefits would increase by approximately \$1,785,000 and \$1,899,000 as of December 31, 2024 and 2023, respectively. Furthermore, investment gains of approximately \$277,000 and distributions of approximately \$392,000 related to such accounts have also been excluded in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. As such, the financial statements are not in conformity with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions: Participant contributions and the related Organization matching contributions are recognized in the period the participant contribution is withheld from compensation. The Organization's discretionary contributions are recognized when the related compensation is paid to the participant.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through September 10, 2025, which is the date the financial statements were available to be issued.

3. **Certified information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA, CREF, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodians of the Plan.

- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The unit values of the variable annuities and the pooled separate account are listed on NASDAQ. As a result, these assets have been reported based on Level 1 inputs.

The TIAA Traditional Non-Benefit Responsive Annuity Account is reported at contract value, which approximates fair value. The contract value equals the accumulated cash contributions and interest credited to the contract less any withdrawals. Contract value is deemed to approximate fair value based on observation of recent participant investments at contract value and by comparison of historical and current yields of highly rated corporate bonds to historical and current crediting interest rates of the contracts, taking into consideration the liquidity restrictions applicable to the contracts. See further discussion in Note 8. In determining the reasonableness of the valuation methodology, the Plan administrator evaluated a variety of factors including existing contracts, economic conditions and TIAA's overall credit rating.

- 5. Guaranteed investment contract** The Plan participates in a traditional benefit responsive investment contract with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Delaware") via an investment in a Guaranteed Investment Contract ("GIC"). Delaware commingles the assets of the GIC with other assets in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Delaware is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Delaware, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.
- There are no reserves against contract value for credit risk of the contract issuer or otherwise. No events limit the ability of the Plan to transact at contract value. There is a surrender charge of five percent for an employer-level liquidation of this contract unless the employer provides 12 months advance notice.
- 6. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Plan termination** Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

- 8. Insurance annuity account**
- The plan participates in the TIAA Traditional Annuity, an investment contract with TIAA. The contract is segregated into non-benefit and fully benefit responsive categories. TIAA commingles the assets of the contract with other assets in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Each premium allocated to the investment contract buys a guaranteed minimum amount of lifetime income, based on the rate schedule in effect at the time the premium is credited. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value. The contract has no maturity date and there is no market value adjustment upon discontinuance. TIAA has determined that fair value approximates the contract value of the investment.
- There are no reserves against contract value for credit risk of the contract issuer or otherwise. A portion of the annuity contract is non-benefit responsive as it requires withdrawals in the form of a lifetime payout annuity or in periodic installments over a 10-year period. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a purchase of annuity contract in the Statement of Changes in Net Assets Available for Benefits. In 2024, no such annuity contracts were purchased.
- 9. Party-in-interest transactions**
- Certain Plan investments are managed by affiliates of TIAA, CREF, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. These entities are the custodians and recordkeepers as defined by the Plan. The Plan pays expenses related to plan operations and investment activity to various service providers. These transactions qualify as exempt party-in-interest transactions.

The Plan is party to an agreement with Delaware that provides for a portion of the revenue earned by Delaware with respect to the services it provides for the Plan, including the recordkeeping fees paid from participant accounts, to be made available to the Plan in an ERISA budget account ("EBA") to pay expenses that are reasonable and directly benefit the Plan and its participants. For the year ended December 31, 2024, Delaware deposited approximately \$63,000 into the EBA. This amount has been netted against administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits. The Plan incurred approximately \$42,000 in investment advisory and accounting fees during the year ended December 31, 2024, which was paid from the EBA. Amounts due to the investment advisor of approximately \$2,700 are included in accrued expenses in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023. The balance in the EBA was \$26,652 and \$6,466 at December 31, 2024 and 2023, respectively, and is reported as amounts due under ERISA budget account in the Statements of Net Assets Available for Benefits.

During 2021, the Organization failed to remit to the custodians certain employee contributions and loan repayments totaling \$113 within the period prescribed by Department of Labor regulations. During 2023, the Organization failed to remit to the custodians certain employee contributions totaling \$333 within the period prescribed by Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions.

10. Tax status

Prior to January 1, 2024, the Plan was a prototype Non-standardized 403(b) plan of Principal Life Insurance Company which received an opinion letter on March 31, 2017, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Effective January 1, 2024, the Plan is a volume submitter 403(b) plan of Principal Life Insurance Company which received an opinion letter on March 31, 2017, in which the IRS stated this form of the plan document was acceptable under the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

11. Insufficient accounting records and supporting documents

The Plan assets held with TIAA are a collection of individual contracts with respect to which participants can engage in a range of investment actions without the consent or involvement of the Organization. Each Plan participant maintains his or her own personal contract relationship with the vendor, TIAA. Following adoption of the new 403(b) regulations in July 2007 (which became effective for the year ended December 31, 2009), the Organization undertook action to obtain prior year Plan account records. TIAA provided historical plan-level reports, but only for the year ended December 31, 2008. Accordingly, the Plan is unable to provide sufficient accounting records and supporting documents related to annuity and custodial accounts issued to current and former employees prior to January 1, 2008.
