We have performed audits of the financial statements of Somerset Trust Company 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Somerset Trust Company 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1: Description of the Plan

The following brief description of the Somerset Trust Company 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees, except excluded classes, of Somerset Trust Company (Bank). Employees must be employed on December 31 of the Plan year and have worked at least 1,000 hours within that calendar year to be eligible for bank contributions and any match. The Plan includes a 401(k) before-tax savings feature, which permits participants to defer compensation under Section 401(k) of the Internal Revenue Code (Code). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*, as amended. The Board of Directors of the Bank is responsible for oversight of the Plan. The Board determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Employees may also elect to contribute from their base salaries to the maximum amount permitted by the Code. Employees may elect to have their contributions invested into various mutual fund investment options offered by the Plan. The Plan Amendment approved December 1, 2023 moved the administration to Voya Retirement Insurance and Annuity Company, who now serves as the trustee of the Plan. For the year ended December 31, 2023, the Bank offered a fixed match on employee salary deferrals of 50% not to exceed 10% of the employee's annual compensation for that year. Effective January 1, 2024, the Plan was amended to change the discretionary employer match to 100% of up to 5% of employee elective salary deferrals.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Bank's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the employer contributions in the Plan is based on completion of credited service years. A credited service year is considered one in which the participant completed at least 1,000 hours of service. Employees become 100% vested after three years of service. Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of service, regardless of account balance, all distributions must be made in lump-sum form. Participants whose vested accounts do not exceed \$5,000 will receive a lump-sum distribution regardless if distribution is requested. Participants whose vested accounts exceed \$5,000 will receive the option for lump-sum distribution or to leave account within the plan.

On June 20, 2024, the Plan approved and operationally implemented to increase the threshold for determining distributions in cash or stock from \$5,000 to \$7,000 for involuntary distributions after December 31, 2023, but is still pending formal amendment to the Plan document.

Forfeited Accounts

At December 31, 2024 and 2023, there was no balance in the forfeiture nonvested account. Forfeitures are allocated to participants' accounts in the ratio of each participant's compensation in relation to compensation of all participants, used to reduce Plan expenses, or used to reduce the employer's matching contribution for the Plan year. As of May 25, 2017, the Plan was amended to permit forfeitures to be used to reduce any employer contributions, including Qualified Non-elective Contributions, Qualified Matching Contributions, and contributions pursuant to the ADP Safe Harbor Contributions. During 2024, the Plan utilized \$6,546 of forfeitures to pay Plan expenses. Any Plan language stating or implying that these contributions must be fully vested when made or when contributed was modified to provide that such contributions must be fully vested only at the time such contributions are allocated to participants. During 2024 and 2023, there were no forfeitures allocated to participant accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Uses of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined by the Trustees. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Bank are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

All expenses of maintaining the Plan are paid by the Bank.

Note 3: Certification of Plan Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Trust Department of Somerset Trust Company and Voya Retirement Insurance and Annuity Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income (loss) as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Plan Amendments

The Plan approved an amendment on January 12, 2023 that amends the base definition of eligible compensation. Effective January 1, 2023, the base definition will align with U.S. Code 3401(a) wages (wages for withholding purposes). The Plan approved an amendment on December 1, 2023 to remove nonparticipant directed investments from the Plan allowing Plan participants to control the investments of their entire account. The Plan was also amended to change the Plan custodian to Voya. Effective January 1, 2024, the Plan was amended to change the discretionary employer match to 100% of up to 5% of employee elective salary deferrals.

Note 5: Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Voya. Voya is a trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Bank for investment management services were \$71,128 in 2024

Note 6: Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy and include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. The Plan has no investments classified as Level 2. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no investments classified as Level 3.

Investments measured at net asset value per share and excluded from the fair value hierarchy are the Common Collective Trust in the amounts of \$24,000 and \$169,660 at December 31, 2024 and 2023, respectively. The fair value of this investment is measured using the net asset value per share practical expedient. The common collective trust held by the Plan requires 12 months' notice for a complete liquidation; however, the trustee, at its discretion, may waive the 12-month waiting period. There are no unfunded commitments associated with these investments. The primary investment objective of this investment is to either provide capital appreciation and income or capital appreciation and total return or income while minimizing principal volatility.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8: Tax Status

The design of the Plan is based on an underlying volume submitter plan, which has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying volume submitter document is qualified under Section 401(a) of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9: Reconciliation of Financial Statements to Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the IRS and the accompanying financial statements include classification differences.

Note 10: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11: Prohibited Transactions

During 2024 and 2023, there were no prohibited transactions on the Plan.

Note 12: Subsequent Events

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued.
