INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Glade Run Lutheran Services 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Glade Run Lutheran Services 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions at December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Glade Run Lutheran Services 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan, established effective January 1, 2005, and amended and restated most recently on January 1, 2022, is a defined contribution plan and covers substantially all employees of Glade Run Lutheran Services (the "Sponsor") who have attained the age of 21 and have completed at least one year of service. Employees are eligible to participate on the first day of the quarter coinciding with or next following the date after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in assets during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are carried at their fair values based on published quotations or, in the absence of readily ascertainable market values, at such values as the custodian determines. The unrealized appreciation (depreciation) of investments is determined by the change in current market value from the beginning of the year (if held for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized appreciation (depreciation) of investments is determined by the change in the current market value from the beginning of the year (if held since the beginning of the year) to the date of sale, or from the date of purchase to the date of sale. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis.

Contributions - Participants may elect to contribute to the Plan up to the limit established by the Internal Revenue Service. Employee contributions are recorded in the period during which payroll deductions from the Plan participants' earnings are effected. The Plan includes an automatic salary deferral feature, under which 2% of each employee's eligible compensation is automatically withheld and contributed to the Plan, unless the employee has elected to defer either a different amount or no

amount at all. Participants may direct their contributions into various diversified investment options.

The Plan provides for an employer matching contribution, equal to a discretionary percentage of the employee's percentage of salary deferrals, which will be determined each year. For the period January 1, 2023 through June 30, 2024, the matching contribution was 50% of the first 3% of employee compensation contributed. For the period July 1, 2024 through December 31, 2024, the matching contribution was 100% of the first 3% of employee compensation contributed.

Participant Rollovers - Participant rollovers represent nonforfeitable transfers from other qualified plans.

Participant Accounts - Each participant's account is credited with the participant's contribution, the employer matching contribution, if applicable, and plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefits - Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The form of payment is a lump-sum distribution.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting of employer contributions and earnings thereon is according to the following schedule:

Less than 1	0%
1 but less than 2	33.3%
2 but less than 3	66.6%
3 or more	100%

Forfeitures - Forfeitures represent the portion of non-vested account balances remaining in the Plan for all terminated employees. Forfeiture balances are reallocated on the earlier of the distribution date of the employee's entire vested account balance or at the end of the fifth year in which a participant reaches their fifth consecutive one-year break-in-service. Forfeitures will serve to reduce future employer contributions. Forfeitures were not significant during 2024 and 2023.

Administrative Expenses - Contract administration fees were paid by the Plan to John Hancock Life Insurance Company for the period January 1, 2024 to May 10, 2024 and to John Hancock Trust Company LLC for the period May 11, 2024 to December 31, 2024, while general administrative expenses are assumed by the Sponsor as provided by the plan agreement.

Fair Value Measurements - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodology used at December 31, 2024 and 2023.

Mutual Funds: Each mutual fund is valued using a quoted price in an active market (Level 1 measurement).

Collective Investment Trusts (CITs): Each CIT invests in a collective investment trust as well as a variety of separate accounts and mutual funds. The collective trust fund and the separate accounts are not value using publicly quoted pricing inputs; the mutual funds are valued using publicly quoted pricing inputs. The fair values of all of these investments are used to determine the net asset value (NAV) of each CIT. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and each CIT can be redeemed at NAV as of the measurement date. Therefore, each CIT has a readily determinable fair value (Level 1 measurement).

Pooled Separate Accounts (PSAs): Each PSA invests mainly in domestic stocks, which are valued using publicly quoted pricing inputs. The fair values of all of these stocks are used to determine the NAV of each PSA. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and each PSA can be redeemed at NAV as of the measurement date. Therefore, each PSA has a readily determinable fair value (Level 1 measurement).

These methods may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

Subsequent Events - Management has evaluated subsequent events through September 11, 2025, the date upon which the financial statements were available to be issued.

2. CERTIFIED FINANCIAL INFORMATION

John Hancock Life Insurance Company, the custodian from January 1, 2023 to May 10, 2024, and John Hancock Trust Company LLC, the

custodian from May 11, 2024 to December 31, 2024, have certified that the following data included in the accompanying financial statements is complete and accurate.

- Investments, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying schedule.

3. PARTIES-IN-INTEREST AND RELATED PARTIES

The custodians provide access to certain investments and, accordingly, are considered parties-in-interest.

Neither the Sponsor nor employees involved in the administration of the Plan receive any compensation from the Plan.

4. PLAN TERMINATION

The Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested, and the net assets of the Plan will be distributed by the custodian in accordance with the trust agreement in a uniform and nondiscriminatory manner.

5. INCOME TAX STATUS

The Plan is a non-standardized, pre-approved plan for which the sponsoring organization has obtained a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes that the Plan is qualified.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for years before December 31, 2021.
