## Notes to Financial Statements

December 31, 2024 and 2023

### 1. Description of Plan

The following description of Lamprey Health Care 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a tax-exempt, defined contribution retirement plan sponsored by Lamprey Health Care, Inc. (the Organization). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Principal Trust Company (the custodian) is the custodian and recordkeeper of the Plan.

#### Eligibility

The Plan is available to all Organization employees, excluding student employees and nonresident aliens. Employees are eligible to make salary deferrals to the Plan upon hire. There is no year of service or age requirement and employees are immediately eligible for the employer matching contribution.

#### Vesting and Forfeitures

Effective January 1, 2019, the vesting schedule for employer contributions changed from immediate to a five-year graded vesting schedule. Any participants that were in the Plan prior to January 1, 2019 will remain immediately vested. All employee deferrals are immediately vested.

Forfeited balances may be applied to offset employer contributions or cover administrative expenses. As of December 31, 2024 and 2023, available forfeited balances totaled \$36,230 and \$16,118, respectively. During the year ended December 31, 2024, \$16,537 in forfeitures was used to reduce employer contributions and \$7,408 was applied toward administrative expenses.

#### Contributions

Each year, eligible participants may make contributions to the Plan through salary deferrals up to 100% of eligible compensation, as defined in the Plan. New hires are automatically enrolled at 4% of eligible compensation. The Plan has an automatic salary deferral increase. Participant deferrals will by 1% annually on January 1st until a maximum deferral rate of 8% is reached. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (the Code).

The Plan provides for a matching employer contribution. The Organization has elected to make a matching contribution equal to \$0.50 per dollar of employee deferrals up to 8% of the eligible participant's election, with a maximum employer contribution rate of 4%.

### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's and employer's contribution and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses, and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Notes Receivable from Participants**

Participants may borrow up to \$50,000, subject to certain limitations and vested account balance, as set forth in the Plan document.

### **Investments**

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan currently offers investments in shares of a group annuity contract and mutual funds.

### **Payment of Benefits**

Participants shall become eligible to receive their vested account balances upon retirement (the normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump sum payment or a monthly annuity. In addition, participants may withdraw their pre-tax contributions upon demonstration to the plan administrator that they are suffering a hardship, as defined in Section 403(b) of the Code.

## 2. **Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

### **Investments**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Administrative Expenses**

Substantially all administrative expenses are paid by the Plan. Fees paid for accounting services amounted to \$18,500 for the year ended December 31, 2024 and are reported as administrative expenses on the statement of changes in net assets available for benefits.

### **Subsequent Events**

Management has considered transactions or events occurring through August 25, 2025, the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Group Annuity Contract**

The Plan has a benefit-responsive group annuity contract with Principal Life Insurance Company (Principal Life) through Principal Trust Company. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The group annuity contract is fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to currently transact at contract value and may result in a deferral of the payment at contract value for up to 12 months. Such events include but may not be limited to the following: (1) removal of a group of participants from Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan; (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (3) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business; (4) removal from the Plan of one or more groups of classifications of participants; (5) partial or complete Plan termination; or (6) Plan disqualification.

#### 4. Income Tax Status

The Plan is a volume submitter plan sponsored by the Principal Trust Company. The volume submitted plan obtained its latest advisory letter on March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### 5. Information Prepared and Certified by the Custodian

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by the custodian as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

#### 6. Party-in-Interest

The group annuity contract is also managed by Principal Trust Company; therefore, these transactions qualify as party-in-interest transactions. Fees paid to the custodian amounted to \$57,070 and are reported as administrative expenses on the statement of changes in net assets available for benefits.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan document to terminate the Plan at any time subject to the provisions of ERISA.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Fair Value Measurement

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued using market quotations.
