Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **PES 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **PES 401(k) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES to FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION of PLAN

The following description of **PES 401(k) Plan** (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution 401(k) plan covering substantially all eligible employees of Paradise Energy Solutions, LLC (Plan Sponsor), Sunstream Energy LLC, Gap Bros. Holding LLC, and Upward Broadband LLC (members of the controlled group and collectively the Company), who have attained the age of 18. Enrollment is allowed on the first day of the month coinciding with or next following date eligibility requirements are met. The Plan automatically enrolls all newly eligible employees in the Plan with their deferral rate set at 6% of eligible compensation. The Plan was established effective January 1, 2017, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees that are considered to be leased employees are not eligible to participate in the Plan.

The Plan Sponsor is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan is following regulatory changes related to the Coronavirus Aid, Relief, and Economic Security (CARES) Act and the Setting Every Community Up for Retirement Enhancement (SECURE) Act, but has not been formerly amended for these changes. The Plan has until December 31, 2026 to formally amend the Plan for these regulations.

Contributions

Each year, participants may contribute up to the maximum amount allowable under applicable federal regulations. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other defined benefit or contribution plans. The Plan allows participants to direct the investment of their contributions into any of the available investment funds. The Plan allows Roth and pre-tax deferrals. The Company contributes a safe harbor matching contribution that is equal to 100% of the employee's contribution not in excess of 1% of the employee's compensation, and 50% of the employee's contribution that exceeds 1% of the employee's contribution, up to a maximum of 6% of the employee's compensation. The Company may also make a discretionary profit-sharing contribution to an employee's retirement accounts. This profit-sharing contribution is only for eligible employees who have completed at least 1,000 hours of service during the Plan year, and those who are employed by the Company on the last day of the Plan year. There was no discretionary profit-sharing contribution made by the Company in 2024 and 2023. The Company's safe harbor matching and discretionary contributions are invested as directed by the participant into the same investment options offered by the Plan.

Participant Accounts

A record-keeping account is set up in each participant's name to show the value of his/her retirement benefit. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings (losses), and charged with allocations of (c) forfeitures and (d) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's Safe Harbor matching contribution and Profit-Sharing contribution portions of their accounts are based on years of service. Participants are vested in the Company's safe harbor matching contribution and Profit-Sharing contribution and related earnings as follows:

Payment of Benefits

A participant shall be entitled to receive the balance held in his or her account upon termination of employment, death, disability, or attainment of normal retirement age. Normal retirement age is 65. Participant benefits will be paid in a lump sum as agreed upon by the participant and the Plan Administrator. Partial withdrawals or installment payments are permitted for payments made for purposes of required minimum distributions to participants who are 73 for the years ended December 31, 2024 and 2023. The Plan Administrator may automatically roll any terminated participant accounts with a balance of \$5,000 or less into an individual retirement account established on behalf of the terminated participant. If an account balance is less than \$1,000 and the participant has terminated employment, the Plan will distribute the value of the account to the terminated participant in cash. Effective December 20, 2024, the Plan adopted one of the SECURE Act 2.0 provisions to increase the maximum force-out limit to \$7,000.

A participant may request a hardship withdrawal from their fully vested account balances related to employee deferrals and rollover contributions.

In-service withdrawals are permitted for participants who have attained the age of 59½.

Each participant designates a person or persons who are to receive benefits under the Plan in the event of their death.

Forfeited Accounts

Forfeitures may be used to pay Plan expenses or reduce employer matching or discretionary contributions. At December 31, 2024 and 2023, forfeited nonvested accounts were \$8,772 and \$5,602, respectively. Forfeitures of \$15,338 and \$12,344 were used to pay Plan expenses for the years ended December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loans must be repaid within five years unless proceeds are used to purchase a principal residence in which case the Plan Administrator may permit a longer repayment term. All loans bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The rates of interest on outstanding loans at December 31, 2024 and 2023, ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions from each regular paycheck. A maximum of two loans can be outstanding at a time per participant.

NOTE 2 - SUMMARY of SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis in accordance with accounting principles generally accepted in the United States of America (US GAAP). Current US GAAP standards are contained in the Accounting Standards Codification (ASC) as set forth by the Financial Accounting Standards Board (FASB).

Investments held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends and capital gain distributions are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded based upon the terms of the Plan Document for purposes of Form 5500 reporting. However, for purposes of the financial statement, for active participants who have not incurred a distributable event (employment termination, death, or disability), but have delinquent loans, the participant loan remains outstanding until a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. The balance of administrative costs is paid by the Plan and allocated to Plan participants. Administrative fees consist of recordkeeping fees and fees charged on loans and distributions.

NOTE 3 - CERTIFIED PLAN INVESTMENTS

Certified Investments

The information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends and capital gain distributions for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Matrix Trust Company, the trustee of the Plan. The Plan Management has obtained certifications from the trustee that such information is complete and accurate.

For the years ended December 31, 2024 and 2023, the Plan's investments including investments bought, sold, and held during the year appreciated in value by \$761,230 and \$768,324, respectively. NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a framework that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Plan which received an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Non-Standardized Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and trust tax-exempt.

US GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

The Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - RELATED PARTY and PARTY-in-INTEREST TRANSACTIONS

As previously discussed, the Plan issued loans to participants that are secured by participant account balances. Participant loans totaled \$82,439 and \$72,879 at December 31, 2024 and 2023, respectively. Interest income from participant loans was \$5,484 and \$4,128 for the years ended December 31, 2024 and 2023, respectively. All of these transactions qualify as party-in-interest transactions.

The Plan pays for certain administrative fees charged by Employee Fiduciary, LLC, which is considered a party-in-interest to the Plan. These fees do not constitute prohibited transactions and amounted to \$17,038 and \$13,744, for the years ended December 31, 2024 and 2023, respectively.

NOTE 8 - RISKS and UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan Sponsor amended the Plan to add Ambassador Towers as a member of the controlled group. It was also amended to change the force-out amount so balances over \$-0-, but less than \$5,000, are rolled into an IRA.

Effective March 23, 2025, the Plan Sponsor amended the Plan to add Optimal Services LLC as a member of the controlled group.

Subsequent events were evaluated through September 11, 2025, which represents the date the financial statements were available to be issued.
