Notes to Financial Statements

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Ion Financial, MHC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is sponsored by Ion Financial, MHC (the "Company") for the purpose of providing employees of the Company and its subsidiaries with retirement benefits. The Plan is a defined contribution retirement plan, covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

To be eligible to participate in the Plan, an employee must be at least eighteen years of age. Employees may enroll in the Plan on the first day of each calendar quarter immediately following the date this eligibility requirement is met.

Contributions

The Plan permits both employee and employer contributions. Participants may contribute between 2% and 40% of annual pre-tax compensation, as defined by the Plan, subject to certain limitations. Employees may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollovers"), as further described in the Plan document. The Company may contribute to the Plan a discretionary matching contribution of \$0.50 for each \$1.00 of participant contribution up to 6% of eligible pre-tax compensation contributed by participants. The Company may also contribute to the Plan discretionary and/or profit sharing contributions, provided the Company has net profit for the Plan year, and any qualified contribution necessary to ensure that the Plan complies with the nondiscrimination regulations of certain sections of the Internal Revenue Code (the "IRC") and ERISA. For the Plan year ended December 31, 2024, the Company made the matching contribution and the additional discretionary Company contribution which was 5% of the participants' annual base salary.

The Plan includes an automatic salary deferral feature which states that if a participant does not make their own deferral election, the Company will automatically withhold 6% of the participant's compensation per pay period. In addition, a participant's automatic deferral will increase by 1% each year for a maximum of 12%. If a participant makes an "Affirmative Election," he or she is not subject to automatic deferral and automatic escalation.

Participants may direct the investment of their contributions, as well as contributions made on their behalf by the Company, in the VOYA Fixed Account, various mutual funds offered by VOYA Retirement Insurance and Annuity Company ("VOYA"), the Plan Custodian, as well as certain other companies' mutual funds allowed by the Plan. Participants may change their investment options at any time. There are no non-participant directed funds.

Participant Accounts

Each participant's account is credited with the participant's contribution, any contributed amounts from other qualified defined benefit or contribution plans, and allocations of the Company's contributions and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Fees associated with participant loans are charged to the individual participant's account.

Notes to Financial Statements

Vesting

Participants are 100% vested in their contributions plus actual earnings thereon. Participants become fully vested in their share of the Company's discretionary matching contributions either upon maintaining active employment status on the last day of the Plan year, upon the attainment of normal retirement age (age 65) during the Plan year or upon death or disability while employed during the Plan year.

Forfeitures

If a participant terminates employment with the Company at a time when the participant does not have a fully vested interest, and liquidates his or her account prior to December 31, the Company's discretionary matching contributions and the actual earnings thereon are forfeited. Forfeitures are retained in the Plan and are used to reduce future employer contributions. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$2 and \$1,953, respectively. Employer discretionary matching contributions were reduced by forfeitures of \$1,953 during 2024.

Payment of Benefits

Upon attainment of normal retirement age, termination of service, or termination of service due to death or disability, participants may elect to receive benefit payments under the Plan. Partial or lump-sum benefit payments can be made in accordance with the Plan document, equal to the participant's vested account balance. If a participant's account balance is less than \$5,000, distributions due to termination may be made without the authorization of the participant.

In-Service Distributions

The Plan permits payment of benefits to participants while employed by the Company in the case of an immediate and heavy financial hardship, such as medical or education expenses, or to purchase a primary residence. In the case of financial hardship, payment is limited to the amount of the participant's individual account balance attributable to elective salary deferrals and the amount of actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, subject to certain restrictions, as described in the Plan document. Notes receivable from participants are evidenced by promissory notes for the amount of the note and are collateralized by the participant's vested account balance for terms of up to five years, or greater if used for the purchase of a primary residence. Notes receivable from participants bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The interest rates in effect during 2024 ranged from 4.25% to 9.50%.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Subsequent Events

The Plan monitored and evaluated subsequent events for footnote disclosures or adjustment required in its financial statements for the year ended December 31, 2024 through August 21, 2025, the date on which financial statements were available to be issued. On May 13, 2024 the Company entered into a definitive agreement to merge with NVE Bancorp, MHC. The transaction closed on April 28, 2025. The NVE 401(k) plan will not be merged, consolidated or otherwise combined with the Plan.

Notes to Financial Statements

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Employer Contribution Receivable

The Company may contribute discretionary matching contributions, provided the Company has net profit for the Plan year. Furthermore, any employer contributions which are allocable to the participant accounts shall be paid to the Plan no later than the twelve-month period immediately following the Plan year. The 2024 employer discretionary and matching contributions were recorded as a receivable of the Plan at December 31, 2024 and 2023 and were paid to the Plan in January 2025 and 2024, respectively.

Expenses

All administrative expenses related to the Plan are paid by the Company. Transaction charges (for loan and benefit payment transactions) are paid by the Plan by reducing the balances of those participants initiating the transactions. Investment fees related to the Plan are netted against dividend and interest income.

Payment of Benefits

Benefit payments are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the dates of the financial statements and the changes in net assets available for plan benefits during the reporting periods, and when applicable, disclosures of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenues and expenses during the reporting periods. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides for various investment options in any combination of insurance company guaranteed interest accounts and mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Notes to Financial Statements

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Mutual Funds: The fair value of mutual funds is based on the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded and all mutual funds are classified as Level 1 within the fair value hierarchy.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The contributions to the VOYA Fixed Account are held in VOYA's general account. The crediting interest rate for the VOYA Fixed Account may not be less than 1% per annum, is periodically reviewed for resetting, and can be adjusted annually. The crediting interest rate is subject to change based on the claims paying ability of VOYA. The VOYA Fixed Account is credited with earnings on the underlying investments and charged for participant withdrawals. The average yield on the VOYA Fixed Account was 2.75% and 2.00% in 2024 and 2023, respectively. VOYA's credit rating was A+ as of December 31, 2024 and 2023.

Notes to Financial Statements

The VOYA Fixed Account is included in the financial statements at contract value as reported to the Plan by VOYA, as the contract is considered fully benefit-responsive. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may direct the withdrawal or transfer of all or a portion of their investment in the fixed account at contract value.

NOTE 5 - INCOME TAX STATUS

The Plan is a Volume Submitter 401(k) plan. The Plan received an opinion letter dated June 30, 2020, and is designed to constitute a qualified tax-exempt plan under section 401(a) of the Internal Revenue Code (the "IRC"). As such, the Plan is exempt from Federal income tax, and amounts contributed by the Company will not be taxed to the participant until the participant receives a qualifying distribution from the Plan. The sponsor of the volume submitter plan has received an opinion letter from the IRS that the form of the volume submitter plan is acceptable under the applicable provisions of the IRC. Management believes that the plan is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - CERTIFIED INVESTMENTS

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by VOYA, the custodian of the Plan.

NOTE 7 - RELATED PARTY AND PARTIES IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds which invest in registered investment companies managed by VOYA, the Custodian of the Plan. These qualify as party-in-interest transactions. Administrative fees paid for services rendered by parties in interest were based on customary and reasonable rates for such services. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

Participants of the Plan are allowed to take notes collateralized against their account balances.

Notes to Financial Statements

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will immediately become 100% vested in their account.

NOTE 9 - RECONCILIATION OF PLAN FINANCIAL STATEMENTS TO THE FORM 5500

The Annual Return/Report of Employee Benefit Plan (the "Form 5500") has reported employer contributions on the cash basis; in accordance with GAAP, the Plan has reported employer contributions on the accrual basis. Accordingly, certain balances included on Schedule H, Line 4i - Schedule of Assets (Held at End of Year) in the Form 5500 differ from those included in these financial statements.
