### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Nationwide Truck Brokers, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 20, 2025 and June 30, 2024, and the related statement of changes in net assets available for benefits for the short year ended June 20, 2025 and year ended June 30, 2024, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was a defined contribution plan covering all employees of Nationwide Truck Brokers, Inc. (the Company) who had attained six months of service as defined by the Plan and were at least 18 years of age. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On May 28, 2024, the merger of this Plan into Ruan Employees 401(k) Savings Plan (Ruan Plan) was approved, effective July 1, 2024. All assets were subsequently transferred from the Plan into the Ruan Plan on September 3, 2024, with the exception of a minimal forfeiture balance that was transferred June 20, 2025.

**Participant and Employer Contributions**

Contributions to the Plan were made as follows:

**Participants**

Each year, participants could contribute up to 90% of compensation up to the statutory limit, as defined by the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants could direct the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds and a guaranteed investment contract as investment options for participants.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan, unless they affirmatively elected not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions were automatically invested in a designated balanced fund until changed by the participant.

Unless an automatically-enrolled participant elected otherwise after receiving appropriate notice, contributions made on their behalf would be increased annually by 1% capped at an annual maximum of 5% of eligible compensation. Any participant could affirmatively elect to have their contributions automatically increased by a specified percentage or flat-rate amount at a specified interval (quarterly, semi-annually, or annually).

**Employer Matching Contributions**

The Company could make a discretionary matching contribution to the Plan on behalf of each participant that contributed to the Plan. For the short year ended June 20, 2025 and year ended June 30, 2024, the contributions were equal to 10% of the first 5% of compensation that a participant contributed to the Plan.

**Participant Accounts**

Each participant's account was credited with the participant's contribution, the Company's matching contribution, as well as allocations of Plan earnings and was charged with an allocation of any administrative expenses paid by the Plan. Allocations were based on investment earnings on account balances, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

**Vesting**

Participants were 100% vested in compensation deferrals and employer matching contributions plus earnings thereon at all times.

**Notes Receivable from Participants**

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes were secured by the balance in the participant's account. The notes had various maturities and annual interest rates, which were commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest were paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of services, a participant could elect to receive their vested interest as a lump sum payment or could choose from various other payment and annuity options. In-service and hardship distributions were permitted pursuant to the terms of the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were charged directly to the borrowing participant's account and were included in administrative expenses when incurred. As of June 30, 2025, and June 30, 2024, no allowance for credit losses has been recorded. If a participant did not make loan repayments and the plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the plan document.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits were recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan were paid by the Company and are therefore excluded from these financial statements. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

**Date of Management's Review of Subsequent Events**

Management has evaluated subsequent transactions and events through September 8, 2025, the date these financial statements were available to be issued, and has determined that no items require additional disclosure, except for the merger as described in Note 1.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the short year ended June 20, 2025 and year ended June 30, 2024, are reported in the net appreciation in fair value of investments.

**NOTE 4 – GUARANTEED INVESTMENT CONTRACT**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Lincoln Financial Group Trust Company. Lincoln Financial Group Trust Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Lincoln Financial Group Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at June 30, 2025 and June 30, 2024, was \$-0- and \$873,257, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.70%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Lincoln Financial Group Trust Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events limited the Plan's ability to transact at contract value with plan participants or the issuer.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments were shares of mutual funds managed by Lincoln Financial Group Trust Company. Lincoln Financial Group Trust Company was the trustee as defined by the Plan, therefore, these transactions qualified as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in administrative expenses.

Certain fees incurred by the Plan for investment advisory services are netted within net appreciation in fair value of investments, as they were paid through revenue sharing, rather than as a direct payment from the Plan. The services were provided by Global Retirement Partners, who was the Plan's investment advisor, therefore, these transactions qualified as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 – TAX STATUS**

The Plan had adopted Lincoln's Pre-Approved Profit Sharing Plan. The Internal Revenue Service (IRS) had determined that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) by a letter dated June 30, 2020. The plan administrator believes that the Plan was designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan was qualified and the related trust was tax-exempt.

**NOTE 6 – TAX STATUS – Continued**

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to June 30, 2022.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities would occur in the near term and such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
