### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of LGI Homes, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024

#### NOTE 1 - DESCRIPTION OF PLAN

The LGI Homes, Inc. 401(k) Plan (the "Plan") was adopted on May 30, 2015. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of LGI Homes Inc. (the "Company") who have three months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The investment committee for the Plan Sponsor meets on a quarterly basis to review the appropriateness of the Plan's investment offerings, monitors investment performance, and initiates any changes in Plan investments.

**Amendments:** An amendment to the plan was executed with an effective date of January 1, 2024, which provided for an adjustment to the calculation of plan compensation. This adjustment provides the following compensation exclusions: reimbursements or other expense allowances, unused leave and the value of restricted stock or stock option granted to an employee.

**Contributions:** Participants may make an elective deferral, for each Plan year, in an amount equal to the maximum amount allowable not to exceed the limits of Code Sections 401(k), 404 and 415. In addition, participants over age 50 were allowed to contribute an additional \$7,500 for 2024. For 2024 the Company made discretionary matching contributions up to 4% of each employee's eligible compensation. Total matching contribution for 2024 was \$4,565,262 The Company matching contribution for 2025 will be 4%.

**Participant Accounts:** Each Participant's account is credited with the Participant's contribution and an allocation of the Company's contribution and Plan earnings. Allocations are based on Participant earnings or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

**Investment Options:** Upon enrollment in the Plan, the Participant is given a summary of the various investment options available under the Plan. The Participant then directs their contributions and any matching Employer contribution, to the various investments of their choosing. Changes in investments in the Participant's account are made directly by the Participant with Fidelity Management Trust Company, the Trustee of the Plan.

**Participant Notes Receivable:** Participants may borrow from their fund accounts an amount equal to the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. The terms of the loans shall not exceed five years unless for the purchase of a primary residence. The loans are secured by the balance in the Participant's account and bear interest at a rate commensurate with rates charged by representative commercial banks, currently 9.50% - 10.50%. Principal and interest payments are submitted by the Participants directly through Fidelity.

**Vesting:** Participants are immediately vested in their voluntary contributions. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants are 100% vested in Company matching contributions after five years of credited service.

**Payment of Benefits:** On termination of service due to death, disability or retirement, a Participant may elect to receive an amount equal to the value of the Participant's vested interest in his or her account in a lump-sum amount, installments over a period of not more than the assumed life expectancy, or the purchase of a different form of annuity. For termination of service due to other reasons, a Participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Administrative Expenses:** Expenses paid by the Plan for 2024 total \$203,679.

**Forfeited Accounts:** On December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32,537 and \$13,435, respectively. These amounts are used to reduce future employer contributions and plan expenses.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

**Date of Management's Review:** Subsequent events were evaluated through August 18, 2025, which is the date the financial statements were available to be issued.

**Basis of Accounting:** The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of Benefits:** Benefits are recorded when paid.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

**Mutual Funds**

The fair value of mutual funds and managed income portfolio funds is based on quoted net asset values of the shares held by the Plan at year-end as certified to by the trustee.

**Stable Value Fund**

A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**NOTE 4 - INVESTMENTS CONTRACTS WITH TRUST COMPANY**

The Plan's investments are held by Fidelity Management Trust Company (FMTC). All Participant accounts are participant-directed as to both Employer and Employee contributions. FMTC maintains the contributions in mutual funds. The accounts are credited with actual earnings on the underlying investments and charged for Plan withdrawals. The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been certified to as complete and accurate by FMTC. The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in New Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by FMTC, the Trustee, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$90,961,637 and \$76,584,597 on December 31, 2024 and 2023, respectively, and related increase to net assets of \$14,377,040 for the year ended December 31, 2024.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service has determined and informed the Plans administrator by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and the related Trust is tax exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by FMTC. FMTC is the trustee as defined by the Plan and, therefore these transactions qualify as party-in-interest transactions. The Plan also has notes receivable from participants on December 31, 2024 and 2023. These notes and all transactions relating to these notes are parties-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants are 100% vested in their accounts.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risk include global events, which could impact the value of investments and securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
