1. DESCRIPTION OF THE PLAN

The following description of the Wrist North America, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution plan pursuant to Sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”). The Plan was adopted effective January 1, 2010, with its latest amendment and restatement effective January 1, 2022, by Wrist North America, Inc. (the “Company” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

All of the Company’s employees who are not union or nonresident aliens are eligible to participate in the Plan. Employees are eligible after attaining 21 years of age. Employees can elect to contribute to the Plan immediately upon meeting the eligibility requirement. Employees must complete one year of eligibility service before they become eligible for the employer match contributions or non-elective contributions.

Plan Custodians

Empower Annuity Insurance Company of America and Empower Trust Company, LLC (“Custodians”) are the custodians of the Plan.

Contributions

Participants can contribute pre-tax and after-tax Roth contributions to the Plan subject to certain limitations established by the IRC.

The Plan is a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company matches 100% of participant contributions up to 3% of the participant’s eligible compensation, plus 50% of deferrals up to the next 2% of eligible compensation. The safe harbor employer match contribution is computed based on each payroll period. The Company may also make a non-elective contribution to the Plan. There were no non-elective contributions made during 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, employer contributions, an allocation of Plan earnings or losses, and administrative expenses. These allocations are based on the participant’s eligible compensation, as defined, and account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Investment Options

Upon enrollment in the Plan, participants may direct their contributions into any of the investment options offered by the Plan. Participants can change their investment allocation among the various investment options either through direct transfer from one option to another or by changing the percentage allocation of future contributions.

Vesting

Participants are immediately vested in their contributions, safe harbor employer match contributions, and the actual earnings thereon. Employer non-elective contributions vest based on a 6 year graded vesting schedule. Participants or their beneficiaries shall be immediately vested in their accounts upon death, retirement, or total and permanent disability.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000, reduced by the highest outstanding note receivable balance in the participant's account during the prior 12-month period, or 50% of the vested balance of their accounts, without penalty, subject to IRC regulations. The minimum amount that a participant may borrow is \$1,000, with only one note outstanding at any time. Note terms are not to exceed five years, unless the note is used to acquire a principal residence, in which case, the Plan administrator may permit a longer repayment term. The notes are secured by the balance in the participant's account and bear a rate of interest equal to the prime interest rate plus one percent.

Participant Withdrawals

Upon termination of services due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount or installment payments. If the value of the participant's account is less than \$1,000, the payment will be made in cash in a single lump-sum. If the participant's account balance is more than \$1,000 but less than \$5,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant.

Any taxable distribution paid directly to the participant will be subject to mandatory federal income tax withholding of 10% or 20% of the requested distribution.

Forfeitures

The Plan provides that nonvested portions of Employer contributions that are forfeited by terminated participants may be applied, at the Company's discretion, to Plan expenses, reallocated to participants or used to reduce future Employer contributions. No forfeitures were used to reduce employer contributions for the year ended December 31, 2024. Total forfeitures available for use by the Plan were \$2,029 and \$2,000 as of December 31, 2024 and 2023, respectively.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract with is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Other income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions, based upon the terms of the plan document, upon liquidation of their account balance.

Participant Withdrawals

Participant withdrawals are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three level of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar asset or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liabilities has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. INVESTMENT WITH INSURANCE COMPANY

The fixed income account holds a benefit-responsive investment contract (the "Contract") with Empower Annuity Insurance Company of America ("Empower"), formerly Great-West Life & Annuity Insurance Company. Empower maintains the contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent.

Because the Contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Contract. Contract value, as reported to the Plan by Empower, represents contributions made under the Contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value.

5. TAX STATUS

The non-standardized pre-approved profit sharing plan with CODA adopted by the Company received its latest opinion letter, dated June 30, 2020, which the Internal Revenue Service (“IRS”) stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter, however, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. CERTIFIED INVESTMENTS

Certain Plan investments are managed by the Custodians and, therefore, qualify as party in interest transaction. In addition, the Plan provides for notes receivable from participants, which are party in interest transactions that are exempt from the prohibited transaction rules.
