Notes to Financial Statements

Note 1. Plan Description

The following description of the MORryde International, Inc. 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of MORryde International, Inc. (the Company) who are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a percentage of their gross wages, as defined by the plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make, at its discretion, a matching contribution to the Plan. For the year ended December 31, 2024, the Company contributed a discretionary match equal to 100% of the first 1% and 25% of the next 4% of total deferrals of the participants' taxable wages that a participant contributed to the Plan. Additional amounts may be contributed at the option of the Company's Board of Directors. There were no additional amounts contributed to the plan year ended December 31, 2024. The Company's contributions are invested in a manner similar to participant contributions and are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, if any, and (b) plan earnings, and charged with any withdrawals and an allocation of certain administrative expenses. Income and realized and unrealized gains and losses on investments are allocated to the participant accounts on each valuation date based on the earnings of directed investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as of the issuance date of the loan, based upon the terms of the plan document. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of participant accounts plus actual earnings thereon, if any, is based on years of continuous service. A participant is 100% vested after five years of credited service.

Payment of benefits: Upon termination of service, attainment of age 60, death, or retirement, a participant may generally receive a lump-sum amount equal to the value of his or her account. Benefits are recorded when paid.

Administration of plan assets: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses for the trustee's fees are paid directly by the Company.

Note 1. Plan Description (Continued)

Forfeitures: At December 31, 2024 and 2023, forfeited non-vested accounts were not material. These accounts will be used to reduce plan expenses or the Company's matching and discretionary contributions. The utilization of these accounts was not material for the year ended December 31, 2024.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: The brokerage account consists primarily of registered investment companies, a common collective trust, and interest-bearing cash.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Fair value measurements: Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 2. Significant Accounting Policies (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

Shares of registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust: Valued at the net asset value (NAV) of the units held by the Plan at year-end. The value is supported by the information reported by the investment advisor using the audited financial statements of the fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through September 2, 2025, the date the financial statements were available to be issued.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers into or out of Level 3 assets.

Note 5. Related-Party and Party-in-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Fidelity. Recordkeeping and custodial services for the Plan were provided by Fidelity; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the service provider totaled \$101,517 for the year ended December 31, 2024.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 7. Income Tax Status and Uncertain Tax Positions

The Plan is an adopter of a non-standardized form of a prototype plan. The prototype plan has received a pre-approval letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan pre-approval letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and had taken no significant uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.
