Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of MEC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of assets held for investment purposes and schedule of reportable transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of MEC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General – The Plan, effective January 1, 1989, is a defined contribution plan covering substantially all of the employees of Medina Electric Cooperative, Inc. (the Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility – All employees in place as of January 1, 1989, were eligible to participate when the Plan initiated. After the Plan's initiation, employees are eligible for participation in the Plan after completing one year of service. There is no age restriction. The Plan entry dates are the 1st of every month.

Contributions – Under the Plan, the participant and the Employer are both allowed to make contributions. The participants are allowed to contribute a portion of their salary to the Plan subject to those limitations provided for in Section 401(k) of the Internal Revenue Code. The Employer matches an amount equal to 3% of participant's base wages.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of matching contributions are used to reduce the Employer's matching contribution or to pay plan expenses. During the years ended December 31, 2024 and 2023, cash forfeitures of \$17,258 and \$1,454, respectively, were added to the forfeiture account. In 2024, forfeitures totaling \$38,148 were used to offset Employer contributions. As of December 31, 2024 and 2023, unallocated forfeitures totaled \$23,684 and \$43,041, respectively.

Participant Accounts – Each participant has up to three accounts, with one account designated for participant 401(k) contributions, one account designated for participant Roth IRA contributions, and one account designated for Employer contributions.

Participant contribution accounts are credited with the participant's contributions and the earnings of the specific investment vehicles selected. Participants may self-direct their contributions to several investment vehicles, including money market accounts and variable annuities.

The Employer contribution accounts are credited with the Employer's matching contribution and an allocation of the Employer's discretionary contribution. Allocations are based on each participant's share of the total compensation paid during the fiscal year to all participants in the Plan. Participants may also self-direct the Employer account to several investment vehicles, including money market accounts and variable annuities.

Vesting – Each participant's Employer contribution account vests at the rate of 0% per year for the first year and 20% per year thereafter until fully vested after six years. Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

If a participant dies or becomes disabled, the participant's accrued benefit derived from the Employer contributions becomes 100% vested without regard to the above schedule. In the event of full or partial termination of the Plan, an affected participant's rights to the accrued benefit shall be 100% nonforfeitable. The Plan can be terminated at the discretion of the Employer.

NOTES TO FINANCIAL STATEMENTS

Payment of Benefits – A participant may receive distributions prior to separation of service after normal retirement age is reached. Participant contributions are paid out in a lump sum payment or elect an annuity in accordance with Plan provisions. Upon termination before retirement, the participant may elect to continue the account with the cooperative. If the participant dies prior to receiving all benefits under the Plan, the balance of the participant's account is paid to the beneficiary.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement – Investments are stated at fair value on the last business day of the year. In accordance with the policy of stating investments at fair value, net unrealized appreciation or depreciation for the year is reflected in the statement of changes in net assets available for Plan benefits. Fair value of investments is further discussed in Note 4.

Securities transactions are recognized on the trade-date (the date the order to buy or sell is executed). Income from investments is recorded as earned on an accrual basis.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level slightly different than others, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

3. Information Prepared and Certified by Trustee

The following information included in the accompanying financial statements and supplemental information was obtained from data that has been prepared and certified to as complete and accurate by Ascensus (the Trustee).

Notes Receivable from Participants

Participants may borrow from their fund accounts an amount no less than \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding balance of notes during the one-year period ending on the day before the date of the new note over the current outstanding balance of notes as of the date of the new note, or 50% of their vested account balance. Note terms range from one to five years, or more if used to acquire a principal residence of the Plan are permitted to withdraw notes from their account balance as long as they meet certain requirements. The notes are secured by the balance in the participant's account. Interest rates on these notes ranged from 5.25% to 10.50% as of December 31, 2024. Participants may not have more than two outstanding notes at one time.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued on the Net Asset Value (NAV) of shares held by the Plan as of the close of business of the NYSE at year end, which is fair value.

Common/Collective Trust: Valued obtained directly from the fund house or other investment provider held by the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Concentrations of credit risk exist if a number of investments are engaged in similar activities and have similar economic characteristics that could cause their ability to meet contractual obligations to be similarly affected by changes in economic or other conditions. The Plan has invested in a variety of financial instruments and investments involving diverse industries and geographic areas to mitigate exposure to credit risks.

In accordance with Fair Value Measurement (Topic 820): Disclosure for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent), investments measured using the NAV practical expedient in ASC 820, Fair Value Measurement, are exempt from categorization within the fair value hierarchy. 5. Administration of Plan Assets

The Plan assets are held by the administrator of the Plan. Employer and participant contributions are invested by the administrator as directed by the participant. Administrative expenses for the Plan are paid directly by the Employer for the first \$5,000, and the balance of the Plan expenses and transaction charges are paid by the participants. Investment related expenses are included in net appreciation in fair value of investments.

6. Tax Status

The Internal Revenue Service (IRS) has determined, in the letter dated January 31, 2006, that the prototype standardized profit sharing plan is a qualified plan under Section 401(a) of the Internal Revenue Code. The Plan, which operates under the prototype plan, is exempt from federal income taxes under Section 501(a) of the Internal Revenue Code.

The Plan has adopted the "uncertain tax positions" provisions of accounting principles generally accepted in the United States of America. The primary tax position of the Plan is its filing status as a tax exempt entity. The Plan determined that it is more likely than not that its tax positions would be sustained upon examination by the IRS or other State taxing authority.

The Plan is no longer subject to U.S. federal and state income tax examinations by federal taxing authorities for the years before 2021.

There were no penalties or interest related to income taxes recognized during the years ended December 31, 2024 and 2023.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

8. Reconciliation of Financial Statements to Schedule H of Form 5500

The accompanying financial statements show different amounts for employer and employee contributions than what is represented in Schedule H of the Form 5500 because those amounts that are receivable at year end are not reflected on the Form 5500.
