## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of  
Workiva 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Workiva 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

#### **Other Matter**

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Workiva 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information of the Plan's provisions.

**General and Eligibility**

The Plan is a defined contribution plan covering all employees of Workiva Inc. (the Company) that are 18 years of age and older. Eligible employees can make deferral contributions starting on the first day of the month coinciding with or next to the employment commencement date. Participants are also entitled to employer matching contributions at the time deferral contributions start. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions and Investment Options**

Each year, participants may contribute up to 85% of their pre-tax annual compensation not to exceed the maximum allowed under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company made discretionary matching contributions of 100% of the participant's contribution, up to 6% of eligible compensation with a maximum limit of \$3,000 for the year. The Company may also make discretionary matching or profit-sharing contributions to participating employees. For the years ended December 31, 2024 and 2023, the Company made no additional discretionary or profit-sharing contributions.

Participants may direct the investment of contributions into various investment options offered by the Plan. Participants may currently invest contributions into mutual funds and two common collective trust funds. Participants may change their investment options daily.

**Participant Accounts**

Each participant's account is credited with the participant's deferral contribution and an allocation of (a) the Company's contributions and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. Any participant loan fee incurred with respect to a particular participant or beneficiary is allocated against the participant's account on a direct basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and Company match contributions plus actual earnings thereon. The Company's discretionary profit-sharing contributions become 25% vested after one year of service, as defined, and continue vesting thereafter at 25% per year to become 100% vested after four years of service.

**Payment of Benefits**

Upon termination of service or reaching retirement age, participants may elect to receive a lump sum distribution equal to the value of his or her account, choose to receive installment payments available under the Plan, or roll over the amount into another qualified plan. Employees, regardless of age, who have a financial hardship, may request a lump sum withdrawal from their 401(k) elective deferral account, subject to limitations as defined in the Plan.

**Notes Receivable From Participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of 50% of their nonforfeitable account balance or \$50,000, reduced by the excess of the participant's highest outstanding participant note receivable balance during the prior 12-month period over the participant's current outstanding note receivable balance. Generally, note terms range from one to five years, unless the note is for a principal residence, which may be repaid over a term established by the Plan administrator at the time of the loan. The notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by Bank of America, N.A. (Bank of America). Principal and interest are paid ratably through payroll deductions. Notes receivable from participants outstanding at December 31, 2024 mature through August 2034 and bear interest ranging from 5.25% to 10.5%.

**Forfeitures**

Forfeitures of nonvested participants' accounts are used to pay administrative expenses and offset the Company's future contributions to the Plan. As of December 31, 2024 and 2023, the Plan had unallocated account balances amounting to \$27,314 and \$23,343, respectively. For the years ended December 31, 2024 and 2023, no forfeitures were utilized during the year.

**NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes are treated as distributions based upon the terms of the Plan document; therefore, there is no allowance for credit losses as of December 31, 2024 or 2023.

**Contributions**

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 3 — ADMINISTRATIVE EXPENSES**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan.

**NOTE 4 — INFORMATION CERTIFIED AND PROVIDED BY BANK OF AMERICA**

The following is a summary of the Plan's asset and income information as of and for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared or derived from information provided by Bank of America and furnished to the Plan administrator. The Plan administrator has obtained a certification from Bank of America that the information provided to the Plan administrator is complete and accurate.

**NOTE 5 — PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provision of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6 — TAX STATUS**

The Plan adopted a non-standardized form of a prototype plan sponsored by Merrill Lynch, Pierce, Fenner & Smith Inc. (Merrill Lynch), an affiliate of Bank of America. The prototype plan has received a letter from the Internal Revenue Service (IRS) as to its qualified status, dated June 30, 2020. The Plan administrator believes that the Plan is designed and is currently being operated in accordance with applicable provisions of the IRC.

The Plan follows the accounting guidance for uncertainty in income taxes and management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustments to the financial statements.

**NOTE 7 — RISKS AND UNCERTAINTIES**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. Such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8 — FAIR VALUE MEASUREMENTS**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. GAAP requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1 - defined as unadjusted quoted prices in active markets accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 - defined as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means; and
- Level 3 - defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Investments carried at fair value are classified, in their entirety, based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets within the levels of the fair value hierarchy.

A description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below:

- *Mutual funds and money market fund:* Valued based on quoted prices in active markets.
- *Common collective trusts:* Valued at the quoted redemption values, also known as net asset value (NAV), determined by using available market information and appropriate valuation methods, as provided by the Bank of America and represent the value at which the Plan, or the participant, could initiate a transaction with the Bank of America.

**NOTE 9 — PARTY-IN-INTEREST TRANSACTIONS**

The Plan issues notes receivable to participants subject to Plan provisions. These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

The Plan uses Merrill Lynch, an affiliate of Bank of America, for recordkeeping services. The Plan paid \$17,006 and \$15,501 for these services for the years ended December 31, 2024 and 2023, respectively.

The Plan administrator has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.
