## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Broadway Services, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Basis for Opinion**

## **Notes to Financial Statements**

### **Note 1. Description of the Plan**

The following description of the Broadway Services, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

Broadway Services, Inc. (the Plan Sponsor) established a 403(b) plan to provide employees with a systematic means of saving and investing for the future. All permissible employees of the Plan Sponsor, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Each year, participants may contribute up to 100% of their eligible compensation to the Plan, up to the maximum allowable by the Internal Revenue Code (IRC). The Plan allows catch-up contributions for participants that attain the age of 50.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of any sponsor contributions, and plan gains or losses.

#### **Investment Options**

Upon enrollment in the Plan, participants may direct the allocation of their contributions and the Plan Sponsor's contributions into various investment options managed by American United Life Insurance Company. Participants may monitor and manage their individual accounts throughout the year.

#### **Vesting**

Participants are immediately vested in elective deferrals, including catch-up contributions and rollover contributions, and the earnings attributable to those contributions. Participants will become vested in sponsor contributions and related earnings upon completion of three years of service.

#### **Payment of Benefits**

Upon severance of employment, participants are entitled to a lump-sum distribution of their account balance. Participants may also elect to receive benefits prior to severance of employment and upon reaching age 59½, or as a result of hardship or disability.

#### **Participant Investment Rollovers**

Participants are allowed to transfer or rollover funds into the Plan from other qualified 403(b) plans.

### Note 1. Description of the Plan (Continued)

#### **Risks and Uncertainties**

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain underlying investments, it is at least reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan at any time. Upon termination or partial termination of the Plan, or the complete discontinuance of contributions, the rights of all affected participants to their accrued benefits shall be fully vested and non-forfeitable.

#### **Participant Loans**

The Plan does not provide for participant loans.

#### **Forfeitures**

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be utilized to pay plan administrative expenses, reduce future sponsor contributions, and/or be reallocated to participants ratably based on compensation. At both December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0-. Forfeitures used to pay plan administrative expenses during 2024 were \$800. Forfeitures used to reduce sponsor contributions during 2024 were \$19,392.

#### **Administrative Expenses**

The Plan permits the payment of administrative expenses from available funds in the Plan's forfeiture account.

### Note 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Contributions**

Contributions from plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

##### **Tax Status**

The Plan Administrator believe the terms of the Plan have been designed to meet the requirements of the applicable sections of the IRC and is currently being operated in conformity with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America provide accounting and disclosure guidance about positions taken by a plan in its tax returns that might be uncertain. The Plan Administrator believes that it has appropriate support for any tax positions taken and, as such, does not have any uncertain tax positions that are material to the financial statements.

##### **Payment of Benefits**

Benefits are recorded when paid.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Account:* Valued at the market value of the underlying investments as adjusted for the Plan's units of participation (annuity units) in the pooled account. Annuity units are established for each investment division of the separate account. The value of these annuity units is determined at the close of the stock exchange each day the exchange is open for regular trading. The values increase or decrease based on the investment performance of the corresponding underlying portfolios.

- (f) This category seeks the highest turn consistent with its asset mix. The fund is a "fund of funds". It invests in other American Century mutual funds (the underlying funds) that represent a variety of asset classes and investment styles. The target date in the fund name refers to the approximate year an investor plans to retire and likely would stop making new investments in the fund.
- (g) This category includes equity investments in companies with a market capitalization between \$2 and \$10 billion, which is calculated by multiplying the number of a company's shares outstanding by its stock price. Mid-Cap is an abbreviation for the term "middle capitalization".
- (h) This category includes equity investments in companies with a relatively small market capitalization. The definition of Small-Cap can vary among brokerages, but generally it is a company with a market capitalization of between \$300 million and \$2 billion.
- (i) This category is made up of funds that restrict investment to a particular industry, primarily real estate and energy-related industries.

#### Note 5. Fully Benefit-Responsive Investment Contracts

The Plan holds traditional investment contracts with American United Life Insurance Company (AUL). The Plan's investment in AUL's fixed interest and stable value accounts are held as part of AUL's general account assets. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures, or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Certain plan investment options are managed by AUL, the Plan's custodian. Therefore, these transactions qualify as party-in-interest. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the provision of the party-in-interest transactions under ERISA.

#### **Note 7. Subsequent Events**

The Plan Administrator has evaluated subsequent events through the date that the financial statements were available to be issued, August 28, 2025. No subsequent events occurring after the date above have been evaluated for inclusion in these financial statements.
