Independent Auditor's Report

To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dubois-Pike-Warrick Economic Opportunity Committee, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Dubois-Pike-Warrick Economic Opportunity Committee, Inc. 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 –Summary of Significant Accounting Policies

The significant accounting policies followed by the Plan are summarized below.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The Plan administrator uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported additions to and deductions from net assets. Actual results could vary from the estimates that were assumed in preparing the financial statements.

Investment Valuation and Income Recognition

Pooled separate accounts which include mutual funds are valued at fair value based on the net asset values as provided by Mutual of America Life Insurance Company on the last business day of the Plan year. Unrealized appreciation and depreciation in the fair value of investments held at year-end and realized gains and losses on sales of investments during the year are determined using the beginning of the year fair value or purchase price if acquired subsequent to that date. Investment contracts are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. The cost of investments sold is computed on an average cost basis for all realized gains and losses. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are

charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative costs

The administrative costs charged to the Plan are paid by the Plan or the Plan Sponsor at the Plan Sponsor's discretion. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Subsequent Events

The Plan's management has evaluated the financial statements for subsequent events occurring through August 27, 2025, the date the financial statements were available to be issued.

Note 2 – Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. This description includes changes due to amendments to the Plan adopted November 1, 1998.

General

The Plan was commenced and made effective November 1, 1998. The Plan is a defined contribution plan covering all employees of Dubois-Pike-Warrick Economic Opportunity Committee, Inc. with one month of service. Those who are at least 21 years of age and completed one year of service are eligible to receive Employer match contributions. The Plan, which provides for retirement, death and disability benefits, is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees can elect to defer up to 100% of their annual compensation, subject to certain limitations and as allowed under Section 401(k) of the Internal Revenue Code. In addition, participants may also make qualifying rollover contributions to the Plan. Effective January 1, 2022, employer matching contributions are equal to 100% of the employee's contribution that does not exceed 4% of compensation.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at the Prime Interest Rate (PIR) plus 1%. Principal and interest is paid through payroll deductions.

Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the interest of all participants becomes fully vested and non-forfeitable.

Vesting

Under the Plan, employee contributions are 100% vested at the time of contribution. The employers’ matching contributions vest at the rates described in the following schedule based on hire date. Upon normal retirement age, or in the event of death or total disability of a participant, the value of each individual account becomes fully vested. Forfeited balances offset termination fees and future employer contributions.

Payment of Benefits

Generally, in the event of retirement, disability, attainment of 59½, or death, a participant’s balance may be withdrawn. In special financial hardship situations, participants may be permitted to withdraw their balance. A married participant will automatically receive a joint survivor annuity and a single participant will receive a life annuity. However, the participant may elect to receive the balance of his or her account in a lump sum or installment payments. An employee who terminates employment prior to normal retirement date is entitled to the vested benefits in his or her individual account.

Forfeited Accounts

For the years ended December 31, 2024 and 2023, unused forfeited accounts were \$0 and \$0, respectively. Forfeited accounts are available to reduce future employer contributions to the Plan. For the years ended December 31, 2024 and 2023, \$0 and \$234 of forfeitures were used to reduce employer contributions, respectively.

Participant Accounts

The Plan maintains participant-directed investment accounts on behalf of each participant. A participant's account is credited with the participant's contributions, Plan Sponsor contributions, and investment earnings based on the investment options elected. Benefits to which a participant is entitled is the benefit that can be provided by participant's vested account. Participants may invest their contributions in different funds through various fund managers offered by Mutual of America Insurance Company, Inc. the Plan's custodian. All administrative costs of the Plan are absorbed by the Employer.

Note 3 – Tax Status

The Plan adopted Mutual of America's Prototype 401(k) Profit Sharing Plan Document on December 2, 2009. The Plan was last restated on January 1, 2022. The Plan Document obtained its latest determination letter dated March 31, 2014, in which the Internal Revenue Service stated the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 4 - Fair Value Measurements

The Plan has categorized its assets that are measured at fair value based on a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to valuation methodologies include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 6 – Party-In-Interest Transactions

Certain plan investments are managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the contract holder as defined by the Plan and, therefore, these investments and investment transactions qualify as exempt party-in-interest transactions. Plan audit and accounting fees are paid by the Employer/Plan Sponsor. Certain administrative functions are performed by officers and employees of the Plan Sponsor. These employees are also Plan participants. No such officers or employees received compensation from the Plan.

Note 7 – Investment Contract with Insurance Company

The Plan entered a deposit administration investment contract with Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with interest at a current rate of interest determined by Mutual of America and charged for participant withdrawals and administrative expenses. The investment contract, unlike traditional guaranteed investment contracts, do not have a specified maturity date and there are no known scheduled cash flows associated with these contracts.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Mutual of America determined that the deposit administration investment account is comparable to a cash equivalent.
