### Note 1 - Plan Description

The following description of Pilkington North America, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that covers substantially all full-time nonrepresented employees, except for the Automotive Glass Replacement Division, and part-time employees who have completed 1,000 hours of service with Pilkington North America, Inc. (the "Company"). Full-time employees are eligible to participate in the Plan 90 days after they become employed. Part-time employees are eligible to participate in the Plan 90 days after the month in which they complete 1,000 hours of service in a 12-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participant contributions may be made via payroll withholdings from 1 percent to 40 percent of the employee's salary (in 1 percent increments) subject to maximum limitations established by the Internal Revenue Code. Each pay period, the Company contributes a guaranteed amount to the Plan equal to 4.5 percent of each eligible employee's salary. In addition, the Company will contribute a matching percentage of eligible salary at 100 percent of the first 3 percent deferred and 50 percent of deferrals between 3 percent and 5 percent of compensation.

For each fiscal year, the Company may make a profit-sharing contribution in an amount not to exceed 2 percent of the employee's eligible salary. The Company made profit-sharing contributions of \$2,518,095 for the year ended December 31, 2024.

The Plan may accept rollover contributions from other qualified plans.

#### **Administration**

The Company has appointed an investment committee to manage the operation and administration of the Plan. The Company has contracted with Empower Annuity Insurance Company and Empower Trust Company, LLC (collectively, Empower) as the custodians to process and maintain the records of participant data.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Transfers**

During the year, transfers occur between company-sponsored plans when employees change employment within pay groups covered by the plans.

#### **Vesting**

Participant and matching contributions are fully vested when made, including rollover contributions. Profit-sharing and guaranteed contributions vest at the rate of 25 percent per year of service.

**Note 1 - Plan Description (Continued)**

***Participant Notes Receivable***

Participants may borrow from their accounts up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at rates that range from 3.44 to 10.00 percent. The interest rate is determined by a committee consisting of plan administrators.

***Benefit Payments***

Upon retirement, disability, or other termination of employment, a participant may elect to receive payment for the value of his or her vested account through a lump sum or annuity distribution.

Upon death, a participant's beneficiary will receive the balance in the participant's account, including both vested and nonvested amounts.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amounts of the account is forfeited. Forfeitures are used to reduce future company contributions.

***Hardship Withdrawals***

Participants may request that all of their vested contributions or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The participants may self-certify their request for a hardship withdrawal, or the Company must approve any such hardship withdrawals.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Party-in-interest Transactions***

Certain plan investments are managed by Empower. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempted from the prohibition of party-in-interest transactions under ERISA.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Benefit Payments***

Benefits are recorded when paid.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 28, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Empower Trust Company, LLC and Empower Annuity Insurance Company held the Plan's investments and executed all investment transactions as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The investment balances and related investment results included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Empower.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

**Note 4 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Common/Collective Trust Funds**

The common/collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

**Pooled Separate Account**

The pooled separate account is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's net underlying assets. There are no redemption restrictions or unfunded commitments on this investment.

**Note 5 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 6 - Guaranteed Income Fund**

The Plan has a benefit-responsive investment contract with Empower Annuity Insurance Company (Empower AIC). Empower AIC maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.5 percent. When establishing interest crediting rates for this product, Empower AIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
