### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements**

We have performed an audit of the accompanying financial statements of the Balls Food Stores 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 

**Note 1 – Description of Plan**

The following description of the Ball's Food Stores 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution salary deferral plan covering all employees of Four B Corp who have 30 days of service in the Plan year. Eligible employees must also have attained age 20 and must not be covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan's custodian and trustee is Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company. An affiliated company, Principal Retirement Services, serves as the Plan's recordkeeper.

**Contributions**

Contributions of the Plan consist of voluntary employee pre-tax contributions and/or post-tax Roth contributions from salary that are matched to a certain percent by employer contributions. Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to annual statutory limits as defined by the Internal Revenue Service. The elected contribution percent may be changed as often as desired. The Company makes discretionary matching contributions, not to exceed 5% of each employee's compensation. In 2024, the Company matched 50% of the first 4% of each employee's compensation.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of (a) Company discretionary contributions and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions plus earnings thereon is based on years of continuous service. A year for vesting purposes is a calendar year in which the participant has 1,000 hours of service. The vesting schedule for

**Benefits**

Participants are entitled to the benefit, which can be provided from the participant's account. Distribution of the participant's vested accrued benefit shall commence upon request. Upon termination of employment, the participant, or in the case of death, the participant's beneficiary can elect to receive the participant's vested account balance in a single lump sum or request that it be rolled over to a different IRA provider or another retirement plan, in accordance with the Plan document.

**Investment options**

A participant directs all contributions into mutual funds, common/collective trusts, and a guaranteed interest contract managed by the Custodian. Employees can change their investment allocations anytime.

**Amendment and termination**

The Company shall have the right at any time to amend the Plan in any manner it deems necessary or appropriate. Although the Company has not expressed an interest to do so, it shall have the right, at any time, to suspend or discontinue its contributions under the Plan, and to terminate, at any time, this Plan, subject to the provisions of ERISA. In the event that the Plan should be terminated, the entire balance of the participant's account will become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan documents.

**Participant Loans**

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Each loan is secured by the balance in the participant's account and bears interest at a rate that can range from 5.25% to 10.50%; these rates are commensurate with local prevailing rates as determined quarterly by the Plan administrator. As of December 31, 2024 all loans were charged an interest rate equal to the Prime rate at the time of loan origination plus two percent. Principal and interest are paid through weekly or bi-weekly payroll deductions. The number of outstanding loans held by a participant is limited to two loans.

**Forfeited Accounts**

Forfeitures of non-vested accounts may be used to reduce Company contributions. There was \$0 of forfeitures available for use as of January 1, 2024. During the year ended December 31, 2024, forfeited amounts totaled \$18,199 and there were \$139 of losses recorded net of expenses. \$17,577 was used to reduce Company contributions during the year ended December 31, 2024. The balance of forfeited amounts as of December 31, 2024 was \$483.

**Note 2 – Summary of Significant Accounting Policies**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the contract value of the investment contracts.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value and Common/Collective Trusts, which are reported at net asset value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 6 for further details. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in mutual funds and guaranteed interest contracts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Employer and participant contributions are reported in the year services are rendered to the Company by the plan participants.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Recently Issued Accounting Pronouncements**

The Trustees have reviewed all recent accounting pronouncements issued by the FASB (including its Emerging Issues Task Force) and the AICPA and feel they did not or will not have a material impact on the Plan's present or future financial statements.

**Note 3 – Information Certified by Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information prepared by the custodian of the Plan's assets, and furnished by the Plan administrator. Accordingly, Principal Life Insurance Company, the trustee of the Plan, has certified that the following information included in the financial statements and the supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, transfers into the plan, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Schedule H, item 4i – schedule of assets held at end of year, December 31, 2024.

The Plan invests in mutual funds and common/collective trusts which hold various securities, including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 5 – Investment Contract with Insurance Company**

The Plan provides the Principal Fixed Income Guaranteed Option, a fully benefit-responsive group annuity contract with a fixed rate of interest issued by Principal Life Insurance Company ("PLIC") as an investment option for participants. The objective of this investment option is to guarantee principal and provide a stated interest crediting rate backed by PLIC. The contract is included in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully

benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Under the existing contract, the composite crediting rate on participant accounts was 4.75% as of December 31, 2024. The investment contract has a 5% early withdrawal charge should the Plan discontinue the contract without proper notifications, as prescribed in the contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events that may limit the ability of the Plan to transact at contract value are not probable of occurring.

**Note 6 – Fair Value Measurements**

The Plan has adopted ASC Topic 820-10 to measure the fair value of certain of its financial assets required to be measured on a recurring basis. ASC Topic 820-10 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). ASC Topic 820-10 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability. The three levels of the fair value hierarchy under ASC Topic 820-10 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the closing price reported on the active market on which the individual securities are traded.

Common/Collective Trusts – The fund manager calculates a net asset value per unit on the Fund’s valuation date and the underlying investments of these funds are valued as described in their respective financial statements.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7 – Income Tax Status**

The Company adopted a Prototype Non-standardized 401(k) Profit Sharing Plan which received a favorable opinion letter from the Internal Revenue Service dated March 31, 2014, indicating that it is qualified under Section 401 of the Internal Revenue Code (the “Code”). The Adoption Agreement may have been amended since the date of the letter, however, the Plan’s administrator believes

that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the related trust is exempt from tax under Section 401(a) of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no IRS audits for any tax periods in progress. The Plan sponsor believes it is subject to income tax examinations for the years of 2024, 2023, 2022, and 2021.

**Note 8 – Related Parties and Parties-in-interest**

Certain plan investments are mutual funds, common/collective trusts, and guaranteed interest contracts managed by Principal Trust Company. Principal Trust Company is the custodian/trustee as defined by the Plan and, therefore, these investments qualify as party-in-interest transactions.
